## THE WORLD OF LABOR.

Extensive Strike of Brick-Makers in New Jersey.  
TRENTON, April 6.—The brick manufacturers at a meeting held last week decided to reduce the wages of their employees 20 per cent, the cut to affect all classes of help now receiving \$2 to \$4 per day. The dullness of trade is the reason for the new schedule. There are thirteen large yards in Trenton, and they all have an immense quantity of brick on hand, carried over from last year. The manufacturers say brick have fallen from \$29 to \$12 per 1000. The employees met today and decided not to accept the reduction.

## IMPORTANT DECISION

The Supreme Court Reverses the Montana Court Decision.

ORDERS A NEW TRIAL.

Interesting Case—Long In Litigation and the End Not Yet Reached—Eastern News.

WASHINGTON, April 6.—The United States supreme court, reversing the judgment of the supreme court of Montana in the case of Andrew J. Davis, appellant, vs. Henry Wiebold, and ordering the case remanded for a new trial. This was the suit for damages, and involved the title to certain lands in the town of Butte, Montana. The case turns upon the construction to be given to a provision of the town site law of the United States.

Davis held title under the town site entry act, of which one provision is that no title should be acquired under the act to any gold, silver or copper mine, or to any valid mining claim, held under the existing laws. Wiebold claimed title under the general laws, and when Davis offered to prove that at the time the patent of Butte town site was issued, the premises in dispute were not known to be valuable for minerals of any kind. The objection was taken on the ground that Wiebold's patent showed that as a matter of fact the premises did contain valuable mineral lands, and as such could not be granted by a town site patent. The court sustained the objection, and their ruling, which was really decisive of the controversy this court overrules. The question involved in the suit has long been in dispute, and there has been various, and in some instances diverse, opinions on it in the executive departments. The United States supreme court has several times passed upon it by inference and implication, but this, it is said, is the first direct decision.

The court in the opinion, written by Justice Field, says: "The important question is whether, in the absence of the knowledge that there were any valuable mineral lands within the town site, Davis can be deprived of the premises purchased and occupied by him, because of the subsequent discovery of minerals on them, and the issue of a patent to the discoverer. After much consideration we have arrived at the conclusion that this question must be answered in the negative. The object of the town site act was to afford relief to inhabitants of cities and towns upon the public lands, by leaving a valuable tract in a town site, and thereby, under such protection many towns, with buildings of great value, have grown up. It would in many instances be a great impediment to the progress of such towns, if the title to those premises, by their inhabitants, were subject to be overturned by the subsequent discovery of mineral deposits under their surface. If their title would not protect them against the discovery of mines and minerals, they would protect their property for the purpose of exploring for the mines. We do not think any such results were contemplated by the act or that any construction should be given to it as would lead to such results.

## SHAVING THE BABY.

A New Jersey Infant Almost Killed by Its Little Brothers.

WASHINGTON, N. J., April 6.—Mrs. Janet MacNair, of Kersville, left her three children, aged 9, 7 and 2 1/2 years, at home while she went to the store Saturday. When she returned, she found the youngest lying on the floor covered with blood, with a razor by its side. The child was very weak from loss of blood, though not dead. His little face was one mass of cuts, and in the neck was a large gash that came within a little of cutting the jugular vein. The other children were finally discovered in a closet fast asleep. Their little hands were covered with blood. They explained to their mother that they had been playing barber and trying to shave the baby, who would not keep still and was cut. They became frightened at the blood and hid themselves. The baby's wounds were dressed, and he will recover, though he may have two or three bad scars on his face. Hereafter the razor in that house will be put out of reach.

## RAIN IN PLENTITUDE.

Good Crops for California This Season.

SAN FRANCISCO, April 6.—Rain fell throughout the state today and reports from all sections indicate that the crop prospects are unprecedentedly bright. Crops of all kinds will be benefited, especially wheat in the San Joaquin valley.

## Quiet in the Coke Region.

MOORE'S PLEASANT, Pa., April 6.—Quiet prevails in the coke region today. There has been no disturbance of any kind. The first effort to start the coke-works since the riot commenced was made this morning. Four hundred men are at work, a majority of them being old employees. They were not interfered with in any way while going to work. Sheriff Clawson came over from Greensburg this morning with warrants for twenty-five rioters, and Superintendent Morris Ramsey has sworn out warrants for the arrest of fifteen additional rioters. These warrants were placed in the hands of constables, and it is expected that before midnight at least thirty rioters will be in jail.

## VATICAN DECISIONS.

They Are In Line With the Success of Republics.

DEMOCRACY WILL PREVAIL.

The Pope Has So Decided, And the Others Must Follow—A Prophetic Voice.

ROME, April 6.—Cardinal Legation's toast at Algiers, and events which rapidly followed these striking utterances, are still much discussed in church circles. Everything clearly indicates a decided drift of the Catholic church toward a modern democracy, but those who have enjoyed the confidence of Pope Leo, know he has always considered it of prime importance for the church to free itself from identification with the old dynastic parties. In all countries the pope has favorite correspondents, upon whose advice he places special reliance, and who are charged with carrying out his personal policy.

## Had to Cut It Short and Return to Washington.

SAN FRANCISCO, April 6.—Secretary of War Proctor, accompanied by a military party, today made a tour of inspection of the various fortifications and sites of the proposed fortifications, which were pointed out by Col. Mendell, chief of the United States engineering corps on the Pacific coast. Telegrams were sent this forenoon to various northern points, giving notice that it has been found necessary for the secretary to change his plans and start East to-night.

## FIGHTING IN INDIA

BRITISH TROOPS AMBUSHED AND SLAUGHTERED.

Natives Uprising in Every Direction—Attacking the Soldiers all Along the Line.

CALCUTTA, April 6.—If indications are correct, very serious trouble is brewing in India for the British forces. Emboldened by the success at Miranzai, which recently crushed the Ghorka escort accompanying Chief Commissioner Quinlan in his effort to settle disputes among the rival chieftains of Assam and Miranzai, the Kohat territory, natives of the Punjab, have risen in arms, and are attacking the British troops along the whole length of their lines. The attack is being pushed so vigorously that a strong reinforcement must be sent to Miranzai, which is the front. Full details as to this uprising are withheld by the British authorities here.

## KILLED BY A BOY.

A Walla Walla Man Shot Dead Through Carelessness.

WALLA WALLA, April 6.—Sunday about noon Wm. G. Kershaw, living at Dixie, Walla Walla county, went to a closet in the yard of the back of his residence. A boy named John Rodgers was in the yard at the time playing with a needle gun. The gun went off either accidentally or with the intention of scaring Kershaw. After a time Kershaw not returning to the house, they went out to look after him and found him lying dead. The ball had shot off his left forehead, and then entering Kershaw's side, came out under the right arm-pit, causing almost instant death. The boy was arrested, but said he did not know anything about it except that the gun went off. He did not think it had hit anybody. An inquest is being held.

## MAXWELL URGED.

For Chief of the Fortification Bureau.

CHICAGO, April 6.—Commissioner M. H. DeYoung, of California is earnest in his efforts to have Walter S. Maxwell, of California, appointed chief of the bureau of fortification, the position being held by the chief of that bureau should come from California, and endorsing Maxwell for the position. Maxwell is a California citizen, and has obtained the signatures of all the leading commissioners and publishers of almost all the dailies in Chicago. Work commenced to-day on the exhibition buildings, in preparation for the Southern California fruit exhibit to open next Monday. While the exhibit will be but the fore-runner of what California will do at the World's fair, the value of the fruit will not be far from \$100,000.

## CHARGED WITH LIBEL.

The Reverend Gentleman Was Too Free With His Pen.

DALLAS, Tex., April 6.—The grand jury has returned two indictments for criminal libel against Rev. Robt. T. Hanks, a noted Baptist. He is charged with libeling Rev. E. B. Sardy, L. R. Searles, S. B. Grant and A. M. Johnson, all prominent preachers of the same faith. The offense consists in having charged in his paper that the said divines were scandal mongers of the "Texas Baptist and Herald" and "Notorious liars." The indictments are the outcome of a bitter newspaper war between the Western Baptist and the Texas Baptist and Herald.

## SECRETARY NOLLE RENDERS A DECISION THAT INVOLVES MUCH.

He Decides Against the Locators Under the Two Acts—It Knocks Out the Investors of Over \$100,000.

TIMBER AND STONE ENTRIES.

WASHINGTON, April 6.—Secretary Noble today rendered a decision rejecting the applications to perfect about 42 entries, made under the timber and stone acts, made by members of the Kaweah Co-operative colony in California, now with the Sequoia National Park reservation, created by acts of congress approved September 25 and October 1, 1890. The secretary holds these applications to purchase under timber and stone acts, and parties making the same acquire no vested rights thereby. The applications are therefore denied. It is estimated these colonists have expended in construction of public roads and other improvements about \$100,000. The only relief must be by an act of congress.

## CHICAGO ELECTION.

THE MOST HOTLY CONTESTED FOR MANY YEARS.

Five Men for Mayor and They Hotly Contest World's Fair Work and Interests.

CHICAGO, April 6.—The municipal election to-morrow will close one of the most peculiar and hotly contested campaigns in the history of Chicago. No less than five candidates are making the contest for the majority, and as between four of these it is impossible to forecast the result. The first candidate in the field was Elmer Washburn, ex-chief of police and ex-chief United States secret service bureau. He was put in nomination ostensibly by an independent citizens movement, whose object it is to minimize the influence of the foreign elements in the city administration. Arguments in favor of its candidate is a necessity in view of the approach of the World's fair, of putting the city in to a condition as to clean streets and to render the police force self-sufficient. Thieves, gamblers and other criminal classes, will not dare to flock to the city in anticipation of a rich harvest.

## FIENDISH MURDER.

PITTSBURG, April 6.—John S. Gonzales, a woodworker, was found dead near West Liberty, Pa., today, with a bullet-hole through his head, and his pockets rifled.
