The graduating class consisted of three young ladies and one gentleman. They are: Veina E. Adair and Linna A. Holt, of Eugene; Etta Lewis, Harrisburg; J. Clarence Veazie, Dallas. The first prize was carried away by Miss Etta Lewis, the young lady from Linn county, and the second prize by Miss Veina Adair. Mr. Veazie was valedictorian. All acquitted themselves with honor.

PORTLAND POLITICS.

CHIEF PARRISH LIKELY TO BE OUSTED.

A Demand to Reorganize the Police Force of the Metropolitan Senator Mitchell's Views.

PORTLAND, June 18.—A movement is being inaugurated to bring about the removal of Chief Parrish and the reconstruction of the police force. The Telegram this evening says: It is learned that a petition has been prepared under the auspices of the Young Men's Municipal Reform Club, asking the police commission to remove Mr. Parrish and such members of the police force who have been guilty of obnoxious petisanship or have otherwise demonstrated their unfitness, and this petition will be put into circulation to-morrow among the voters of the city, who will be asked to sign it.

THE BRIDGROOM ARRESTED.

A Country Elopement That Developed Into a Case of Abduction

NORWICH, N. Y., June 18.—There was a romantic elopement of a pair of lovers from Guilford and a midnight marriage here on Friday night last. The bride had just passed her fifteenth birthday. She is the only daughter of Devillo to a well-to-do farmer of the town of Guilford, and has been tenderly brought up and well educated. The groom is a young farm hand, aged about twenty years, and having a fair share of good looks. They became engaged and wanted to marry, but the girl's parents forbade the match on the ground that she was too young and that her lover had not the means to give her a suitable support. On Friday evening they stole out of the Eccleson mansion together, and getting into the carriage which the groom had provided, they drove post haste to this place. Justice Nash was called out of bed and made them early in the morning. The next morning the bride and groom were taken to the county jail here to await the action of the grand jury on the charge. The father reclaimed his daughter who tearfully consented to return home with him. He angrily divorced for his daughter, and will prosecute her alleged abductor to the full extent of the law.

MARRIED AN INDIAN.

A Pretty Author Becomes the Bride of a Sioux

NEW YORK, June 18.—Miss Elaine Goodale, the well-known author, who is government inspector of Indian schools in North and South Dakota, and Dr. Charles A. Eastman, an Indian of the Sioux tribe, who is government physician at the Pine Ridge agency, were married today at the Church of the Ascension.

FATAL CLOUBURST.

Twenty-five Miners Entombed and One Drowned.

NEW YORK, June 18.—A dispatch from the City of Mexico: A cloudburst killed at least twenty-five people and many mules, besides doing great damage to property at the Concepcion mine, at San Luis Potosi, to-day. The mine was working at full blast at the time, and there was no indication of the impending disaster early in the morning.

A Brutal Prize Fighter.

ST. PAUL, Minn., June 18.—Pat Killen, the well-known pugilist, was yesterday sentenced to five months' imprisonment, three months for kicking Matthias Kuffman, and two months for kicking and slapping Miss Lizzie Allen into unconsciousness. Killen ran away as soon as he committed the cruel assault and is now in Chicago, but will be brought back here to serve his time as soon as the officers can locate him.

GEN. SCHOFIELD WEDS

The Commander-in-Chief of the Army Wins a Young Bride.

NEWS EAST OF THE ROCKIES.

Project of a Railroad to Alaska—A Destructive Cloudburst in the South

—Many People Killed.

KEOKUK, Ia., June 18.—The marriage of General John M. Schofield, commander-in-chief of the army of the United States to Miss Georgie Kilbourne, of this city, took place in St. John's Episcopal church to-day. The groom is a gray veteran of the war, and is over 60 years of age. His bride is a handsome young woman of 26. She has a comfortable fortune of her own. Years ago she was a girl chum of General Schofield's daughter and later made long visits at the general's home at Washington. His wife died a few months ago, and for a new one he chose Miss Kilbourne. As far as consistent with the rank of General Schofield and his bride, to-day's wedding was devoid of display; the only military feature being the general and staff who appeared in full uniform. Only immediate friends and relatives of the contracting parties were present. The city is handsomely decorated for the occasion.

RAILROAD TO ALASKA.

A Scheme to Build It Into the Far Northwest.

CINCINNATI, June 18.—Hon. Charles Francis Adams, of Boston, ex-president of the Union Pacific, has written a letter to E. H. Wells, the Alaskan explorer, concerning the latter's published scheme for building a railroad to Alaska. Adams says:

When I was in the Dominion and also in Alaska, it seemed to me not impossible the time might come when a railroad would be needed and would be surveyed for from Winnipeg northwesterly into the mining country of Alaska; but I was equally persuaded of the fact that this time had not come, neither do I believe it will come within the next ten or fifteen years.

This significant letter is construed as a conservative admission from Adams that an Alaska railway may actually be built within the next twenty years, thus forming a link of the chain that is to connect the czar's Siberian railways with America.

MODERN CAIN AND AEL.

Fatal Results of a Quarrel Between Two Brothers.

CARMEI, N. Y., June 18.—Frank Fallamale, the 8-year-old son of a mechanic living in Brewsters, N. Y., was shot on Tuesday morning by his brother Fred, four years older than himself. The little fellow died the same afternoon, after Dr. Miller had vainly tried to extract the bullet, which had lodged in his hip. It was at first thought the shooting was accidental, but it now looks as if Fred deliberately killed his unfortunate brother. John Fallamale, the father of the boys, makes a statement that leaves no doubt as to Fred's guilt. The father said that after the boys awakened, but before getting up, they had quarrelled. Fred was heard to tell Frank he wanted to shoot. A moment later Fred got up and obtained his father's pistol, with which he shot the little fellow. Frank did not recover consciousness sufficiently to tell his story.

RIDDLED WITH BULLETS.

A Mysterious Murder in a Florida Battle-boat.

FORT WHITE, Fla., June 18.—At this morning's trial was passing the woods between Bradford and Fort White, the passengers saw the body of a man tied to a millpost. The train was stopped and the body was found to be that of a tall man, apparently about 21 years of age, lashed fast by a rope around his neck and waist. His hands were tied behind his back and his body was riddled with buckshot. Inquiries at the next station showed that nothing had been heard of any lynching. The authorities are looking into the matter.

A Ship on Fire.

SAN FRANCISCO, June 18.—The French ship Valparaiso, which was sighted some days ago proceeding to this port with a fire in her hold, was towed into port this morning by the tug Relief, which had been sent out to meet her. The vessel was 255 days from Shields, England, and 62 days from Valparaiso, with a cargo of 190 tons of coal, consigned to Eugene Thomas, of this city. The fire was extinguished after 150 tons of coal had been jettisoned. The damage by fire has not been estimated.

Drowned While Out Sailing.

PETERSBORO, Ont., June 18.—A party of eleven persons of Hia-watha went sailing in a small yacht on Rice lake, last evening. A sudden squall captured the craft, and John Foote, and his 19-year-old daughter and 3-year-old baby were drowned. The others were rescued. The bodies were recovered.

Killed by a Tornado.

HARTFORD, June 18.—It is reported that a tornado at Avon, in the valley of the Farmington river, yesterday afternoon did great damage, and that three persons were wounded or killed. No further particulars have been received since midnight.

Poor Harvests in Europe.

LONDON, June 18.—A Times (Vienna) correspondent says the harvest in Hungary will be middling in quality and quantity, while in Austria it will be decidedly inferior to the harvests of the last five years.

A WICKED MOTHER.

She Skins in Society, But Was Cruel to Her Child.

ELGIN, Ill., June 18.—George E. Bowen is under arrest for breaking an ice pitcher over his wife's head. He is the son of millionaire Geo. S. Bowen, president of the National Electrical Society and a well known railroad man, who operated in New York state. The wife

is the daughter of a Chicago Board of Trade operator named Creighton, who owns an elegant country seat here. The couple were married with elaborate ceremonies about three years ago. Domestic differences began before the honeymoon ended. Mrs. Bowen had been accustomed to keep her child in a yard made of wire netting while she attended to her society affairs. The neighbors say she occasionally kept her infant there all night. Divorce proceedings are in progress.

A Parrot Story.

Some time ago a captain, who had been on a long voyage, brought home a parrot. The parrot, who had been with him, had learned some of the sailor's sayings. One evening the captain invited a friend to supper, and began talking about where he had been, to which the parrot replied: "That's a lie!"

His Church Followed Him.

PITTSBURG, June 18.—Last night the congregation of the Allegheny Reformed Presbyterian church, Rev. J. R. Milligan, pastor, who was recently deposed by the synod, unanimously withdrew from the Reformed Presbyterian church and will seek admission to the United Presbyterian church. Compulsory Education Bill Vetoed

HARRISBURG, June 18.—Governor Pattison today vetoed the compulsory education bill passed by the legislature.

WASHINGTON GOSSIP

THE PRESIDENT GOES TO THE SEA SHORE.

Accompanied by Mrs. Harrison and Her Lady Friends—News of the Capitol.

WASHINGTON, June 18.—The president, accompanied by Mrs. Harrison, Mrs. Dismick, Mrs. George R. Williams and Miss Ella Warfield, left Washington at nine o'clock over the Pennsylvania railroad, for Crpe May Point. The cottage there is ready for the party. The president will remain at the seashore till next Tuesday.

R. N. Beltz, assistant commissioner of Indian affairs, has left for San Francisco, where he will open bids and award the contracts for furnishing the Pacific coast Indians with provisions, agricultural implements and hardware.

The treasurer's statement issued to-day shows the net balance is but \$1,235,000, which is the lowest figure yet reached.

Secretary Foster left Washington this morning for a week's visit to his home in Fostoria, Ohio.

Secretary Proctor has gone to Vermont for a week or ten days.

THE BARBOUR MURDERERS.

The Meshes of the Law Closing Around the Assassins.

PORTLAND, June 18.—James Williams, one of the murderers of Wm. M. Barbour, the Lebanon merchant, in this city, who was held without bail for the crime, is now in the county jail, while Henry Wilson, or "Dukes," as he is now known, is confined in the general cell as a witness.

"Dukes" complains because Charles Davis, who was brought down from Montana, gave some damaging testimony against Williams, and also put "dukes" in a fair way for the penitentiary.

Davis claims that Williams' partner, White, who really did the killing, failed to divide the spoils as all the accomplices thought he should, and while in jail at Butte, Jimmy Rice, one of the murderers squealed.

Wilson said that while in jail with Williams in Butte the latter confessed that he and one White had spotted Barbour in Portland, and, after following him a ways out of town, started in to rob him. As he showed fight White, or "Leavenworth Fatty" shot him and then both threw his body into the creek. Rice said that White did not make a fair 'divy,' and claimed he only got about \$40.

There is no longer any question but Williams is one of the correct parties, and the others are now tracing White, who is believed to be somewhere in Utah.

Funeral of the Victims.

BASILE, June 18.—A public funeral was held for a large number of victims of Sunday's disaster near Mosenchenstein. The entire population attended the funeral.

No Truth in the Report.

LONDON, June 18.—An investigation by the stock exchange of reports of a revolution in Portugal proves them entirely unfounded.

Left for Behring Sea.

SAN FRANCISCO, June 18.—The United States steamers Mohican and Alert, left this morning to join the other government vessels in Behring sea.
