FARMERS ALLIANCE Completion of the State Organization in Portland. OFFICERS FOR THE YEAR. Membership Dues the Cause of Discussion —Pierce is President and Bruce is Vice President.

Portland, July 9.—The alliance met this morning at 9 o'clock pursuant to adjournment. The first thing in order was the report of the committee on constitution. An hour more was taken up discussing the various articles of the proposed constitution, and it was finally adopted, with several amendments.

The quarterly dues were fixed at \$1.05, of which 60 cents is to be paid into the treasury of the state alliance, and 45 cents into the treasury of the local sub-alliance. This discussion took up the time till noon, when an adjournment was had until 1 o'clock this afternoon.

The alliance met at 1:30 this afternoon and proceeded with the election of officers: President, Nathan Pierce, of Unatilla county. First vice president, Major J. Bruce, of Benton county. Second vice president, S. H. Holt, of Jackson county. Secretary, W. W. Myers, Clackamas county.

Mr. Pierce, the first president of the Oregon State Alliance, is an extensive farmer of Milton, Unatilla county, in which town he lives and adjoining which he has several hundred broad acres of exceedingly fertile land. Formerly he was a democrat, but for several years has identified himself first with the prohibition party and next with the alliance party. He is a man of excellent character and intelligence, but has no special qualifications as an executive officer. In this respect the convention could have made many selections that might have been better, but time and experience may develop abilities in Mr. Pierce that he is not known to possess. The fact that he is radically in favor of prohibitory laws would seem to be as strong an endorsement of prohibition as if such a prohibition plank had been put in the platform.

Mr. Bruce is an old-time farmer of Benton county, and last year was the third-party candidate for congress.

Harvesting has commenced in the Willamette valley. Superintendent Downing, of the state penitentiary, says: 'We are nearly full. Three more men exhaust our capacity, and we will have to ask the courts to send no more convicts here.' There is now about 400 convicts in the penitentiary.

A few of the wool growers of Cook county have sold their wool, realizing on an average about 16 cents a pound in the Dallas. They say that at this price their wool realized them more than 100 sheep that they had raised last year. Their clip being much heavier than that of last year.

Although money is scarce at Union, where the original company was organized, as it is now at every place in the Northwest, the people there quickly subscribed \$10,000 worth of stock in the construction company, which evidences their faith in the new plan of railroading the country, as soon as organization is effected and plans arranged, will build the initial single-rail and saddle track railroad in Oregon, probably in the Willamette valley. Some of the original company's stock is being sold at Portland for fifty cents on the dollar. Dr. Mahana was in the city to-day, en route for Union. He leaves tonight for Portland, to remain some time.
