A \$25,000 Damage Suit—The Result of Old Veterans Love for Mail.

SALFEM, Aug. 4.—A license to wed was issued today to Benson Starr, of Olympia, and Laura L. Goltra, of Albany and Salem.

Papers insinuating quite an interesting story of romance in real life have been filed with the county clerk, instituting a suit for damages in the sum of \$2500 against an old Grand Army man named Benson Starr, the plaintiff, and E. Goodenough, who claims a breach of marriage contracts. She claims that she was living in Missouri and through the board of trade got into a correspondence with "Baby," who wanted to marry her. She said "her things and came west," when he said she didn't suit him. According to his story he was not to marry her unless, after eight of her, she pleased him, which she did not do. "Baby" has lost the sight of one eye and is losing the other. The suit comes on trial in October.

AN EDITOR SHOT.

A Rival Newspaper Man Shoots His Prospective Son-in-Law.

OAKLAND, Cal. Aug. 4.—R. S. Calvin was shot and fatally wounded last night by John G. Howell, a former newspaper proprietor. Calvin, who is the editor of a small weekly paper, was in love with Howell's daughter, and it is reported they were at one time engaged, but the engagement was broken. Since then Calvin, it is stated, has been forcing his attentions on the young lady. Calvin and a friend met Howell on the street last evening and the three went to a room in the Wilcox block to talk over the matter. Calvin, in his ante-mortem statement, says Howell suddenly ordered him to throw up his hands and began firing. The latter was arrested but deemed to be innocent. Calvin passed a comfortable night under the influence of opiates. There is a possibility he may recover. The hemorrhage is very slight. He is in no condition to make any statement this morning. No charge has been made against Howell. He is perfectly cool and seems to be justified in his action last night. Calvin, a few days ago in speaking to a reporter, said he met Miss Howell at a church fair and became infatuated. He talked incoherently about her, saying he wanted to see her and make an explanation. All his friends believe his mind is affected by his infatuation for the young lady, who never encouraged him. Some time ago Howell was considering attempting to send Calvin to the asylum, but gave it up because no evidence could be obtained. Calvin was dangerous to the life of Howell's daughter and nothing of her father's intention till he had shot Calvin. She bears the highest reputation, and is a well-known teacher in the Franklin school.

NEW YORK EDITORS ALL INDICTED.

THE BOYS IN BLUE

The Twenty-Fifth Annual Encampment of the G. A. R.

A MONSTER PROCESSION.

Over 40,000 Veterans and Twenty-Eight Bands in Line—It Was a Hot Day.

DETROIT, Aug. 4.—The opening day of the twenty-fifth annual encampment marks the quarter of a century in the growth of the organization, and every soldier realizes that it must also mark the apex in the prosperity of that great order. It has been the desire of all prominent leaders of the organization that the twenty-fifth encampment should be the most successful in the history of the G. A. R. and the parade the most magnificent ever known.

Forty-two thousand men and one hundred and twenty-eight bands of music, the largest city band stand was a quarter full when the Buffalo Veterans marched up, comical Uncle Sam headed the ranks followed by files in yellow linen continental garb, and color bearers carrying a dozen old battle flags. After after cheer echoed as they passed and in like manner were they honored by the "Navies."

The crowd was tremendous, and that does not half express it. Not only boys climbed trees to get a better view of the festivities, but grown men and grey bearded fathers swung themselves into the branches and peered down with as much eagerness and as little dignity as any of the rising generation. Just as the spectators began to wonder if the parade was going to be late, the front of the famous old Thomas post of Chicago appeared in the distance giving the signal for a roar of greeting and the excited crowd that was drowned by the noisy bands for the time being. One old soldier who persisted in carrying an open umbrella to protect him from the hot descending rays of the sun was made the butt of many humorous remarks. The parade started exactly on time and moved without a break over the prescribed route. Arriving at the reviewing stand in the Campus Martius, Commodore J. W. Vessy, dismounted and Senior Vice Commodore Irwin led the column of nearly 40,000 over the remainder of the route. The parade continued six hours.

Twenty-eight hundred veterans from Indiana were greeted with cheers. Following their orders were divisions from Colorado, Wyoming, Kansas, Delaware, Minnesota, Missouri, Oregon, West Virginia, South Dakota, Washington, Idaho, Arkansas, Alaska, Arkansas, Montana, and Texas. The naval veterans and Sons of Veterans, 5089 strong, brought up the rear and closed the parade.

A DESPERATE FIGHT

BATTLE BETWEEN CATTLE-MEN AND ROBBERS.

Forteen Men Killed—Officers and Physicians Waylaid and Killed in Louisiana.

ORANGE, Tex., Aug. 3.—Belder Sanders, who has just returned from Lake Charles, La., confirms the report of a riot at Lockwood, La., on the 1st of August. The last account he heard was from a wounded man who left the scene at 4 o'clock yesterday. He stated that fourteen men were killed and two were missing. It was a free-for-all fight between the "Red Bones" and "Whites." Sanders stated that many different reports are being circulated, and nothing more authentic could be learned. Latest reports place the number of wounded at sixteen. Officers and physicians were waylaid and murdered. Another account of the riot comes from Westlake, La., to the effect that the trouble was caused by the breaking out of an old feud between a band of robbers known as the Kingsworth gang and the cattlemen of that section.

The following is a partial list of those killed: Dyon, Marion, Markie, Lee Perkins, Owen Ashworth, of the Red Bone gang; and James Ward and Ewan, the cattlemen. The latest report is to the effect that everything is quiet. The coroner is making an investigation.

The Markets.

PORTLAND, Aug. 4.—The wheat market is unchanged.

The visible supply of wheat east of the Rocky Mountains is reported at 16,789,000 bushels, an increase of 2,689,000 bushels during the past week.

The wheat market is again unsettled. Some merchants are offered new, on which it is difficult to fix a price. They have offered all the way from 40c to 47 1/2c per bushel. Old will sell 56 1/2c higher, and is now bringing 47 1/2c @ 50c.

SAN FRANCISCO, Aug. 3.—The prices of wheat were quiet this morning. Wheat is steady with a fair demand. Barley is in heavy supply and prices are weak and lower. Oats and corn are dull, and prices are weak. There are no changes in millstuffs. Hay is in heavy supply and prices are fairly steady.

YAQUINA BAY

ENTRUSTWORTHY REPORTS ABOUT THE HARBOR.

The Government Engineers Accused of Doing a Bad Job Surveying the Bay.

PORTLAND, Aug. 4.—Dr. J. R. Bailey, a pioneer resident of Yaquina, in an interview published in the Telegram this evening, says: "There has been a great deal of improvement on Yaquina bay within the last two years, though the general depression in prices and scarcity of money has not allowed us to boom any. Still values of real estate have gradually increased, and a number of new buildings have gone up."

"The government had a tug there, twice surveying the bay, and I understand, has made a report. The Oregon Pacific tug, which knows the bay and thoroughly, finds about seven feet more water over the bar than the government tug did, which is in official charge of Captain Symons."

"The government vessel surveyed the bar in this way: It went across from one side to the other, till it got into shallow water—seven or seven feet—taking soundings all along, and then made up the depth by taking an average of all these soundings."

The captain of the Manzanita came there the day before I left, and reported better and deeper water than ever before—eighteen feet over the bar. The government surveying tug the same day, within an hour of the same time, reported only twelve feet. The captain in charge of the work on the jetty-work says the water is better than ever before; it has been improved to the extent of three feet in depth by the work done within the last six months. Vessels coming in report four or five feet more water than the government engineers report."

The Telegram adds editorially: It seems that Yaquina harbor is also a victim of Captain Symons' alleged investigations, although we have not read his report yet. It will probably be that the harbor is unnavigable, and improvements thereon might as well stop.

Was It Murder?

NEW YORK, Aug. 4.—The body of the girl who was found murdered at Glendale, L. I., yesterday, was identified to-night by Charles Webber, of New York, as his niece, Miss Haver, 22 years old, of North Haven, Conn., who left that place Saturday morning with a man named John Habe. The girl, who was infatuated with Habe, inherited several thousand dollars from her mother, and has still \$5000 to her credit in the First National bank of this city. When she left North Haven she had \$275 on her person, and Webber believes she was murdered for the money. The New York and Brooklyn police are looking for Habe.

Trouble Brewing in Spain.

Vessy, dismounted and Senior Vice Commodore Irwin led the column of nearly 40,000 over the remainder of the route. The parade continued six hours.

Twenty-eight hundred veterans from Indiana were greeted with cheers. Following their orders were divisions from Colorado, Wyoming, Kansas, Delaware, Minnesota, Missouri, Oregon, West Virginia, South Dakota, Washington, Idaho, Arkansas, Alaska, Arkansas, Montana, and Texas. The naval veterans and Sons of Veterans, 5089 strong, brought up the rear and closed the parade.

A DESPERATE FIGHT

BATTLE BETWEEN CATTLE-MEN AND ROBBERS.

Forteen Men Killed—Officers and Physicians Waylaid and Killed in Louisiana.

ORANGE, Tex., Aug. 3.—Belder Sanders, who has just returned from Lake Charles, La., confirms the report of a riot at Lockwood, La., on the 1st of August. The last account he heard was from a wounded man who left the scene at 4 o'clock yesterday. He stated that fourteen men were killed and two were missing. It was a free-for-all fight between the "Red Bones" and "Whites." Sanders stated that many different reports are being circulated, and nothing more authentic could be learned. Latest reports place the number of wounded at sixteen. Officers and physicians were waylaid and murdered. Another account of the riot comes from Westlake, La., to the effect that the trouble was caused by the breaking out of an old feud between a band of robbers known as the Kingsworth gang and the cattlemen of that section.

The following is a partial list of those killed: Dyon, Marion, Markie, Lee Perkins, Owen Ashworth, of the Red Bone gang; and James Ward and Ewan, the cattlemen. The latest report is to the effect that everything is quiet. The coroner is making an investigation.

The Markets.

PORTLAND, Aug. 4.—The wheat market is unchanged.

The visible supply of wheat east of the Rocky Mountains is reported at 16,789,000 bushels, an increase of 2,689,000 bushels during the past week.

The wheat market is again unsettled. Some merchants are offered new, on which it is difficult to fix a price. They have offered all the way from 40c to 47 1/2c per bushel. Old will sell 56 1/2c higher, and is now bringing 47 1/2c @ 50c.

SAN FRANCISCO, Aug. 3.—The prices of wheat were quiet this morning. Wheat is steady with a fair demand. Barley is in heavy supply and prices are weak and lower. Oats and corn are dull, and prices are weak. There are no changes in millstuffs. Hay is in heavy supply and prices are fairly steady.

Was It Murder?

NEW YORK, Aug. 4.—The body of the girl who was found murdered at Glendale, L. I., yesterday, was identified to-night by Charles Webber, of New York, as his niece, Miss Haver, 22 years old, of North Haven, Conn., who left that place Saturday morning with a man named John Habe. The girl, who was infatuated with Habe, inherited several thousand dollars from her mother, and has still \$5000 to her credit in the First National bank of this city. When she left North Haven she had \$275 on her person, and Webber believes she was murdered for the money. The New York and Brooklyn police are looking for Habe.

Trouble Brewing in Spain.

LONDON, Aug. 4.—The condition of affairs in Spain is reported as very uneasy. The whole country has been made restless by the fighting in Barcelona, and in Madrid the workmen assembled last night in groups on the corners and discussed the struggle and its object. The sympathy of the people was evidently with the captive revolutionists.

Placed on the Retired List.

WASHINGTON, Aug. 4.—The president has approved a finding of a retiring board that examined St. John F. Melgs, U. S. N., for retirement on account of color blindness, and he has been placed on the retired list.
