CHINESE WAR.

A Grave Situation in Peking and Other Centres.

EUROPEAN NATIONS WATCH.

They Want a Head in the Middle, Providing They Get a Vantage Thereby.

HONGKONG, Aug. 19.—The situation at Peking is grave. The ministers of England, France and Germany, in behalf of others, have daily interviews with Tsung Li Yansen. Hunan is the center of trouble. The bulk of the army is composed of Hunan men, and they defy the authority of the Peking government. The ministers insist that secret societies shall be suppressed, that Hunan shall be opened to commerce, that the mandarins who were implicated in the riots shall be degraded, and that a grant of land for villages, with assurance for the future, or the powers will take immediate action.

The government recognizes that the old tactics of playing the powers against each other is futile and is against their humanity. The emperor is anxious to avoid war. He dreads attempting to coerce the provinces, doubting the loyalty of high officials.

The Chinese openly favor a pure Chinaman for emperor, and advocate expelling the Tartar dynasty. The attitude of many of the troops is suspicious. Li Hung Chang is sitting still, keeping away from the scene of the trouble.

The cost of twenty foreign warships in the Yang-tze-Kiang is heavy, but if they are moved outwards will be repeated.

An English missionary named Gray was nearly murdered by soldiers at Kiran. Unless active steps are taken all the missions will cease operations.

The central government's usual tactics are to temporize, and to refer matters to local officials, but it is anxious to avoid a change of venue from Peking. They have gone too far for retreat without a total loss of prestige. The government is utterly paralyzed, and is afraid to display its rottenness by attempting any action in English, Russian and French fleets are awaiting orders within easy distance.

China is in a dilemma with regard to the movements against her rebellious subjects. The imperial dynasty's refusal would render foreign intervention inevitable. It is believed, however, that at the first sign of force the present obstinacy of the government would give way.

The State University.—The report of the Board of Regents of the State University at Eugene, which has been submitted to Governor Penney by Hon. M. P. Deady, the president, shows the affairs of that institution to be in a prosperous condition. The report shows that during the past year the university numbered 352 students on its rolls. Of these 217 were in the classical department, thirty-six in that of law, twenty in the medical department, and the remainder in the department of music. Almost all the students are from the State of Oregon.

The faculty are: John W. Johnson, A. M., professor of ethics and Latin; Mark Bailey, Ph. D., professor of mathematics and astronomy; Thomas Condon, Ph. D., professor of history, geology and natural science; Benjamin J. Hawthorne, A. M., professor of mental philosophy and English literature; Geo. H. Collier, L. L. D., professor of chemistry and physics; John Stubb, Ph. D., professor of Greek and modern languages; Luella C. Carson, professor of rhetoric and elocution; Samuel E. McClure, A. M., tutor. Those of the school of law: Richard H. Thornton, professor of the science and practice of law; and evidence; Lewis L. McArthur, pleading; C. B. Bellinger, equity. Staff of the school of medicine: Dr. Bingham, chemistry; Dr. McKenzie on theory and practice of medicine; Dr. Bell, materia medica; Dr. Strong, gynecology; Dr. Saylor, clinical surgery; Dr. Nunn, anatomy; Dr. Josephi, obstetrics; Dr. G. Wilson, operative surgery; Dr. Flinn, physiology; Dr. Eaton, the eye and ear; Dr. G. Wells, diseases of children; Dr. Giesy, hygiene; Dr. W. Jones, clinical diagnosis; Dr. J. Wells, general pathology; Dr. Bevan, clinical surgery; Dr. Holl, zymotic diseases; Dr. Mackey, microscopy.

The finances of the university are in as flourishing condition as are its academic affairs. By the reports to date receipts amount to \$27,996.11; total disbursements, \$25,368.20—leaving a balance on hand June 30, 1891, of \$2627.92. The report from the land fund shows a gain of \$7814.94 during the year.

At the annual meeting of the regents the degree of master of arts were conferred upon Henry F. McClure, Robert Collier, A. C. Woodcock, R. F. Reasoner, D. V. Bass, W. C. Cardwell, Jennie McClure and Eva Rogers. The degree of bachelor of laws was also conferred on Charles E. Lockwood.

The sum of \$800 was appropriated for the school of law, and that of \$1000 for the school of medicine, together with \$100 for periodicals. An assistant was given to the janitor at a salary of \$300.

Mr. S. McClure and Miss Philuta E. Murch, tutors, each had their salaries increased \$100 for the ensuing year.

It was discovered this morning that he is a deserter from Company I, first artillery, and a reward of \$500 is offered for his apprehension. Wren says Snyder joined the army as a result of a quarrel with a girl to whom he was very attentive. He is well educated, and time of his army escapade was holding a good position in a Jersey City bank. An effort will be made to buy Snyder out of his present difficulty. If he attempts to claim his newly-acquired wealth he will receive better notice than desertion.
