EDITOR'S TRIBUTE.

Henri Rochefort Believes in Sticking to Old Friends.

BOULANGER'S DEFENDER.

He Leaves An Old Friend a Fine Tribute—Makes a Brave Effort to Brighten His Memory.

PARIS, Oct. 1.—The following article appears in this morning's L'Intransigeant, from the pen of M. Rochefort, it having been telegraphed from London last night: "I had anything but a profound opinion of the man, but the force of the various indignities heaped upon our dear and worthy friend by obscure wretches who made France their prey and their victim, Hamibal, when he slew himself, had at least been vanquished by Scipio. Boulanger succumbs to the blasts of Germans, Hebrews, thieves and ruffians. These wretches combined to call him 'General La Venette' and 'Brave Concussion Naire.' This 'Concussion Naire' had robbed the ministry of a sum sufficient only for the purchase of a revolver, and 'General La Venette' went voluntarily to his death. He had fifty of his followers, abandoned by his own followers, insulted by an ignoble press, and many of these whom he rescued from want and bankruptcy. He expires upon the tomb of the woman who sacrificed her life for him. The man who falls with his shoulder shattered at Champanne, while his accusers, his judges of yesterday, he smuggled into their cellars—men who had mastered the republic and whose personal scruples deterred him from seizing the reins of power. He will have his legend, and his place in history, despite the ordure and the insults, which the hirelings of a gutted press will throw upon him for the last time. Constans should be happy. His yast cemetery is enriched by one more corpse. I advise him, however, not to abandon himself to too much joy. 'Ce n'est pas est de ceux qui reviennent.'"

ANOTHER REPORT.

Central American States Keep Up Their Record.

GUATEMALA, Oct. 1.—News of the most sensational character has been received here during the past twenty-four hours. There is considerable excitement in San Salvador regarding the revolt in Guatemala. A ray of light has just been thrown on the present revolution in Guatemala by a retired American officer, now residing in this city, who for various reasons, does not want his name to appear in connection with the story. According to the story he tells, three Americans supplied with plenty of money visited this city about two months ago. To him they disclosed the fact of a revolutionary government in New York that had for its object the downfall of Barrilla's government in Guatemala, and were backed with funds to carry the movement to a successful issue. Their plan of action was to send experienced military officers into Guatemala. They were to be distributed throughout the republic, and when the time was ripe were to take command of the revolutionary troops. He believes the present revolution is due to the New York parties who furnished funds and ammunition for the insurgents.

CANNOT ESCAPE.

They Are Surrounded In a Canebrake Swamp.

MEMPHIS, Oct. 1.—Since the killing of Overseer Tom Miller on J. F. Frank's plantation and the burning of the plantation, the gin house on Saturday, a posse of city men have been after the rioting cotton-pickers in Lee county, Ark. On Sunday one was killed and several wounded. The rest found refuge in a large canebrake, which was surrounded and the lines patrolled by thirty six white citizens. The cane is very tall and dense, and affords a good shelter. On Tuesday a party of eight negroes attempted to escape. Three of them were shot; one named Peterson was killed instantly. Bob Patterson, leader of the band, was mortally wounded, and another received a flesh wound. The five were captured. The excited captors wanted to lynch them, but cooler heads prevailed, and they were marched under heavy guard to the Lee county jail at Marietta. Yesterday afternoon Captain Busch, of Marietta, arrived at the scene with bloodhounds. They were put on the track of the fugitives in the canebrake, and it is thought they will soon be captured. Escape is impossible, as the canebrake is surrounded with men, and if the negroes resist they will be killed. Tom Miller's body was found by one of the posse, where his murderers had left it, riddled with buckshot. The country is unsettled and cotton-picking is at a standstill. Many negroes have fled, and the loss will be serious.

CAST ON THE ROCKS.

A Steamer Wrecked According to a Report Received.

NEW YORK, Oct. 1.—The big sidewheel Sound steamer, C. H. Northam, which left this city for New Haven, was reported last night to be high up on the rocks. The steamer was brought to this city by a party of excursionists. They reported passing the steamer about 7 o'clock last night. She was brightly illuminated and her passengers could be seen moving hastily about her decks. It was dark at the time, but the excursion boat raised a cloud of steam, and the stranded vessel to distinguish her name. The C. H. Northam left her pier at the foot of Peck slip at 3 o'clock yesterday afternoon. She carried about 200 passengers, it is said, and a full cargo of mixed freight. The steamer was due to arrive at New Haven at 8 o'clock last night. When the excursion party passed the stranded steamer, a small boat is said to have been alongside with some sailors climbing into it. It is presumed they were going ashore for help. Black Rock has long been complained of by mariners; no night marks it, and it is almost directly in the path of passing vessels. A heavy sea was running last night and a stiff breeze was blowing. It is feared the steamer may be seriously injured.
