## COMMISSIONERS WIN.

Judge Boise Says That Their Rates Are Reasonable.

## THE RAILROADS WILL APPEAL.

Steamer Madoe for the Upper River—Paraded Out of the Penitentiary—From Prison to Asylum.

**SALEM, Oct. 20.**—Judge Boise rendered an oral decision in the case of the Union Pacific Railroad Company, vs. the State Board of Railroad Commissioners. This was a writ of review proceeding, the company alleging in the petition that the board of commissioners acted without evidence in fixing rates; that the company had no notice of the time and opportunity to be heard. On the return of the board showing what evidence was considered and what notice given, Judge Boise decided that the evidence was sufficient and also the notice, and that the commission made no error in issuing said order. The judge dismissed the writ.

In the matter of the Southern Pacific Co.'s demurrer to the complaint filed by the board in the matter of rates, the demurrer was overruled, and the company given until Friday to file an answer. The demurrer was also overruled in the case of the Union Pacific and the company given until Friday to answer. The attorneys for the company expressed their intention of answering. The Union Pacific case as well as the Southern Pacific, now come up on the complaint of the commissioners to enforce rates.

Frank McLeuch, living one mile north of Lincoln, was in town today after an outfit of mining tools to develop the field on his Lincoln ranch. He thinks he has discovered a rich iron mine. He brought some samples of the ore to Salem, and they promise well. He thinks he has made a valuable discovery.

The Union Pacific Company will put the steamer Madoe on the upper river route as soon as there is enough water. This will be probably the last of the month. The Oregon Pacific will have their boats on the upper river. The steamer Ewood will also ply the Salem and Portland route.

The railroad commissioners start south to-morrow on their semi-annual inspection of the lines of the Oregon & California in Oregon. They will go as far as Ashland. The Marion County Fruit Growers Association met at the court house to-day and discussed matters of interest to the horticulturist. Samples of dried fruits were exhibited. The association resolved to have a board of agriculture be requested to make an appropriation sufficient to defray the expense of the fruit palace for the fair of 1892.

David S. Bingham, sentenced to the penitentiary for Baker by Governor Penney, was paroled to-day by Governor Penney. The pardon was granted on the recommendation of the district attorney. Bingham was serving a term of one year. He came to the prison on June 27 last.

August Klingebil, a convict in the Oregon state prison, was examined as to his mental condition to-day and committed to the asylum. He came to the penitentiary on July 12, last, to serve a year term for arson by bailment. He is from Multnomah county, whence come nearly half of the prisoners. There are now 373 there.

**Dead in His Own Boat.**—Coo's Bay News. On Monday forenoon, Walter Byron, Bailey and Henry Morris, arrived in town, towing a skiff which contained the body of John E. Williams, which they had found close to the mouth of Catching slough. When they discovered the skiff on the mud-flat, the shoulders and right foot of deceased were hanging over the side of the skiff, immersed in the water, the body being held in this position by the left leg, which was caught under the forward seat. Coroner Butler was notified, and immediately took charge of the remains. The deceased was born in Manchester, England, and came to America in 1873, and to Coo's Bay in 1874. He was 54 years old and leaves a wife to mourn his loss.

## THE FACTIONS WILL UNITE.

He Will Be Accepted to the Parallels—Never Has Abused Parnell But Spoken Well.

**LONDON, Oct. 20.**—Mr. John Dillon's speech eulogizing Parnell has considerably softened the feelings of the Parallels toward him, especially as it was coupled with a repudiation of the attacks in the Dublin Catholic on Parnell's memory. There is now believed to be a possibility of reconciliation under Mr. Dillon. No one doubts the truth of Mr. Dillon's statement that he loved Parnell, and there is only one speech of Mr. Dillon on record in which he antagonized Parnell, and that was on the subject of the Paris fund, and a few days before Parnell's death. Before going to jail, Mr. Dillon had been careful to keep a moderate course. He hoped that discussion would come to an end before his release. Upon being liberated, he threw his lot in with the McCartlyites, but he never used personal abusive terms regarding Parnell, and the utmost charged against him by the Parallels is that, when an offensive term was used in his presence, he failed to rebuke it. There is no proof that he heard it, and if he did he probably thought it best to ignore it. Mr. Dillon is undoubtedly considered by the Parallels the strongest man in the two factions, and the most positive and commanding character.

**JAPAN'S EMPEROR.**—It is no Longer Good Form to Call Him "Mikado."

The name of Mikado is, most persons know, now an entirely obsolete imperial title, the Japanese using the title of Kotai in Japanese, and Emperor when speaking to foreigners or in a foreign tongue. European countries frequently, however, still make use of the title Mikado, which is a breach of etiquette in Japanese estimation. Russia, for instance, still speaks of the Emperor of China as Mikadohan, and until a few years ago persisted in speaking of the Emperor of Japan as the Mikado, but during the Viscount Enomoto's residency in Russia as Japanese Minister he informed the Russian Government of its error, and pointed out the historical reasons for this title being no longer used, since which time of the Russian Government has continued to the use of the European title, Emperor.—Japan Gazette.

## COMMISSIONERS WIN.

Judge Boise Says That Their Rates Are Reasonable.

## THE RAILROADS WILL APPEAL.

Steamer Madoe for the Upper River—Paraded Out of the Penitentiary—From Prison to Asylum.

**SALEM, Oct. 20.**—Judge Boise rendered an oral decision in the case of the Union Pacific Railroad Company, vs. the State Board of Railroad Commissioners. This was a writ of review proceeding, the company alleging in the petition that the board of commissioners acted without evidence in fixing rates; that the company had no notice of the time and opportunity to be heard. On the return of the board showing what evidence was considered and what notice given, Judge Boise decided that the evidence was sufficient and also the notice, and that the commission made no error in issuing said order. The judge dismissed the writ.

In the matter of the Southern Pacific Co.'s demurrer to the complaint filed by the board in the matter of rates, the demurrer was overruled, and the company given until Friday to file an answer. The demurrer was also overruled in the case of the Union Pacific and the company given until Friday to answer. The attorneys for the company expressed their intention of answering. The Union Pacific case as well as the Southern Pacific, now come up on the complaint of the commissioners to enforce rates.

Frank McLeuch, living one mile north of Lincoln, was in town today after an outfit of mining tools to develop the field on his Lincoln ranch. He thinks he has discovered a rich iron mine. He brought some samples of the ore to Salem, and they promise well. He thinks he has made a valuable discovery.

The Union Pacific Company will put the steamer Madoe on the upper river route as soon as there is enough water. This will be probably the last of the month. The Oregon Pacific will have their boats on the upper river. The steamer Ewood will also ply the Salem and Portland route.

The railroad commissioners start south to-morrow on their semi-annual inspection of the lines of the Oregon & California in Oregon. They will go as far as Ashland. The Marion County Fruit Growers Association met at the court house to-day and discussed matters of interest to the horticulturist. Samples of dried fruits were exhibited. The association resolved to have a board of agriculture be requested to make an appropriation sufficient to defray the expense of the fruit palace for the fair of 1892.

David S. Bingham, sentenced to the penitentiary for Baker by Governor Penney, was paroled to-day by Governor Penney. The pardon was granted on the recommendation of the district attorney. Bingham was serving a term of one year. He came to the prison on June 27 last.

August Klingebil, a convict in the Oregon state prison, was examined as to his mental condition to-day and committed to the asylum. He came to the penitentiary on July 12, last, to serve a year term for arson by bailment. He is from Multnomah county, whence come nearly half of the prisoners. There are now 373 there.

## BRIGHTER PROSPECTS

Dillon Likely to Succeed Parnell As the Irish Leader.

## THE FACTIONS WILL UNITE.

He Will Be Accepted to the Parallels—Never Has Abused Parnell But Spoken Well.

**LONDON, Oct. 20.**—Mr. John Dillon's speech eulogizing Parnell has considerably softened the feelings of the Parallels toward him, especially as it was coupled with a repudiation of the attacks in the Dublin Catholic on Parnell's memory. There is now believed to be a possibility of reconciliation under Mr. Dillon. No one doubts the truth of Mr. Dillon's statement that he loved Parnell, and there is only one speech of Mr. Dillon on record in which he antagonized Parnell, and that was on the subject of the Paris fund, and a few days before Parnell's death. Before going to jail, Mr. Dillon had been careful to keep a moderate course. He hoped that discussion would come to an end before his release. Upon being liberated, he threw his lot in with the McCartlyites, but he never used personal abusive terms regarding Parnell, and the utmost charged against him by the Parallels is that, when an offensive term was used in his presence, he failed to rebuke it. There is no proof that he heard it, and if he did he probably thought it best to ignore it. Mr. Dillon is undoubtedly considered by the Parallels the strongest man in the two factions, and the most positive and commanding character.
