ATTEMPTED TO ESCAPE.

The Bird Man Louden Arrested for Complicity in the Ingram Murder.

Charles W. Louden, the bird man who was the chief witness in the recent Ingram murder trial, was arrested at Southern Pacific depot yesterday as he was in the act of making his escape.

He had his trunk with him, and was seemingly on the point of leaving for parts unknown. The prosecution thought he knew a good deal more about the murder than he was willing to relate at the trial and he has been shadowed by a detective for several days.

When he attempted to leave on the noon train yesterday he was promptly arrested and lodged in jail, as an accessory to the crime. The examination will be held at 10 o'clock this morning.

The case will come up in Justice Humphrey's court. Messrs J. K. Weatherford and W. R. Bilyeu will appear for the defendant and Deputy District Attorney J. B. Wyatt and Mr. H. H. Hewitt for the state.

It is said the prisoner broke down and cried like a child when he found himself in jail charged with the crime. His trunk has been taken charge of by the authorities and its contents will be examined.

The Toledo Coal Mine.

Coll Van Cleave, who has been in Portland for a day or two, told an Oregonian reporter that the Toledo Coal Company's tunnel is in 200 feet. It is slow work, as the tunnel is through rock, but one estimate is that it will need no timbering. The upper vein of coal which was drilled through seen to be six feet in thickness, was found to be between seven and eight feet thick when a shaft was sunk into it. The shaft is not all drilled out when the tunnel is completed. It is expected that the tunnel will tap the vein before the end of the month. The coal is of excellent quality, and has been pronounced the best on the coast. The supply in that section is said to be practically inexhaustible.

NO PLACE FOR LILLY YOUNG.

Reformatory Institutions Close Their Doors Because She is Too Old and Too Young.

As well as the state of Oregon is supplied with penal, reformatory and charitable institutions it is a singular fact that there is no place to put a young girl 14 or 15 years of age who has strayed from the paths of virtue and fallen into the ways of the wicked. Sheriff Harry Smith, of Astoria, was in Portland on Friday for the purpose of finding some place where he can put Lilian Young, the Albany girl who eloped with a negro named George Smith and was found living with him in Astoria, says the Oregonian. It is the desire of the girl's parents that she be taken away from her seducer and put in a place where she will have an opportunity to reconsider the rash step she has taken and think of a better life than that of living with a negro. She is only 15 years of age, and is not supposed to be old enough to know what is best for her own good. It was for the purpose of finding some institution that offers the opportunities of a reformatory that Sheriff Smith came to Portland. That he did not find such an institution is a sad commentary on the state's lack of facilities for caring for classes of unfortunate. Sheriff Smith found the doors of the Boys and Girls' Aid Society closed to the girl. He also found closed doors at the Woman's Home, the Refuge, the Babies' Home and the Magdalen Home. The state reform school would take the girl, but it is not yet ready to take children. For some of the institutions enumerated the unfortunate girl is too young; for others, too old. Sheriff Smith will have to keep her in Astoria or send her home to her parents.

Jeff Myers Bank from Ohio. He tells why he did not go further East, but Nothing More.

"No, I haven't time to talk for publication; I am not looking for reporters and I am not seeking notoriety," said Hon. Jeff Myers, the democratic war horse of Linn county, who's prominent spoken of as the democratic candidate for the first congressional district, as he boarded the train for home last evening. He has just returned from a trip East and had stuck in the heat of the political battle in Ohio, so the reporter thought the least he could do was to shed a few tears for the defeated candidate, Campbell. "I tell you I know nothing about the diplomatic senator," as he was further pressed for news. "I did not go East to see Cleveland's baby nor did I go to Ohio to stump the state for Governor Campbell. I had no ax to grind and did not go to boom Governor Penrose for vice-president. I knew all about the election in New York, and have nothing to say. Yes, the duck season is pretty well advanced in the East and baseball is booming. For the rest I will refer you to my friend, Col. Bob Miller. Good-bay."

NEWS OF THE COAST.

Interesting Items from Exchange Throughout the Northwest.

The fruit-growers of Ashtand have taken united action to stamp out the San Jose scale in that city and vicinity before it spreads so far as to be beyond control.

Applegate Brothers took 500 head of range-fed heaves through Linkville to the railroad last week that would have been mistaken for stall fed cattle by any one, in such good condition were they.

Sale crackers worked most of Thursday night trying to drill through T. M. Burrows' safe at Salem. The joke was not locked and contained only the books of business. A policeman frightened them away.

The Dalles Chronicle tells of a wagonload of produce recently brought to that city which consisted of six heads of cabbage, the 1st dozen filling the wagon-bed. These mammoth cabbages were raised on the dry hills near the Dalles, and were the wonder and admiration of all who saw them.

A few horses in Klamath county are afflicted with glanders, and the danger having come to the knowledge of the county inspector, E. S. Tull, of Visalia, he has notified owners to corral all horses diseased. The state veterinarian surgeon paid them a visit, and all incurable cases will be promptly dispatched.

At a meeting of the county alliance held in Linn county last Wednesday it was decided to organize an alliance mercantile company. The company is to be incorporated with a capital stock of \$15,000, for the purpose of conducting a general merchandising business in that county. At what point will be decided by the stockholders.

The city assessment for Corvallis shows a decided increase this year. The total valuation of real estate aggregated \$1,000,000 of personal property, \$28,231; total valuation of all property, \$947,334; indebtedness, \$23,579; exemptions, \$21,740, leaving the value of the total taxable property, \$722,315. The tax levy, which will be 7 mills, will run the total amount of taxes to \$261.46, and increase over last year 1875.40.

Surveyors "Bleeding" Squatters. Special Agent Lounsbury, of the general land office, has been instructed to investigate the charges that deputy surveyors are exacting blood money from squatters in order to enter a grant. He wishes it understood that deputy surveyors are paid for making surveys, and no compensation is required from squatters. Lounsbury has information that the practice of "bleeding" squatters is practiced extensively, but there is no evidence that the surveyor-general was cognizant of the frauds. The first action will be against Gilbert M. Ward, who had a contract to survey 10,000 acres of land. He failed to survey as contracted, and in one instance charged with demanding money of squatters. Clinton Paulson has also been charged by squatters of township 12, range 10 west, in Clatsop county, with demanding large sums of money for the survey. Half a dozen men made affidavits incriminating Paulson. Cavanaugh has been notified and arrests will follow.
