**THE DAY IN CONGRESS.**  
SPEAKER CRISP NAMES TWO OF THE COMMISSIONERS.  
President Harrison Will Not Make Any Appointment Until Late Next Week—Washington Gossip.  
WASHINGTON, Dec. 12.—The house met at noon today and after prayer by the chaplain, Speaker Crisp announced the appointment of committees on accounts and mileage, as follows:  
Accounts—Rusk, of Maryland; Dickerson, of Kentucky; Mason, of South Carolina; Sawyer, of Iowa; Pearson, of Ohio; Quincebaum, of New York; Griswold, of Pennsylvania; and Cutting, of California.  
Finance—Castle, of Minnesota; chairman; McKim, of Virginia; North Carolina; Kendall, of Kentucky; Caldwell, of Ohio; and Fisk, of Iowa.  
The house then, at 1:30 o'clock, on motion of Hoffman, adjourned until Wednesday next.  
It is not likely the president will make any new appointments before the end of next week. Many important new appointments are to be made, chief of which is the vacancy in the war department caused by the resignation of Secretary Proctor. S. B. Elkins, of West Virginia, is mentioned as most likely to receive the appointment, but Assistant Secretary Grant is thought will stand a very good chance of getting it.  
Secretary Foster is reported to have tendered resignation at a time since he was taken ill. He is still weak, however, and will hardly be able to make his contemplated Southern trip for several weeks yet.

A "Prize" Grand Jury Not Legal.  
SAN FRANCISCO, Dec. 12.—The state supreme court, by five justices against two, decided to-day that the present grand jury of the city and county of San Francisco is an illegal body. The question came before the supreme court on the application of ex-Assessor Elwood Bremer, for a writ of prohibition to restrain Superior Judge Wallace from proceeding against him under indictments filed by the grand jury, charging Bremer with malfeasance in office.

**Cold Weather in California.**  
SAN FRANCISCO, Dec. 12.—The weather bureau this morning states that unofficial reports from Nevada and the mountains in extreme eastern California indicate that the temperature last night fell as low as 26 deg. below zero at Hallock, Nev., 20 below at Carlin, 16 below at Elko, with 15 below at Boca Vista. The temperature at the same place today at Fresno and Yuma this morning.

**THE NICARAGUA CANAL.**  
Pacific Coast Will Carry Out the President's Recommendation.  
SAN FRANCISCO, Dec. 12.—A meeting of the Nicaragua canal committee was held this afternoon in the directors' room of the chamber of commerce. For some time the committee has had under consideration the formulation of an address to the people of the Pacific coast, and the committee regarding the following heading for a petition addressed to congress in aid of the construction of the canal, and in favor of national control of the enterprise:  
The undersigned citizens of the United States of America, residing on the Pacific coast, respectfully and urgently petition congress to provide or guarantee such necessary means as will assist, protect and hasten the completion and secure the national control of the Nicaragua maritime canal, as recommended by the president in his recent message to congress.  
The petition was adopted, and it was also agreed to distribute copies of this as widely as possible. It was decided to request the formation of auxiliary canal committees at Portland, Seattle, Spokane and Port Townsend, to read these petitions for circulation. Horace Davis was asked to prepare a brief address to the people of the state, asking them to endorse the petition.

**Called By a Falling Scaffold.**
