Political Issues—State and National.

In November next the great campaign will be made, the result of which must determine what party shall administer the Government for the next four years. This is a matter of so grave importance that every person in the Government ought to give it serious thought, enough at least to be able to use their influence and votes (those who have that right) in a proper manner and in the right direction, for nothing is more apparent than the fact that unless the people of this Government, like all other popular governments, shall take pride enough in their own institutions, when they themselves are the only sovereigns, to see to it, that their national affairs are administered fairly and honestly, and to see that their public servants (not rulers) obey the sovereigns, will the perpetuity of the great Government cannot long be expected or hoped for.

The Republicans declare that the allegiance of the people of this country is due first to the General Government: and it means simply this, that the supreme, sovereign, uncontrolled power of this Government rests entirely with the whole people in the aggregate, and that whenever they, or a majority of them, shall express their will, fairly and constitutionally at the ballot-box, that will shall be obeyed.

The Democrats declare that the Constitution must be strictly construed, that the supremacy of the State over the General Government must be preserved, that the States must have the right to regulate their own internal affairs, and no interference from the General Government.

The Work of the Hour. To-day the representatives of the Republicans of Polk county will meet to put forth a ticket to fight the battles of that party during the coming campaign. In the contest now pending, great interests are at stake. Interests of a local nature which come home to each and every voter in the land. The principles of the party are well reflected in the platform adopted in Portland. It is broad, comprehensive, definite. Let the present Convention see that they get out men every way worthy to reflect those sentiments, and well qualified to defend them. Let no one be influenced by personal preferences or blinded by prejudices. Too much is at stake to allow any quibbling for mere personal preferences. We hope to see the ticket made up of men—active, energetic men, who will carry force with them; men who are not afraid to show where they stand upon questions in which the people are deeply interested. There is now no time for dallying. If we would be successful we must work. If we would work successfully we must have good material to work with. That we have men who will work, and work earnestly, for the best interests of their constituents, all are willing to admit. Let the Convention, then, bring out such men, and then work for their election, and success is certain.

The Democracy declared in their Dalles Platform, that the thanks of the people are due to the present administration in Oregon for its great success in protecting the rights of the people. We submit this issue to the candid consideration of an honest and thinking people: Why should \$200,000 of the people's money be taken from the School Fund and given outright to a monopoly at Oregon City, when the work could have been prosecuted just as well, and the people benefited just as much without it? Why did a Democratic Legislature, in violation of the Constitution, raise the salary of the State Treasurer \$2,000 per year under pretence that he ought to have assistance in disbursing the people's money? Why did a Democratic Legislature try to rob the people of Oregon by the passage of their odious litigant law, compelling all parties to suits, and survivors of deceased persons to pay double the rates for which they could procure it done before, for all legal advertising? And last, but not least, why did that Legislature so frame the law in relation to swamp lands in the State, that unscrupulous persons could secure all that was valuable before the public could possibly know that such a law had passed at all, fixing it in such a way that a few parties could even take the land from, and drive off the actual settler who had located upon the same under the homestead and pre-emption laws of the General Government; and why was not some provision made in the law, whereby the actual settler could be protected, and whereby the lands could be put up at public sale and give every man a fair chance to obtain and pay for the lands what he thought they might be worth to him, and at the same time give the State an opportunity of receiving for those lands something near their value? Let Gov. Grover answer to day.

News Summary.

New York, April 29.—The Herald's Berlin special says Bancroft and Davis have expressed the opinion, in the presence of Bismark and Russell, that the claim for consequential damages would not be withdrawn from the American case. Bismark volunteered the opinion that the American position is correct.

Washington, April 29.—Senators Trumbull, Fenton and Tipton it is reported will go to Cincinnati to day.

Chicago, April 29.—Morning papers filled with dispatches from Cincinnati. Aspect of affairs constantly changing. Contest for nomination probably between Adams and Davis. There is a report that Trumbull has written a letter directing the withdrawal of his name. The following are some of the various combinations at present on the tapis: Adams and Curtin; Davis and Greeley; Adams and B. Gratz Brown. Other Candidates appear to be rather on the outside at present.

San Francisco, April 29.—Attorney General Williams and Secretary Delano will be serenaded at the Grande Hotel to-night by the Republicans.

The Committee of 100 has been in executive session all the afternoon, acting on the report of the Committee of Conference with the St. Louis delegation, on the 35 parallel railroad project.

Surveyor General Hardenburg, Secretary Delano, and others have been in conference to-day on the subject of the public land surveys in California. The Secretary says he will endeavor to have the surveys pushed forward with an increased force and as fast as possible.

Kalama, April 29.—Garfelde is unanimously nominated for delegate to Congress. H. G. Struve and L. B. Adams are elected delegates to the Philadelphia National Convention. Joseph M. Fletcher, of Vancouver, and C. S. Anders, of Walla Walla, are nominated for Prosecuting Attorneys.

Jacksonville, April 29.—At the Democratic primaries held here on Saturday the Bedrock wing were entirely successful.

Hon. J. G. Wilson and Hon. John Burnett, candidates for Congress, spoke here to day. They leave for the north by the stage to-night.

Weather warm and cloudy; grain prospect very good.

Chicago, April 30.—Dispatches from Cincinnati this morning, indicate a tremendous struggle between the adherents of Trumbull and Davis. From this State, it would appear that each party is so determined to carry its point that either will be willing to sacrifice the success of the movement rather than submit to a square defeat. Much ill feeling is displayed, and if the action of Illinoisans be any indication of the general state of affairs, it presages a notable failure of the whole movement.

Albany, April 30.—The Governor has vetoed the New York City charter. It is believed that the House will sustain the veto.

Salt Lake, April 30.—In the Third District Court this morning a certified copy of the decision of the Supreme Court of the United States was presented with the ruling that the manner of drawing petit jurors since September 20, 1879, was illegal. Four hundred prisoners are released by this ruling—24 for murder.

Cincinnati, April 29.—The City is fast filling up with delegates and visitors to the two Conventions which meet here on Wednesday. Full delegations from several States and a portion of those from others, have arrived.

To-day the subject of the platform, particularly the tariff plank, is engaging the attention of the caucus. Revenue reformers are prejudiced, but protectionists firmly insist that the tariff question must be left out or carefully handled, or it will lose a large vote.

It is said that the New York Free-traders are for Grant. It is thought, however, that the question will be satisfactorily settled by to-morrow and that the platform will not differ essentially from that presented by the Missouri Convention, under which this Convention was called.

At a meeting of the New York delegation, Whitelaw Reid, presented Horace Gaeley's views on the subject of the tariff plank, which are briefly to leave the subject till the election of Congressmen.

The struggle for the nomination still appears to be between Adams and Davis, and the present situation is not essentially different from that heretofore stated.

Washington, April 29.—A caucus of Republican Senators agreed to a plan for the disposal of business: First, to finish the deficiency bill; next, the House bill repealing duties on tea and coffee, naval and appropriation bill, amnesty bill, amended enforcement bill continuing in force until the end of the next regular session, Congress act empowering the President to suspend the habeas corpus, and other general appropriation bills.

A number of important bills were introduced, and referred.
