

MONOPOLISM AND CORRUPTION REBUTTED.

The election is over, and the result shows unmistakably, that the people are determined to put an end to corruption, and hereafter refuse to support political rings, bad men, and monopolies.

The present indications are that Col. Nesmith is elected by a large majority, and at the same time it is patent that a very light vote has been polled; all this is very significant, and shows but too plainly the determination of the people.

QUERY.—Who feels the cheapest? Senator Hipple Mitchell who is in Washington backed by his resolution endorsing bigamy, seduction and all crimes known to the law, except murder, or Hi. Smith who ran upon that resolution and was reprobated by the Republican party by 2,000 majority.

HUGE.—Dallas precinct polled thirty two votes for Hi Smith and seventy for Nesmith, total one hundred and two out of two hundred; and Bridgeport precinct polled five for Nesmith and seven for Smith against nearly one hundred at the last State election.

CONUNDRUM.—Since the last election it is pretty hard to tell whether the "ring" consisting of Holladay and his tools, has left the Republican party or, whether the boot ain't on the other foot,—the Republican party has left the "ring."

THE MAJORITIES.

The Oregonian furnishes the following table of reported and estimated majorities, so far as heard from. Nesmith majority in Benton is one hundred, in Columbia thirty, in Douglas one hundred and ninety four, in Jackson seventy eight, in Lane three hundred and nine, in Marion eighteen, Polk one hundred, Umatilla three hundred Wasco one hundred and twenty five, in Washington twenty six Yamhill sixty nine, total one thousand three hundred and eighty three.

TELEGRAPHIC.

The Pennsylvania Election. Philadelphia, October fourteen.—Returns from all the wards in the city but one, show for Judge of the Supreme Court, Gordon, Republican. 45,995; Ludlow, Democrat, 39,208. Republican majority is ten thousand six hundred and ninety seven.

Philadelphia, October fourteen.—In Burkes County the Democratic majority is about four thousand. Center county returns indicate a Democratic majority of five hundred for the county. Bedford county is very close with a small Democratic majority. Fulton gives about 275 Democratic majority. Cumberland county gives a Democratic majority of 600. Columbia county has a Democratic majority of 1,350. Monroe county, Stroudsburg included, gives a Democratic majority of 1,200.

Philadelphia, October fifteen.—The Press estimates Goaden's majority for Judge of the Supreme Court at over 18,000. Lutton Republican is elected in the third Senatorial District. Sixteen Republicans and two Democrats are elected to the legislature from this city. Elliot Republican for sheriff, has twenty seven thousand five hundred and forty majority over the Democratic and Reform Candidates combined.

The Iowa Election.

Chicago, October fourteen.—Returns from the Iowa election, up to midnight, are scattering and meagre, but they indicate a full vote and a considerable Republican gain over the vote of two years ago. The Republican State Ticket is undoubtedly elected, though by a reduced majority, but the antimonopolists have carried their Representative ticket in quite a number of counties where the Republican State ticket has a majority.

Chicago, October fifteen.—2 A. M.—Returns from Iowa are still incomplete but they indicate that the Republican State ticket is elected by about 20,000 majority. The Anti-Monopolists will probably succeed in the election of many members to the Legislature.

Later.—Additional advices from Iowa confirm the early advices of the probable re election of Carpenter Republican for Governor, and the success of the Anti-Monopoly county ticket the majority of the counties. The Legislature will probably be Republicans.

The Ohio Election.

Cleveland, October fifteen.—Later returns from the State indicate a close vote for Governor, with probabilities in favor of the Democrats. The majority will not run over one thousand either way. Democrats claim the State beyond a doubt. Cuyahoga county give Noyes about two thousand majority.

Election in the District of Columbia. Washington, October fourteen.—The election for the members of the District of Columbia House of Delegates, resulted in the election of two Democrats and twenty Republicans.

Yellow Fever.

Memphis, October 12.—The streets to-day are almost deserted. No crowds of citizens going to or from church, no pleasure parties—nothing but hearse and attendants hurrying to the cemetery and quickly returning to receive other victims of the terrible scourge. The ceremony of burial has long since been shorn of its solemn formality. To meet the demands for the removal of the dead, undertakers are required to move with celerity more becoming merchandise transports. Occasionally a vehicle containing the Visiting Committee of some relief association, passes at a rapid pace, but aside from these, the city presents a gloomy appearance. A perceptible change in the temperature about 3 o'clock this afternoon, gave promise of frost, in the event of which, a check to the spread of the disease may be expected, but a fearful increase of mortality will surely follow.

Shreveport, October 12.—Seven deaths occurred here from yellow fever to-day.

Cincinnati, October 12.—The Common Council has appropriated \$15,000 for the relief of Shreveport.

STATE ITEMS.

So much water has collected in the Albany and Santiam Ditch that it will add considerable to the cost of finishing it.

On Sunday two warehouses at Junction City fell down, scattering their contents, forty thousand bushels of wheat, in every direction. The Buildings were owned by Wm. Lemons and O. E. Bean & Co.

The Oregon and California Railroad Company has adopted the Oregon Home for the sick, at Salem, as the place of treating all cases of injury occurring to the employes of the road between Aurora and Roseburg.

The Register says, as last Monday was the first day of the Circuit Court a large number of people were gathered in Albany from other parts of the county and State, all of whom voted and although this was the case, the vote of this precinct showed a count of at least one fourth less than the usual vote cast in the precinct.

Four men were arrested at Portland for illegal voting.

The Masonic Hall at La Grand was dedicated Wednesday M. W. Grand Master Thos. McE. Patton officiated and S. F. Chadwick delivered the Oration

A young Oregonian named Ira Cutting got into jail at Walla Walla a few days since for passing what was supposed to be a counterfeit fifty dollar bill.

The ship Spirit of the Dawn will load at Portland with flour for Liverpool, instead of wheat. This shipment of flour to the United Kingdom is a new enterprise.

Roseburg collected fines, taxes and licenses during the last year to the amount of \$2,747 27, and disbursed \$2,707 14. She has \$40 in her Treasury, and owes \$100.

Colonel Kimball, Inspector of Indian Affairs for California and Oregon, visited the Umatilla reservation last week. While there he held a council with the leading Indians.

Two insane persons were examined yesterday before Judge Hamilton, and were ordered to be removed at once to Asylum. Their names were John Burk and James Peoples. Both these men were sent some time ago to the Poor House, but on manifesting symptoms of insanity were brought to the city. The cause of insanity is unknown.—Oregonian.

The Albany Register of the 15th inst. says \$15,000 is the amount N. Baum will receive and pay out on his wheat contract to-morrow—Thursday. Thus the American coin comes floating in, and will eventually be pretty well distributed throughout the entire community, making times much livelier than they have been for many years previously. Owners of wheat land in Linn county this county are in luck, to be sure.
