THE REPUBLICAN CONVENTION.

The republican convention reassembled at 10:30 A. M., and began the selection of delegates to the national convention. The following names were presented: Senator J. N. Dolph, John M. Swift, of Baker, A. G. Hovey, of Lane, John T. Apperson of Clackamas, W. J. McCoull of Yamhill, O. N. Denny of Multnomah, B. B. Tuttle of Multnomah, L. Blum of Umatilla, John Kelley of Lane, L. Coffin and F. M. Nickerson of Josephine. M. S. Woodcock of Benton, in a brief speech submitted the following resolution, of which he moved the adoption: Resolved, That James G. Blaine is the first choice of the republican party of Oregon at this convention for president of the United States, and the delegates of the national republican convention from this state are hereby instructed to use their best efforts to secure his nomination. The chair decided the resolution could not then be entertained if there was any objection, as it was outside of the immediate order of business to consider it. One or two opposed, but the convention generally applauded the resolution, and some asked to have it voted on at once, the chair announced that the convention would proceed to ballot for the six delegates, the resolutions to be considered later. The first ballot resulted: Applegate 4, Apperson 136, Blum 58, Burnett 2, Coffin 73, Denny 102, Dolph 135, Dwight 1, Dumaway 8, Frierson 35, Hovey 134, Hirsch 1, Kelly 80, McConnell 120, Mitchell 2, Montgomery 37, Nickerson 44, Steel 6, Swift 148, Tuttle 73. Dolph, Apperson, Hovey, McConnell and Swift were declared elected. On the second ballot Denny received 125, Kelly 40, Montgomery 11, Tuttle

3, Nickerson 12, and Coffin 11. Denny was declared elected. The Blaine resolution was here submitted and adopted. A communication was received from the Young Men's Republican Club, asking delegates to be present at the ratification in the evening. DISTRICT NOMINATIONS. Launch of the Ferry Boat.

The Kalama ferry boat was launched May 17th at 11 o'clock from Smith Bros. & Watson's ship-yard at the foot of Market street. Preparations were made quietly for the event and but very few knew of the intention to set her afloat to-day. A few indefinite rumors were floating around, however, and a boat 150 people gathered in the vicinity by the time she glided down the ways, most of the spectators being residents of the neighborhood. The TELEGRAM was apprised of the affair and a reporter visited the yard in time to see one of the prettiest launches ever made in the northwest. The vessel had been constructed with the expectation of high water floating her off without the necessity of a regular launching, but the river not having risen as rapidly as the work progressed it was thought best not to await high water, but to get her into her proper element as soon as possible. Ways were constructed and this morning workmen commenced the preliminary work of preparing for the launching. This done, at about 10:30 everything was ready and the men began knocking out the blocks that held her from the water. A move of several inches was soon made and then she stuck a short time. The sledges were again applied and at 11 she glided swiftly and gracefully into the Willamette, amid the hurrahs of the crowd. The steamers Larkline and Vancouver came up during the process and stopped just outside the boom of logs. The latter vessel was nearest the ferry boat and the huge wave sent ahead as she forced her bulk into the river, caused the steamer to rock frightfully, several times dipping so deeply that the water poured into her lower deck. The ferry will be towed down to Albina and receive her machinery from Smith Bros. & Watson's dock. It is expected that she will be ready for service in about two months and will then be taken to Kalama and put on the route across the Columbia. The work on her has been done in a masterly manner and reflects credit on the builders. Her construction has given employment to a large number of men for some time and a portion of the force will be retained to finish her up.—Telegram

AN ESSAY. Delivered Before the W. C. T. U. BY MRS. E. L. ALLEN.

MRS. PRESIDENT, SISTERS OF THE UNION, AND FRIENDS:—In addressing you upon the work that is before us needs no apology. It is presumed that every one is already aware of the extensive and energetic movements at present advancing in our country in behalf of temperance, that, and unparalleled interest in this work has been excited, and is still rapidly strengthening in thousands of districts; that talent, wisdom, experience, learning and influence are now enlisted in its service with a measure of zeal and harmony far surpassing what was ever witnessed before in such a cause, that great things have already been accomplished; that much greater are near at hand, and that the whole victory will be eventually won, if the temperate portion of society are not wanting in their solemn duty, must have been seen already by those living along the main channels of public thought, feeling elevated as we now are, upon a tide of general interest and zeal; a tide which may either go on increasing its flood till it has washed clean the very mountain tops, and drowned intemperance in its last den; or else subside and leave the land infected with a plague, the more malignant and incurable from the dead remains of a partial inundation. It has become a question which these who are now at the outset of their influence in society should especially consider: What can we do, and what ought we to do in this cause? It can not be denied, that our country is most horribly scourged by intemperance. Yes, we are groaning under a most desolating bondage, the land is trodden down under its polluting foot, or families are continually dishonored, ravaged, and bereaved; thousands annually slain, and hundreds of thousands carried away into bondage. What are the statistics of this traffic? Ask the record of mad-houses and they will answer, that one third of all their wretched inmates were sent there by intemperance. Ask the keepers of prisons, and they will testify that, with scarcely an exception their honorable population is from the schools of intemperance. Ask the history of paupers now burdening the land of charity, and you will find three-fourths of them have been the victims directly, or indirectly of intemperance. Inquire at the gates of death, and you will learn that no less than ten thousand souls are annually passed for the judgment bar of God, driven there by intemperance. How many slaves are there among us? We ask not of slaves to man, but to intemperance in comparison with whose bondage the yoke of the tyrant is freedom. And what does the nation pay for the honor and happiness of this whole system of ruin? Five times and perhaps more every year than for the annual support of the system of government. These are truths—so often published—so widely sanctified—so generally received—and so little doubted, that the particulars need not be given. The time has now come when a great effort must be made to exterminate this ungodly destroyer. It was high time this was done when the first drunkard entered eternally, to receive the reward of Him who has declared that no drunkard shall enter the kingdom of God. And without some effectual effort, it is not certain they will continue to increase, till intemperate men and their abettors will form public opinion, and consequently the public law of this land, then what will effort of man avail? The attempt to keep down intemperance by endeavoring to persuade people to indulge only moderately in strong drink has been the world's favorite for ages, while every age has wondered that the vice increased so rapidly, at last we are awake to a fair estimate of the plan, let the multitude continue to drink a little and still hundreds will drink to death. It is settled therefore that moderate drinking is not the plan on which temperance reform can be prosecuted. We are forced to the conclusion that abstinence or prohibition is the most successful plan on which reformation can be hoped for. But if the places of the present generation of drunkards are to be supplied, where will the victims come from but from our own children? Another company of immortal minds are coming on to fill these places as they have filled others. Who does not see that drunkards are all formed by moderate drinking? No one who ever set out to use strong drink thinks of eventually becoming a drunkard, and that if the young will abstain the drunkards now living will soon die, and the great evil be exterminated. Every one is aware that every male drunkard of proper age is a voter and has equal power in the elective franchise with the most elevated citizen. Nor can
