CORRESPONDENCE.

CLATSOP, OR., June 11th, '84.

EDITOR COLUMBIAN:—The even tenor of things here gives little show to a news-gatherer. About the only thing of importance occurring lately is the marriage of Mr. Dan Rice and Miss Lou Barr, daughter of Mr. and Mrs. A. M. Barr.

These young people were united for life some two months ago. The bride's parents gave them a wedding dinner, and the groom's mother and her husband, Mr. Omar Bryant gave them supper and a reception. That they may have their full share of health, wealth and happiness, and skip disappointments and troubles is the wish of their numerous friends here. Both are talented cultured people and fit adornments of any society. They are living on their own place a few miles above Grandma Barr's.

I see in last week's Standard a rather dirty assault on the Republican presidential candidate. The day has happily gone by when traducing a candidate will defeat him. The people read, they know pretty well every prominent man, and for papers or individuals to try to kill off by mud flinging will only react on those who so besmirch themselves. Those of us who knew Genl. John A. Logan before, and during the war, and who served under him, and all who have watched him fight for the people against monopoly and his struggles for the men who saved the country know that a worn, unshelved, brave and able man never was put up for position. A party without any policy and who only desire a change in the administration so that they can get hold of the spoils is not apt to get far. The way for them is too dark and rough and all the "ore" they can get will not save them, even, nor light their way.

Our lands will be held for the people, and not pass into possession of a few wealthy ones, mainly non-residents, who would engraft in our country the policy practiced in Ireland. Under them the men who saved the country will stand

There has been no measure looking to the building up of the power of the few, and enslavement of the people that he has not fought, and at times almost single handed. His kindness of heart and natural hospitality are proverbial. A poor man in overalls has always been treated with as much consideration by him as has the wealthiest. Genl. Logan in this is a fac-simile of Abraham Lincoln.

He knows that the enemies to our free institutions are not such of us who have had work to get bread for our families, not the poor cripples who upheld the colors during the war and did not return home till the flag waved unmoored all over the land, and one third of our comrades and brothers were left in the ground we had fought over.

He knows that the danger comes from those who have been made mad by wealth, who style themselves "the wealth and intellect of the country," and who "to keep down the poverty stricken rabble" demand strong measures. Blaine and Logan will curb such wretches.

Vandalism when he said "Damn the people" simply spoke for his class. Blaine and Logan will advise such measures as will show such men that the people can control them.

Blaine and Logan will protect American industries, and supported labor calculated to starve out American workmen will be prohibited.

This will not be a "bloody shirt" campaign. The best element of the Democratic party is against it, and on our side it will not be allowed. The time will come when every voter, every where in the U. S. can safely deposit his ballot or speak or publish his political opinions in safety.

The gallant men who fought under the Southern cross, fraternized with the boys who were in the front under the Stars and stripes.

Such men are friends, and to day only look for the good of the country, hoping for prosperous times for all.

Those who shirked their work in the front, and who carried wealth while others gave their blood, may cry out that "there has been too much of old soldiers," they must keep quiet and let us run things, but we don't propose to keep quiet or keep our mouths shut. Without us they would have no money, flag or country. We are over a million and a half strong, and we propose to have our say. With Blaine and Logan our rights will be recognized.

You are an old veteran, Major, and left your blood on more than one glory field. Your pen has been used for the benefit of all of us and for the Republic

SAN FRANCISCO, CAL., June 13, 1884.

The news of Blaine's nomination was received joyfully in San Francisco, and its confirmation by the Republicans here was signalled by the display of 100 guns' ringing of bells and the blowing of whistles. There is not one other man in the ranks of the great Republican party to-day whose candidacy would be so acceptable to our people, or under whose leadership the whole Pacific Coast would more readily march on to victory. Already many political clubs have been formed, amongst others an organization called the

PLEBEAN KNIGHTS, of which Mr. J. N. E. Wilson is President, and whose membership comprises the flower of the young Republicans. A neat uniform has been adopted, the distinguishing feature of which is a black helmet, with a long white plume, making a very showy appearance.

THE ORIGINAL CALENDAR. San Francisco, like all large cities, sees the dark, as well as the sunny side of the human picture. Scarcely a day passes without the development of some atrocious crime, and in very many cases the perpetrator goes unpunished. Felonious assaults, murders, and suicides, are crimes of almost daily occurrence, and so desperate has the criminal element become that the officers of the law are required to exercise the utmost precaution in hunting the villains down. Only last week three murders and four suicides were committed in our city, and in the case of the murder only one was traced to the perpetrator.

THE MURDER OF Ernestine Carboniello, a French Cyprian and resident of No. 3 Waverly place was committed last Friday night. It was a most mysterious affair, as the murderer left not the slightest clue behind that would lead to his identification. Ceine Kahn, a next door neighbor of this woman testified at the coroner's inquest that on the night of the murder she saw a large stout man, dressed in a dark suit, with whiskers cut short, enter the house of the deceased. He remained inside about ten minutes, and upon leaving walked toward Sacramento St. Just as he left the witness heard moaning in the house of Ernestine, ran out for an officer, and entering the woman's bedroom, found her standing by a table near the window. She was blood from head to foot, and her hair was matted presenting a most horrible sight. The murderer had used some blunt instrument.

A CURIOUS CASE OF CHINESE SLAVERY was brought to light the other day in two hawkes corpus cases, involving the control of the person of two young Chinese girls, who were taken from their owner's because of their youth and the immoral purposes for which they were being used. One case was that of Ah Moy, a girl of 14, who was taken from a brothel on Ross alley, whose possession an old hag named Ah Yong petitioned for. The girl is now in care of Rev. Otis Gibson away from baseful influences of Chinatown. The petitioner, with the usual sang froid of her kind swore that the girl was 19 years of age and was her sister, and that she could provide her with a good home. The girl denied the woman's claim to relationship, and stated that the woman bought her in Hong Kong for \$300, and that she had been used for vile purposes. She wanted to remain with Rev. Mr. Gibson, and the Court so ordered. The other case was that of a girl named Hong Ting, who was taken from another brothel and found to be suffering from a vile disease which had almost reached an incurable state. The Court also ordered this girl sent to the Mission.
