RAILROAD RACKET.

September 10th has been set for the change in schedule on the N. P. R. R. between Tacoma and Portland. The trains are expected to leave the former place at 5 A. M., arriving at Tacoma at 7 o'clock and at Portland at noon; returning to leave that place at 1 P. M., arriving at Tacoma at 3, and at Tacoma at 7 o'clock. The trains will run through to Portland. The immense transfer boat is ready for use, and a large force is now employed in putting the line along the Columbia river in good order and it will soon be one of the best ballasted roads in the country. The inclines on both sides of the river are the chief cause of the long delay, but all the men who can be used to advantage are engaged upon them, and they will, doubtless be ready for use at the time agreed upon.—*Olympic Transcript.*

The Northern Pacific company has received a proposition from an English firm to place a line of steamers on from Tacoma to the ports in China and Japan. They want a subsidy from the Northern Pacific of 2,000,000 acres of land. The Northern Pacific people say they will not subsidize any line, as they cannot afford it, but will have a line of their own in a short time. The Canadian Pacific will, it is said by one of its officers, establish such a line from a point nearer the straits of Fuca.—*Ex.*

The farmers on the heights and over on Tualatin Plains, in the vicinity of Bernal Heights station, on the Kalama branch, are taking steps to have a county road built across the heights so that they can reach the station without going a dozen miles out of the way. It will be a great convenience and make that station the most important along the whole line of the road. As soon as the railway is in operation so that its need becomes more apparent delay in its construction will be very brief.

The Kalama branch of the N. P. R. R. will be in readiness by the 10th, inst. for the system to go into operation without a jar or a hitch. Construction trains and large gangs of Chinamen have been constantly engaged in ballasting and filling wherever necessary, and numerous fills were made where trestle existed so as to make the line smooth and substantial. It is laid with the finest steel rails and is one of the prettiest pieces of track in the West.—*Chronicle.*

The Oregonian says: The contract for the construction of twenty-five miles of road on the west end of the Cascade division of the Northern Pacific railroad from South prairie to Green river, was awarded on Tuesday to Nelson Bennett, who is now engaged on the Yakima division. The cost of construction will approximate \$600,000.

Miss Helena Holman, who has been spending the summer with friends in St. Helen, left for Salem this morning (Sept. 2d.) where she takes her former position as teacher of music in the State blind school.

Judge B. F. Dennison and wife and Miss Ella Whipple, M. D., of Vancouver, came over from that city this morning (Sept. 2d.) en route for Seattle, the former and latter being delegates to the Republican Territorial Convention.—*Tel. gram.*

Developments, instead of palliating the crime of W. D. Pittenger, late treasurer of Washington county, disclose a deeper degree of guilt and more extensive financial disaster than accompanied the first announcement of his defalcation and flight. A number of friends are involved in the maelstrom, most of whom are ill able to sustain the loss. The country and state are ample protected by bondsman, as, by mere chance or inadvertence, they were not released when the new treasurer took charge of the books. The taxes embedded aggregate the sum of \$22,000, the sureties for the same being Dr. F. A. Bailey, Conrad Schuimerick and T. A. Tongue. Every effort is being made to discover the whereabouts of the fugitive, opinion being divided as to whether he has gone to British Columbia, is hiding in the mountains, or has committed suicide. The crime is by no means a new one in Oregon for officers having in trust county funds. An ex-treasurer of Yamhill county has been in exile for a long term of years for a like offense. Taking flight after he had vainly tried to cover up his crime by a clumsy story of an imaginary robbery, and an ex-sheriff of the same county served a term in the penitentiary after a brief exile in British Columbia for the same crime. The lesson is one that should not be lost on the public, and will, for a time at least, teach men that the point in business, wherein a friend is not required to furnish vouchers and receipts for money handled and paid out, is one that is not safe for friendship to pass.—*Tel. gram.*

The circular of the O. R. & N. Co., to its employees long foreshadowed by rumor, notifying them of a reduction in wages, to take effect on the first of September, was issued yesterday. The statement of the company is that the step is reluctantly taken and is induced by the present depressed state of the transportation business. A willingness to return to old wages upon the revival of business is foreshadowed. The wages of all officers and employees in the river and sound division are reduced in fair proportion. There is not the slightest evidence of a resistance to the reduction by a strike of the employees, although, of course, much dissatisfaction exists. There is a prospect that house rent and all other living expenses will be lowered accordingly, so that, for those whom the reduction did not catch in debt, with payments calculated up to the dollar on the "installment plan," the difference will not be as marked as it would have been a year ago, when rumors of reduction in salaries first began to be heard.

There is a somewhat concerted movement among the employees of the O. R. & N. Co. below the position of mate to resist the sweeping reduction made in wages by the management in Boston. The boats all went out on time this morning, but all are running short-handed. It is thought that the matter will be satisfactorily adjusted in a few days. River transportation, when coming in conflict with railroads, takes a necessarily subordinate position. There was never a more complete illustration of this fact than has been shown by the decadence of the river trade on the Columbia and Willamette within the past two years. Whether its present languishment will result in the complete fading out of the once enormous transportation business carried on by the fleet of the O. R. & N. Co., or whether it will be succeeded in due time by something like its old prosperity, is a question that a few years will decide.—*Tel. gram.*

A shot has at last told the burglars that have been for sometime infesting this city and East Portland, that there is danger in prowling about people's dwellings while good men sleep. Dr. Pilkington's shot gun had a host of citizens service in last night's discharge. Thousands of empty threats and dozens of arrests would not do as much service to the public in checking the burglar mania that has had such a wide sweep as this one load of buckshot, discharged at random and in the semi-darkness of a hall at midnight. The circumstances of this death, if the wound proves fatal, as new seems likely, are shocking, but the man who, with his "feet swathed in towels, so he may step without noise," goes prowling around the bedrooms of honest sleepers at unseemly hours risks such a fate, and does not deserve a better one.—*Tel. gram.*

War between France and China has begun. On the 23d inst., the French fleet under Courbet, during three years bombardment, destroyed the Foo Chow arsenal and sunk seven Chinese gunboats. The Chinese, notwithstanding they were well armed with improved weapons, made scarcely any resistance. The combat was practically finished in seven minutes. The French had seven killed and the Chinese 1000.—*Transcript.*

On Tuesday A. Cook & Son, of Vancouver, shipped nine tons of Bartlett pears to San Francisco, the product of three orchards adjoining Vancouver.—*Ex.*

SOCIAL NEWS.

HON. M. C. GEORGE will open the PRESIDENTIAL CAMPAIGN for OREGON at ST. HELEN Sept. 10th.

On Sunday we took our family in our hack with Charlie and Jake, and went up to the North Scappoose creek where Mrs. Moore and part of her family and Mr. N. L. Grey and family have been camped for some time. We passed into a new road to us near the Shattuck bridge. The first and only place we saw before we reached our destination was Mr. Ramsey's place. He has a beautifully planned house and everything betokens thrift and energy. He will in time have an excellent and valuable farm hewed out of the wilderness. Dr. Moore was just ahead of us on his road cart with Gingerbread. At last we came to the steep hill that slopes into the valley, and a steep one it was. We however got down it in safety, and were glad when we had successfully made the perilous descent. Mrs. Moore had her headquarters at a log-cabin constructed by James Shintaffer when logging there last winter. A piazza for a dining hall had been improvised in front of the cabin. Near by was the sparkling fresh water of the stream in which Mrs. Moore said they had caught a thousand trout, no small item in furnishing their larder, with delicious food. A neighboring barn with its well cured mows of hay made them splendid bed-chambers, and no fleas or mosquitoes disturbed their existence. A table covered with all the luxuries of the season awaited our participation, biscuits that could not be excelled by a city bakery tempted the palate, some green corn from Garnett's adjacent cornfield was particularly luscious. As it was quite late when we arrived, our stay was short, and the Dr. said he must also go, as he had an engagement in St. Helen. He started and Miss Nelly Moore was to accompany him in the road cart from the top of the steep hill. He had put in his own horse. In turning around the field he upset, and was thrown out, and the horse started to return to the barn. He hollered for us all to keep out of the way. There was a scattering among the youngsters and women. We had just got our team out in the road and saw no salvation for it except we stopped the infuriated horse coming toward us at full tilt. We left our team, and secured him into a fence corner where he fell down. Our team meanwhile ran away over the logs but Garnett fortunately was on hand, and caught our team, and nothing was broken. The Doctor, Garnett and myself then unharnessed the fallen horse as speedily as possible. He did not appear injured. The harness was not damaged a great deal, and the road cart was not as badly broken as it might have been, though the spokes were dislocated and a number of fakes broken out of one wheel. We all started on then and arrived home in safety.

Dr. Stewart has bought a fine Percheron stallion with the Pathfinder blood in his veins, of A. Sunderland of Sanvie's Island who lives on what was formerly the McGowan place. It is a splendid specimen of horsehood, this same stallion of iron gray color, and bears the name of Prince. The Doctor has 150 brood mares, and starts in well fixed in the business to make a success of horse raising. Prince is of the Myers stock of Rogue River, Southern Oregon. Myers brought on from the States a magnificent stallion in 1863 on the same boats on which we came from the Atlantic States, and has done more to improve the breed of horses than any man in Oregon. Mr. Sunderland has very extra blooded horses, and any one wishing to improve their stock would do well to purchase of him.

Mr. John Edmunds states he was not present at Mrs. Dunnaway's lecture at the Upper Scappoose. He only went with Steven Haines as far as the first quarry out from St. Helen, and then returned. He could get no signers for a license at Upper Scappoose for it is in another precinct from where his saloon is.
