The German Reichstag is now engaged in a bitter struggle over the proposed revision of the tariff. 'The German government seems to be pledged to the agrarian party in favor of this measure which places excessive duties on cereals, and provides a bounty to the German farmer who raises certain quantities of grain.


The Imperial Chancellor declared that the Emperor was highly satisfied with the bill; that it had been carefully prepared and was properly adjusted to their economic life and would secure foreign treaties on acceptable conditions. 
