Mrs. W. L. Price, of Kings Valley, is visiting with her daughters, Mrs. L. W. Orin and Miss Elsie Price, of this city. Miss Price has been seriously ill for a week or ten days, but is recovering.

Messrs. Adolph and Hugh Ekstein, of Southern California, were here several days last week in charge of Morgan and Eglin. They own some choice improved 40-acre fruit ranches near Los Angeles to trade for ranches in this section. Any one desiring to make such deal will do well to call on Morgan and Eglin.

While hunting near Albany, Saturday, Fred Forgey, the 17-year-old son of George Forgey, of that city, accidentally shot and killed himself. He was crossing a small stream on a log when the gun struck the log, and the entire contents went into his face, lodging in the brain under the skull, causing instant death. Beyond doubt if one goes into the business in the proper manner there is money in poultry. James Horning who has some very fine white and barred Plymouth Rocks, received an order a few days ago from a party at Nampa, Idaho, for 300 Plymouth Rock eggs, half white and half barred. Mr. Horning was able to fill the order for Barred Plymouth Rock eggs and wrote the party his terms. Mr. Horning is not at all particular about foreign orders as he states that there is a strong home demand for all the eggs that he can spare.

A meeting of Corvallis Grange was held at the college Saturday afternoon, at which time T. J. Risley and J. F. Yates were elected as delegates to the State Grange, which convenes at Salem, May 24. As is the custom, the wives of the delegates will also represent the grange in the capacity of delegates. Cora E. Leeper, M. V. Leeper, J. B. Horner and Mrs. Horner were elected alternates. H. T. French was appointed to represent the grange on the committee consisting of a member each of the council, county court, Citizens' League and faculty of the college, to prepare an exhibit from this county to be shown at the Lewis and Clark Exposition.

Among the many honors of a horticultural character which have been coming to Oregon is a gold medal awarded Prof. E. R. Lake at the Paris Exposition as a collaborator in the horticultural display made there by the U. S. Department of Agriculture. The special honor to Oregon in this award is found in the fact that Prof. Lake was the only one of the collaborators in that department from the United States who was granted this medal. The work was done by him while conducting his investigations for the Department of Agriculture. Prof. Lake made it a point to be at every competition of horticultural exhibits, although in one case this made it necessary for him to make a trip of hundreds of miles at his own expense.—Oregon Agriculturist.

Mr. A. F. Peterson's reputation as an architect and builder extends beyond the confines of Benton county. In such esteem is his ability held abroad, that he has spent more time away from Corvallis during the past few years than he has at home. Besides the fine court house at Fossil, Gilliam county, he has constructed numerous fine residences and other buildings. We are pleased to learn of this resolution as there is no doubt that there will be such demand for his services in and about Corvallis as will keep him fully employed.

"BISMARCK'S" VOYAGE.

The "Red Rover" of the Willamette up Against it—Nerve Suffers.

The recent smallpox scare moved the authorities to secure a pest house. A small house on the Willamette river a couple of miles below Corvallis, belonging to B. F. Hyland, was given over for this purpose, and Deputy Sheriff Henderson placed things in readiness for the prospective inmate, James Whitford.

Mr. Whitford has been up on Smith's island, about four miles south of this city, and for a time he wrestled with smallpox unassisted. The attention of the authorities was called to his case and Hermann Breyer was induced to undertake the task of conveying the patient from his lonely cabin on Smith's island to the pest house and care for him.

Hermann is nervy. He has never had the smallpox, nor much else, for that matter, and had no fear of taking anything that did not belong to him. Hermann listened to the counsel of his cronies, who persuaded him that if he got the Manila Itch and died they would see that it wouldn't cost him a cent. He had all to gain and nothing to lose.

In due season Hermann reached Mr. Whitford's cabin and got everything down to the river bank preparatory to embarking for a voyage down the river to the pest house. Then he started for the river in company with the patient. Mr. Whitford claimed that he was unable to walk as far up the river as the boat was, and asked Hermann if he could not pull the boat down the river to meet him. Hermann declared that he could and went on up to the craft.

Hermann is no sailor. He reached the boat and cast off. Then trouble began. He lost command of the boat on the angry waters of the majestic Willamette; he forgot the German language, the Lord's Prayer, the Ten Commandments, and his democracy, and after a desperate struggle landed on Gerhard's island—to Hermann an unexplored land. Such a predicament! Hermann had possession of an island and Mr. Whitford had the smallpox. They were separated by waters that would not open a passage for them as the red sea did for the Israelites. "Count von Bismarck" was seasick and would not again attempt to reach his patient.

Word finally reached town of the state of affairs and Hermann's friends were afraid he might go wild on the island before assistance could reach him. But this fear was a groundless one. On the other hand there were many expressions of sympathy for Mr. Whitford, and it was feared that exposure might prove a serious matter to the sick man. However, he got back to the cabin and managed to get along alright.

Hermann finally turned up at Henry Gerhard's, and, from a safe distance, called to know if he could pass the night in an unused hog-pen. Henry told him where there was a small cabin that he could occupy.

"Bis" got some straw for a bed and slept over night in the hut. Food was placed where he could secure it and his condition was not serious by any means. The events above chronicled transpired Friday and Friday night. Everything was finally straightened out and Saturday afternoon the veteran sea-dog, "Bismarck," navigated his bark proudly past this city on his voyage to the pest house. All on board were as well as could be expected.

A "comedy of errors" appears to have followed in the wake of everything that was attempted in behalf of Mr. Whitford. To start with, Deputy Sheriff Henderson started out with a rig to hunt a nurse. When a number of miles south of this city, his team ran away and generally raised the mischief. "Samp" finally tied his unmanageable team up and had himself brought to town by a countryman.

Friday morning Mr. Henderson went down to the pest house to await the arrival of the smallpox patient. He awaited until late in the evening, when he walked into town. He had gone without dinner or supper.

Again, Mr. J. O. Wilson, when he learned of the terrible state of affairs that existed on the island occupied by Mr. Whitford and Mr. Breyer, made a slight mistake in sending Jack Wright down with the news. The latter got to town all right, but fell by the wayside long enough to incapacitate him for conveying reliable information regarding the trouble.

After Jack's arrival Jim Cane was dispatched to the rescue. He so liberally fortified himself with disinfectants that he was not able to do himself that honor that was expected of him. So it went.

Well, if we had more space there are several missing links to this narrative that could be given which would no doubt prove interesting. Ah "Bismarck! Auf wiedersehen."

Primaries Occur March 20th.

In pursuance with the call of the Chairman of the County Central Committee, of Benton County, the said committee met in the County Judge's room, the meeting was called to order by Chairman O. V. Hurt. G. W. Denman was appointed Secretary. On motion, J. O. Wilson, S. L. Kline and E. Woodward were authorized to act as proxies for Kings Valley, Fairmount, and Wells. The following committeemen were noted present: G. H. Wamsley, Blodgett; Homer Lilly, Wren; W. H. Whitby, Willamette; D. B. Farley, Monroe; O. Witham, Corvallis No. 1; G. W. Denman, Corvallis No. 2; A. Rennie, Corvallis No. 3.

It was moved and carried that Thursday, March 20 be set as the day for holding the County primaries for the purpose of electing delegates to the County Convention; that Friday March 28 be set as the day for holding the County Convention for the purpose of electing delegates to the State and Congressional Conventions; that the day for holding the County Convention for the purpose of nominating a county ticket be left subject to the call of the present Chairman of the County Central Committee.

It was moved and carried that the apportionment of delegates to the County Convention be one delegate to every 15 votes cast for Thomas H. Tongue for Congress in 1900 and one delegate at large and one for every vote over ten. According to this ratio the following precincts are entitled to the following delegates: Corvallis No. 1, 5; Corvallis No. 2, 8; Corvallis No. 3, 7; Corvallis No. 4, 5; Philomath 9; Wren 3; Blodgett 3; Summit 2; Kings Valley 4; Aleas 3; Dusty 7; Monroe 4; Willamette 4; Soap Creek 3; Fairmount 3. Total number of delegates to County Convention 71. No further business appearing, Committee adjourned.

For Smallpox.

When Jenner discovered cow pox in England the world of science hurled an avalanche of fame upon his head; but when the most scientific school of medicine in the world—that of Paris—gave this receipt and panacea for small pox to the world it passed unheeded. It is as unfailing as fate, and conquers in every instance. It is harmless when taken by a well person. When learned physicians said the patients must die, it cured. Here is the receipt: Sulphate of zinc 1 grain; fox glove (digitalis) 1 grain; 1-2 tea spoonful of sugar, mix with two tea spoonfuls of water. When thoroughly mixed add 4 ounces of water. Take a tea spoonful every hour. The disease will disappear in from 12 to 24 hours. For a child the dose should be smaller according to the age.
