LEMON DEFEATS ORANGE.

A Sport at The Finish Captures a Most Sensational Meet for The 'Varsity.

The Orange suffered its first defeat of the season, Saturday, when the track and field team from U of O scored 71 points to the farmers' 55. The weather was ideal and a large crowd, including visitors from Eugene, Albany, McMinnville and other towns, enjoyed the best meet ever held on Agricultural field.

It was generally conceded that the odds favored the visitors for the winner, especially with Cathey, hurdler and broad jumper; Swan, vaulter, and Horton, mile runner; the collegians' best men in these events, out of the contest. The 18 points in the mile and half mile were virtually given to the 'varsity, but all other events were hotly contested. Williams, of O A C, surprised the visitors and more than met the expectations of those familiar with his powers as a sprinter. He was the star of the day, taking first place in the 50, 100, 220 and 440-yard sprints in fast time, and defeating Captain Payne, of the 'Varsity easily in the two latter events. His performances were remarkable, considering the fact that the 220 and 440 yard dashes were finished in the face of a strong wind, on a circular track, in time nearly equal to the Northwest records. Jackson, also, did excellent work, while Moores was suffering from a bad knee and did not make his usual splendid showing.

For the visitors Thayer, McKinney and Poley had their events best in hand. McKinney handles the weights in fine form, and Poley performs beautifully in the distances. The farmers held the lead until the last two events, the mile and broad jump, gave the 'Varsity 17 points.

Cadets Fraternized.

Among the features of yesterday's celebration was the visit of the cadets of the State Agricultural College, of Corvallis, says the Oregonian. When, upon the arrival of the Albany local, the very soldierly-looking cadets filed out of the coaches, the depot presented a truly military scene. The Corvallis cadets were met at the depot by Major G. C. von Eggeffstein, commandant, and Cadet-Major H. H. Olmstead, Captain and Adjutant M. A. Van Houten and Captain and Quartermaster Leo Hahn, of the Hill Military Academy. Under the escort of these officers they started on their march for the academy, where they were to be entertained till it became time to join the parade.

The academy armory had been turned into a banquet hall, and

four tables the full length of the armory were laid with a substantial lunch. All partook of this with a good appetite, and evident relish, sharpened by a long ride on the cars and an early breakfast. A formal speech of welcome in a few well-chosen words was made by Cadet Hahn on behalf of the Hill Military Academy. This was responded to by Cadet-Major Mayfield, of Corvallis, and by Cadet Oliver Berchtold. Cheer after cheer, which was inspiring to hear, came first from one organization and then from the other. A pleasant hour was spent in social intercourse, and the friendship of the two organizations was more firmly than ever cemented by a short but pleasant visit. The Corvallis cadets' band then entertained their hosts with a short concert, rendering with good time and with good expression several pieces of music. Promptly at 1 o'clock the Corvallis cadets left the Hill Military Academy under the immediate escort of the cadets of the latter institution, and took up their station at Sixth and Irving streets, and at the proper time swung into line, making a very favorable impression.

Memorial Sunday.

Memorial services were held, Sunday, in the M. E. Church, South, in this city. This is probably the first instance in which a minister of that denomination has been invited to officiate in that capacity in Oregon, and it is a further evidence that the wounds sustained in the Civil war truly have been healed. The sermon was preached by the Rev. John Reames, the pastor. It was a good, plain, practical sermon; fit for any day in the week, under all circumstances, at all times, as lessons were drawn from the past and present as guides for the future. The scripture lessons were read by Rev. Moses and Rev. T. T. Vincent led in prayer. The music was especially good and patriotic. The church was handsomely decorated with flags and bunting on the walls, while the pulpit was a bower of flowers and potted plants. On returning to their hall, the Post passed resolutions extending thanks to the pastor for his able sermon; to the church membership for the use of the church, and to the ladies for the beautiful decorations.

A CHARACTERISTIC REPLY.

Judge McFadden "Throws the Harpoon" Into the Church, the Saloon and Numerous Unoffending Citizens.

CORVALLIS, OR., May 22nd, 1903. EDITOR GAZETTE.—In your issue of this date under head "Their Willy Ways" appears an article signed "X." I would not feel justified in noticing this covert matter were it not for the fact that your manner of setting it out, makes the same quasi editorial. X, a fictitious creature, undertakes to manufacture thunder for future, with no regard for the truth. Misrepresentation and innuendo deceive none, except those who mask in deception. Why you should give me so much space seems strange. Your readers are not all fools, nor can they be misled by the wholesale abuse of two citizens of the city. My enemies give me credit for identity. Life is too short to either cringe or dodge when insects blurt and buzz away their brief existence. I have been identified with Corvallis for 30 years, and am fairly well known notwithstanding the flings of X. Mr. Waters has been in our county for 19 years, and we hope able to weather through all the vituperation heaped upon him, notwithstanding the little X's. To strip X's article to bed rock, it is but an effort to burn incense to the shrine of Gaius, the statement that I worked last week to slate men for councilmen is without color. I was called by phone last Sunday P. M. to the office of E. R. Bryson, and went there for what purpose I did not know. E. R. Bryson, Geo. Paul, B. W. Johnson and two others were present considering the destinies of the city—the weight of empire was on them. The printed ticket as it appeared Monday was there on the table. Four names in the first and second wards, for councilmen, were printed whose names I had not before heard mentioned. I had no interest except in the third ward. It is claimed by X in effect that I am a cute old man and that I got up a fusion with the democrats and populists, this is wholly false. I was not on any committee, was not a delegate, nor had I a seat in the convention—was never so mortified nor disgusted in my life as when I saw "Pop Robinson" in the chair in the capacity of Democratic High Priest.

X also gives me too much credit in making choice for all parties in their conventions. It's true in conjunction with some other democrats who wished to conserve the best interests of the county, we urged the nomination of John D. Daly as senator. We were interested in our county, and realized that the republicans would in all probability elect and hence, desired a man of standing and experience in the senate to represent our college and county. A coterie of small fry politicians who had put up their fences

"for harmony" to down Daly had to be dealt with. If our efforts with certain republican delegates to defeat it, conducted to that end, we are pleased, even if X's shoulders have been ganged ever since.

X seems to think Woodson is running for something in the county. He is not, not here in the flesh, nor before the people. It's true many people claimed Woodson had no interest in the county, had no fixed residence here, etc., all of which seems to have been justified. This same coterie of which X is one and who recognize no potential god except John Barleycorn selected Mr. Woodson because of his church connection, reasoning "We can catch those Bible backs with that kind of bait." While Mr. Woodson was doubtless a Christian gentleman of a mild type, the game as arranged by the votaries of the saloons wouldn't work out, and they have abused church ever since for its lack of "Christ-like adherence" in that scheme.

The city papers stated after the election of Monday that there was no politics in it, which was true. A democrat is elected mayor without opposition, both councilmen in the 1st ward are democrats, in the 2nd ward a democrat and a republican, a chief of police a republican, the police judge and treasurer democrats. I have never understood whether Mr. Colbert had any political status, further than he didn't have any prohibition tendencies, although a Methodist brother. Since reading X's article, I had the political complexion of the third ward carefully investigated with respect to their votes for councilmen, with the sure result that 26 democrats in that ward voted for Mr. Colbert; of this there is no doubt. Messrs. Whitehorn, Wiley, Assell, etc., with Westefeld as banner carrier and John Scott on the bass drum and the other brothers all in the line up with a strong church contingency believing that the good Brother Colbert could more safely be depended upon as a progressive Methodist than Mr. Waters as in duty bound voted for Mr. Colbert.

In 1893 I was honored by being elected mayor of the city. The saloons at that time were much inclined to paint the town red—those were wide open times—Sunday or no Sunday they ran just the same. A halt had in decency to be called. In my annual message to the common council as mayor of the city now on file in the office of the police judge, in speaking of the saloons I stated as follows: "This is an educational center. You owe it to yourselves to conduce all on your part to cleanse the city from all debasing influences, and it becomes imperative that the wise laws you have enacted be vigorously enforced—no other consistent course is left open except to enforce the laws of the city as you find them. The charter has given you full power in the premises * * * all persons taking out a license have taken the same, subject to the conditions fixed by law, and have given bond conditioned to comply with the law, which you as a council approved. It is an admitted and notorious fact that the law and the conditions of the bond by you approved are being openly and flagrantly violated every week; and the duty devolves upon you to enforce or have enforced the laws of your own making * * *. The public is becoming fully aroused in the matter of self-protection, and the strict enforcement of the laws in the particulars specified for the general good of the city. The city is therefore either to vindicate the law from within or it will certainly be done from without. Temporizing in matters of this kind cannot longer in decency be postponed—action is demanded. By all those fairly advised it is a known fact that the violation of the conditions of the liquor traffic are easily enforced by law and that speedily."

Mr. Waters was practically a stranger here when I submitted the foregoing, and it was not "expended in winning and controlling the support of the saloons and their adherents" as expressed by X. My ideas are the same today they were ten years ago. The saloon men understand me thoroughly. No change has come over "the spirit of my dreams."

The temperance element at the time was either dead or sleeping. If a temperance sentiment prevailed in Corvallis it was hid under a small measure ten years ago. X's horizon commences with the last June election, and is circumscribed by misrepresentation in every phase. In this connection it is to be remembered that the sheriff of the county closed the Sunday doors of the saloons in the first instance; not the city officials. For the past few years, the saloons have kept fairly orderly houses and in a general sense have complied with the conditions of their bonds and the laws of the city. The conditions surrounding them have forced this, it was not voluntarily done; this has been effected by public sentiment, and the certain fact that the laws will be vigorously enforced if violated. We trust that X will cork up his insane crossness and line up for decency and respectability, and speedily forget this day of small things.
