The Wood We Use.

Every person in the United States is using over six times as much wood as he would use if he were in Europe. The country as a whole consumes every year between three and four times as much wood as all of the forests of the United States grow in the meantime. The average acre of forest lays up a store of only ten cubic feet annually, whereas it ought to be laying up at least thirty cubic feet in order to furnish the products taken out of it. Since 1880 more than 700,000,000,000 feet of timber have been cut for lumber alone, including 80,000,000,000 feet of coniferous timber in excess of the total coniferous stumpage estimate of the census in 1880. —Caspar Whitney in Outing Magazine.

HINDU STUDENT'S LETTER.

Writes of His Native Country—India to Revolt.

Accompanied by his picture, a letter from one of the OAC Hindu students, appeared in Friday's Oregon Journal. That paper says:

In a letter to The Journal H. S. Chima of India, a senior at the Oregon Agricultural college, predicts that the day is not far distant when India will rise in revolt against British rule. He says:

Big nations have nearly come to an agreement that wars should be stopped and that international quarrels should be decided by arbitration, but this does not hold good in the case of India, which has not yet gained even her freedom and consequently cannot be judged in the same manner. We are in every way behind other countries and need war and unless we have war there is no hope for us.

"The English have been ruling us through our hearts ignorant of ourselves, but these hearts have entirely changed. Day by day we are understanding our position and our relation to government more fully.

"The present situation prevailing in India reflect that Seeley's theory that the natives of India have so long been under the foreign yoke that they have lost even the sense of nationality is proving untrue and Lord Curzon's Asiatic policy, 'the east can never be ruled except through the heart,' is proving true because these hearts have changed a little. In addition to these a few bad acts of Lord Curzon have gone a long way in the realization of our state. In this respect he has done us a great service and his name will ever be remembered in association with the awakening of the national spirit in India.

"Everywhere protest meetings are being held in which the evils of the government are brought home to the minds of the masses, and there is a general cry to remove these evils. In fact the people, setting aside all their sectarian dispute, have been aroused to the sense of national freedom.

"This is a favorable sign for the better prospects of India, and if this kind of agitation goes for some time a day will certainly come when sheer loyalty will be considered disgrace and fighting for right self-respect."

CORVALLIS CELEBRATED.

Had Immense Crowd, Good Order and Good Time.

With a bang, roar, and fizz the Fourth was ushered in, and with a fizz, roar, and bang it was ushered out, in Corvallis. The races Tuesday and Wednesday began to draw people in throngs which increased from day to day until the Fourth, when the monster crowd in the history of the town was in attendance at the celebration. The parade was scheduled for 9 o'clock but it did not appear until 10, by which time Main street was literally packed with humanity as far as the eye could see up and down. The parade included the Goddess of Liberty, Miss Nelle Marvin, in a chariot decorated with bunting and drawn by three white horses, the Liberty Car, floats of the W. R. C. and the Washington's and other vehicles, all attractively decorated.

What was generally conceded to be the prettiest feature of the parade was the Coffee Club float, which was the cab beautifully decorated with flowers and greenery, in which Miss Carrie Danneman served coffee to three small boys who rode therein. The entire float was prettily "done" and received many compliments.

After the parade the crowd quickly gathered at the court house square where the program was carried out according to schedule. Congressman W. C. Hawley, Mayor George Lilly, Reader G. A. Peterson, Dr. Kerr, the Goddess of Liberty, the Goddesses of Peace, Miss Mary Danneman and Plenty, Miss Edna Osborn, the ladies of the W. R. C., 50 little girls who sang and others occupied positions on the platform.

Congressman Hawley delivered a splendid oration that has been the subject of very favorable discussion. It was a forceful and polished address, delivered with excellent effect, and was warmly received.

Taken as a whole the day was entirely satisfactory and everyone seemed happy and well pleased.

The afternoon events were all pulled off according to program and were very interesting and amusing. They included a potato race, sack race, hose race, old man's foot race, bicycle race, catching the greased pig, and other events.

The day closed with a grand ball at Taylor's hall and skating at the rink, and in the "wee sma' hours of Friday morning peace and quiet once more fell over the town, and the celebration of 1907 was but a memory.

Convicts' Entertainment.

Nearly 800 people attended the minstrel performance given by the convicts at the penitentiary last night, says Thursday's Telegram, and the participants were roundly applauded and repeatedly encouraged for the success of their efforts. The band and amusements fund was enriched to the extent of over \$100.

These events have developed into social functions of no little significance, hence nearly half of the admissions were complimentary. The minstrelsy and vocal features approached the standard of the modern minstrel performance and the orchestra and band, the latter composed of 27 pieces, under the leadership of O. W. Walton, erstwhile a young musician of Portland, who turned bandit and is serving a 25-year sentence for the murder of a policeman and holding up a streetcar, is exceptionally well trained.

NEW RULES IN FORCE.

Shippers are Requested to Take Notice.

The newspapers are being generally requested to publish the new rules in regard to freight shipments, just issued by the Oregon Railroad commission, and for the benefit of local shippers the Gazette gives space to the same.

Shippers are advised to make their applications for cars in writing, and to specify in their orders the items mentioned in paragraphs 2 to 6 inclusive in the regulations. This will enable a complete record to be kept which will show at all times the actual condition as to cars ordered and supplied, applications unfilled, and will disclose the presence or absence of discrimination in filling shippers' requisitions. The records are to be public. Any shipper will be entitled to inspect the record at his station or the dispatcher's office at any time during business hours. If the record is not kept at any station, or access is denied to bona fide shippers, this Commission will undertake to see the practice is corrected if the facts are reported to it at Salem.

RULES.

1. At each station on every railroad in this state where an agent is maintained, and where freight is received and delivered, there shall be kept and preserved a register or record of all applications for cars by shippers, and said register or record shall give substantially the following information, to-wit:

1. Name and address of the applicant for cars.
2. Number of cars applied for.
3. When cars will be required.
4. Kind and size.
5. Kind of freight to be shipped.
6. Destination of freight.
7. Date cars are furnished and set for loading.
8. Number furnished.
9. Initials and number of cars furnished.

All applications for cars made at any such station shall be immediately and correctly recorded in such register or record in chronological order of application. Such record shall be kept in a suitably bound book, and be subject to the inspection of any bona fide shipper during business hours.

2. A record of car distribution shall be kept at the office of each chief dispatcher of all the railroads doing business in this state, subject to the inspection of any bona fide shipper during business hours. This record shall be made up from daily reports of all station agents on such division, and shall contain the information set forth in the preceding rules. It shall be so kept as to show the shipments of principal commodities. The names of all persons ordering cars on such divisions shall appear in alphabetical order and must show cars loaded for foreign roads, whether on company cars or foreign cars.
