Death of Archbishop Blanchet.

At six o'clock on last Monday evening the Most Reverend Francis Norbert Blanchet D. D. Archbishop of Oregon, died in St. Vincent's hospital, aged 88 years.

His death was not unexpected, as he had received the last sacrament at the hands of his coadjutor Archbishop Seghers about two months ago.

Deceased was born at St. Pierre, Riviere-du-Sud, Quebec, Canada, September 5, 1795; was educated in the Petit Seminaire, Quebec, and was ordained July 18, 1819, by Archbishop Plessis. In April, 1838, he was sent in company with the Rev. Modesto Demers by the Archbishop of Quebec to the Pacific coast to organize a mission situated between the Pacific coast and the Rocky mountains, and arrived at their mission headquarters, Port Vancouver, Nov. 24, 1838, after enduring all the hardships incident to travel across the wild and rugged plains and mountains, traveling by horse, canoe, and sometimes on foot, with the hardy trappers who, along with the Indians, occupied the country that now comprises one State and three Territories. These two priests labored for three years without assistance, and organized churches, and baptized Indians and Canadians by the hundreds.

On October 17, 1843, Rev. Father Blanchet, who held the office of vicar-general, was instrumental in establishing St. Joseph's college at St. Paul, Marion county, this State, and a building was also erected for the reception of the sisters that were expected from Rome. In December, 1843, Oregon was erected into a Vicar-Apostolic and Rev. Father Blanchet was appointed Vicar-Apostolic, and on November, 1844, he set out for Quebec to receive his consecration, and from there he went to Rome, and on his representation, his vicarate was divided into three sees and Rev. Father Blanchet was appointed Archbishop, which office he held until February, 1851, when he voluntarily resigned the charge to Bishop Seghers, who still occupies that position.

Bishop Blanchet served sixty-two years of priesthood, forty-three of which were on this coast, and thirty-five years as the head of the church. He retired to St. Vincent's hospital, where he quietly abided the time when he should be called to his reward, surrounded by the devoted care of the sisters of his church, who anticipated every wish that comes from faith and love held for the aged father confessor. At his own request his remains will be taken to St. Paul, Marion county for interment.

Terrible Tragedy!

On the 18th Zachariah Baker and Benjamin H. Thomas, his son-in-law, each shot and killed the other. The affair took place in Hanley's law office, where the parties were engaged in an arbitration. Baker had heard Thomas was going to assault him, and he bought a 38 caliber Smith & Wesson revolver in Larkin's store. Shortly after the meeting in the lawyer's office they had some violent words, and Hanley remonstrated with them, and told them to be quiet. Hanley then walked out to let them cool down. Instead of ceasing the quarrel Thomas revived it, and said, "You son of a b—, you jumped me once before, but you can't do it again!" He then pulled his revolver, a 32 calibre "Blue Jacket," and snapped it at Baker, but it did not explode. Baker drew his revolver and fired, the ball entering Thomas' left breast, piercing the heart, ranging upward and backward and lodging under his shoulder blade. After being fatally wounded Thomas cocked his pistol and again aimed and fired, the bullet entering Baker's left breast, about an inch above the nipple, piercing the heart, ranging downward and backward, and lodging under the first rib. When Thomas fired the hammer of his revolver in descending severed a lock of his wife's hair, and is said to have ploughed a furrow in her cheek, after ward entering her father's heart.

Dr. E. M. Brown empaneled a jury who returned a verdict that B. H. Thomas and Z. Baker came to their death by each shooting the other. Mr. Thomas was married to a daughter of Mr. Baker. They had been bad friends for some time.

A Visit to the Medical Springs.

We, for the first time, in company with C. W. Jones the proprietor, visited the Eldorado Spring this week.

The location is some three miles due west of Roseburg, in the Umpqua river. In consequence of the tedious windings of the road we were compelled to travel some four miles to get to the spring, which we found to be located amid nature's fairest and most picturesque surroundings. The hills on the left rise to almost mountain height, covered with lofty trees, while near the spring is a strip of level bottom land, covered with a dense growth of fir, maple and myrtle, interwoven with a thick growth of underbrush. To the westward stretches a mile or more of smooth and placid water.

The medical spring itself is in the bed of the river and wells up from a fissure in the solid rock, and at the present low stage the river is a foot or more deep over the spring. The water is obtained by an iron pipe or pumpetock, which is riveted to the bed-rock, over the fissure, the other end fastened to a tree upon the bank, and a common suction pump used to draw the water. The fluid is as clear as crystal and cold as ice water, when first drawn from the fountain.

As to its medical properties there are many testimonials. It would be impossible to describe its taste, and when first drank it is very repugnant, but by frequent draughts it becomes more pleasant. In order to try its effect we drank a quart or more of the water during the day and can say that about the only effect it has had upon us we since have been somewhat drowsy and favored with an insatiable appetite, to the dismay of the waiters and utter consternation of our landlord, who will no longer sell the water to his regular boarders.

State University.

The annual meeting of the regents of the State University was held at Eugene on the 14 and 15 inst. present Mr. P. Deaby, Pres. T. G. Hendricks, R. S. Bean, Dr. S. Hamilton and Rodney Scott. The venerable Dr. Geary was unable to be present. The routine business was gone through and some by-laws passed. Professor Lambert was continued as professor of English literature and Mr. Barker as tutor.

The receipts of the institution during the year, including the sum of \$3,243.14 on hand on July 1, 1882, were \$15,638.89; and the expenditures during the same period were \$14,797.35—leaving a balance on hand of \$841.54. But on July 1st a quarter's salary will be due the faculty, amounting in the aggregate to about \$3000. To meet this there will be, in addition to the amount on hand, \$625 of the permanent appropriation, and probably \$900 interest, making the sum of \$2396, which will leave a deficit of about \$600 when the next term begins in September. But on Friday last there was received from Mr. Villard for the university ten of the first general mortgage bonds of the Northern Pacific Railroad Company of the par value of \$50,000, paying six cent interest payable semi-annually. This generous gift includes the interest from January 1, 1883, so that there will also be \$1500 due from this source by July 1.

The University of Oregon is now an established fact and its permanent success is assured.

DROWNED.—Miss Maud Black, aged about 14 years, a granddaughter of Mr. and Mrs. Minard of Happy valley, this county, was drowned in the Coquiltum river British Columbia, on last Saturday. The scholars of St. Ann's convent of New Westminster were having a picnic. Some of the girls went in bathing and Miss Black and a girl named Nellie Ward were carried beyond their depth. The other girl was rescued. Miss Black was carried under the current and caught beneath a log in about ten feet of water. She remained in the water about an hour before her body was recovered.

GLASS BALL SHOOTING.—A silver medal has been provided as a prize for the best glass ball shot at the coming Fourth of July celebration in Roseburg. The following gentlemen have already signified their intention to compete for the prize. F. Tolles, J. Whiteman, C. Parks, J. Clements, W. T. Peet, L. A. Sanctuary, H. Esterbrook. Any one is at liberty to shoot who desires, without charge.

Gannon Captured.

Yesterday morning ex-Sheriff F. P. Hogan and H. C. Stocum captured R. W. Cannon, the young man who shot and wounded County Searter Jacob Voorhes in Marion county some three weeks ago. He was at Hans Weaver's ranch near Myrtle Creek in this county, and when approached ran his hand in his pocket. Mr. Hogan caught his hand and asked him if he was armed; he answered that he was. They took his revolver and informed him for what they arrested him. They brought him to Roseburg and placed him in the jail for safe keeping during the night.

Mr. Hogan started with the prisoner on the early train this morning to take him to Marion county. They will get the reward that has been offered for his capture.

FROM DRAIN.

The public school here will close in two weeks. The teacher is well qualified for the position, as we hear her spoken of in the highest terms, both by patrons and pupils. Miss Douglas of Lane county, who has been teaching in the Ritchey district, closes her school on Thursday. Mr. G. V. Boggs closed his school on Elk creek last Friday. We think we have been very fortunate in securing such able teachers in this end of the county.

A very pleasant party was gotten up here on last Saturday evening, in honor of the Miss Stoffers of Cottage Grove, who remained in our village until Monday morning.

Our merchants report that they are entirely out of matches and don't propose to stock up until after the first, as the duty will then be removed. We know of several parties who propose to make matches and are more than willing to pay their duty.

Any and all persons claiming adversely any of the above described lands must file their claims with the Register of the Land Office during the sixty days publication hereof, failing to do so their rights will be barred by statute.
