The Chinese Question.

The decision recently rendered by Judge Nelson of the United States circuit court of Massachusetts in the case of the United States vs. John G. Douglas, is regarded with much alarm and serious apprehension by the people of the United States.

If such a construction as this is to prevail then the "Chinese act," which was procured after such a struggle, is without any force whatever. By this extremely technical decision the protection which was sought for and the benefit to be realized by the people is taken away from them.

The decision makes at least 100,000 Chinese persons resident in Hong Kong eligible for emigration to the United States; it opens the gateway to fraud, so that the act is impracticable and easily avoided by every Chinaman who wishes to emigrate to this country.

Pre-empted Lands.

The following decision that mere occupancy of public lands without residence gives no title, may be of value to pre-emption settlers in this State.

In the case of the Stockton building and loan association against Chalmers and others, the Supreme court decides that the bare occupancy of government land, no other step in the direction of pre-emption having been taken by the occupant during his life, or by his administrator or heirs after his death, notwithstanding that the probate court may have set apart the land as homestead for the family of the deceased, does not stand in the way to prevent a third party from filing a pre-emption claim for the same land.
