At this late day many are desirous of having a teacher engaged and a school started. But no action has been taken by those in charge of the institution. At the conference of the M. E. church no report was made, and some ad coated selling the building and donating the proceeds to another school, which is situated at a considerable distance from the men who build it, and who would not be benefited thereby. Besides, we would like to know wherein lies the good policy of abandoning an institution that has a good, substantial fence around it, well sealed, has two excellent musical instruments, and whose last term was the fullest spring term it has had for many years.
