He was the first sheriff after the county was organized, and we believe that he held nearly every office in the county until it was annexed to Douglas county, when he held every office he would accept. An ardent Union man during the war, his dearest friends were those who differed with him on that subject. A friend of the people, a true Democrat, we can say of him.

None knew him but to love him, None named him but to praise. Peace to his ashes.
