Eldorado Mineral Water.

The following letter will explain itself. It will prove of benefit to all who feel an interest in nature's medicine.

SAN FRANCISCO, April 22, 1884. GAO. W. JONES, Esq.

Your favor of the 15th inst. just to hand. The medical gentlemen at Roseburg, or rather, those who have expressed their polite opinion as to the fraudulency of my report on the Eldorado water, have been at great pains to express their sublime ignorance of elementary chemistry, in what they say respecting iodine.

I really could not have believed that any graduate in medicine could possibly be so astoundingly ignorant. Had they taken the trouble to look in 'o' any text-book on chemistry they would have found something to the following effect: Iodine is found in nature in combination with metals, forming iodides, which occur in both the organic and inorganic (or mineral) kingdoms, having been detected in sea-water, sea-plants and animals, and in many mineral springs. Iodine has also been found, in small quantities, in Chili saltpetre, and, on this coast, in combination with silver; in lead ores, also in dolomitic limestone, and in every deposit of rock-salt. It has even been found in coal. It occurs in a few land and fresh-water plants, and in many sea animals, as sponges and oysters; also in cod-liver oil.

Both iodine and bromine, as iodides and bromides, are constituents of the leading mineral springs of Europe. Among these may be mentioned the celebrated waters of Kreutznach, Dierkheim, Krakenheil, Adelheids, Quolle, Challes, in Savoy, and Cascio Cave, in Italy. The celebrated Wood-hall Spa, in England, contains as much as .35 grains of iodide of potassium per pint of water, which is equivalent to a little over a quarter of a grain of iodine.

There are several springs in the eastern States known to contain iodine. Prof. Rogers of Philadelphia, states, in reporting on a mineral water from Monroe county, Pennsylvania: "It has been very minutely analysed and is the first of all of the waters in which I was enabled to detect traces of iodine, which it contains in larger amounts than the old spring, and, indeed, than most of the other water in which I have been so fortunate as to discover this material. The presence of a larger quantity of iodine in this spring points it out as a superior agent in many affections for which iodine is successfully employed."

There are several springs in California containing iodine, many of which I have myself analysed. I will only mention here the celebrated springs of Paso Robles.

I think I have said enough in support of my assertion that iodine does occur in the mineral world, the eminent and learned medicos of Roseburg to the contrary notwithstanding.

Drowned.

Mrs. Champaign was a lady well known in the country and had a large circle of acquaintances and friends. The entire community is shocked and grieved at this sad accident.

Of the nomination for supreme judge it cannot justly be said that the convention selected from the names presented the man whom the people generally regard as best fitted by natural ability and legal attainments for the position; and this being strictly a non-political office, and a very respectable one, reputation for ability and legal attainments ought to have had weight in deciding the nomination. Mr. F. Linn is, however, a man of excellent character and undoubted integrity; but it is questionable judgment to pit him against so well known and so able a man as Governor Thayer. It is just to Mr. Hill to say that the nomination was not solicited by him, that he did no 'work' whatever among the delegates, and is in no sense hurt or disappointed because he did not receive the honor. What we say of the matter is simply born of the conviction that a convention in making nominations for positions which require a certain kind of fitness and known ability ought to select for those positions men whose reputation is highest for the peculiar kind of fitness and ability required."

If that is as much as Mr. Hermann's best friend can say of, about or for him, then should he say: "The pomp and glory of this world, I hate thee," and the more so because I cannot obtain thee. As for F. Linn it is too, too bad and let him exclaim: "Oh for a rest in some vast wilderness."

Louisville April 29-[special]-The republican primaries last night all broke up in violent disorder. The revolt against Arthur and the machine was terrific and several district meetings were changed into free fights. A number of men were shot and a number injured. The anti Arthur republicans outnumbered the revenue people three to one, but the office-holders refused to submit, and in all the districts two tickets have been elected.
