On motion of W. F. Owens, C. Gaddis was elected temporary chairman and W. H. Walker secretary. The object of the meeting being stated by the chairman, on motion the following committees were appointed on credentials: Col. John Lane, J. B. Casfield and Mrs. Teal, on order of business: Wm. Alexander, E. P. Richardson, Mrs. Crouch and P. Benedict, on resolutions: W. F. Owens, Mrs. Dr. Ege, Wm. Alexander, H. Luhn and Mrs. Teal. After remarks by Col. John Lane, W. F. Owens and Rev. W. A. Smick the convention adjourned to meet at 3 o'clock P. M.

AFTERNOON SESSION. The minutes of the morning session were read and approved. The committee on order of business made the following report: 1. That the temporary officers act as permanent officers. 2. Report of committee on order of business. 3. Report of committee on resolutions. 4. And that this convention meet with the W. C. T. U. at 7:30 P. M.

REPORT OF COMMITTEE ON CREDENTIALS as above read and adopted. The report of committee on resolutions being called for the chairman asked for further time, which was granted. After remarks by E. P. Richardson, Col. Lane, B. F. Ramp and others the convention adjourned to meet in evening session immediately after the adjournment of the W. C. T. U.

EVENING SESSION. The W. C. T. U. carried out the following programme: Opening song, America. Prayer, Rev. W. A. Smick. Lesson from I Corinthians XIII, by Rev. J. W. Miller. Song. Short address by Rev. W. A. Smick. Sketch of the life of Dr. Rush by Mrs. Selden. Solo, "Spare My Boy," by Mrs. Flint. Essay by Mrs. Smick. Address by Rev. J. W. Miller. Song "Voice it Down."

These excellent exercises then gave place to the workings of the General Convention with approval of the minutes of the afternoon session and the unanimous adoption of the following resolutions as reported by the committee.

WHEREAS, Governments are instituted to establish justice, insure domestic tranquility, provide for the common defense and promote the general welfare of the people, and

WHEREAS, To secure these blessings the free immigration to our shores of the criminal and pauper classes of the old world should be prohibited. The exchange of any and every production of any country, calculated to work injury, disease or poverty upon the inhabitants of the exchanging parties defeats the great object for which governments are instituted and should be prohibited by international law, and

WHEREAS, The commercial prosperity of this great nation depends upon its agricultural, mechanical and manufacturing industries in its sobriety, morality and christian loyalty to the great objects for which governments are instituted, its pure and noble march and womanhood; its public school system, its christian churches and contented homes, in the proper application of the capital of the nation in the purchase of the manufactured products of legitimate trade, thereby strengthening all legitimate commercial industries, procuring a market for all manufactured goods of every description, provide a demand for the raw material of the farmer, stock-raiser and artisan, thus strengthening legitimate trade in every branch, and

WHEREAS, The diversion of 944 million of the capital of this nation from the purchase of the necessities and luxuries of life annually to the

purchase of intoxicating drinks, is and has always been the chief factor of a deranged trade, a close money market and hard times, a country filled with tramps, gamblers and thieves, and an oppressive taxation to care for the victims of the traffic, and

WHEREAS, This traffic with its deadly blight on all other industries of our common country has been increasing at the rate of over eight hundred per cent in the last thirty years, while our population during the same period has increased at a less rate than two hundred and thirty per cent, and this under the legislation of the Democratic and Republican parties, who have fostered and encouraged this industry so disastrous to the commercial prosperity of the American Nation, so destructive to the great business interests of the people, so prolific of crime and high taxation, so opposite to schools, church and good government as to demand its entire and absolute prohibition by National law. Therefore be it

RESOLVED, That we hold the Democratic and Republican parties responsible for the present deplorable condition of the country, the heavy local, State and National taxation, the overdoing of our jails and penitentiaries, and increasing criminal docket with thousands of broken and destroyed homes, with the present stagnation of business, the constantly recurring strikes and derangements of trade in our large cities, the direct result and effect of the liquor traffic. Therefore be it

RESOLVED, That we demand of the Foster Parents of this nefarious traffic, the State and National governments - its entire and absolute suppression throughout the entire country. We make this demand in behalf of suffering humanity, in behalf of cheap government, low taxes, public education, the Christian religion, happy and contented homes, universal industry, commercial enterprise and national trade. And be it further

RESOLVED, That the hour demands the immediate organization of a political party whose main and central idea is the absolute destruction of the liquor traffic in every county and state of the American Union where such party does not now exist thus insuring a revival of trade an increased demand for all the necessities of life, insuring domestic tranquility and promoting the general welfare of the people which is and will remain the paramount issue in all coming political campaigns until the traffic is forever prohibited by national law.

On motion the secretary was instructed to furnish the local press with a minute of the proceedings of the convention. On motion the convention adjourned sine die. The unity and spirit with which the resolutions were adopted manifested a pitch of public sentiment that is encouraging indeed, and before which the run power must yield dominion; for the purposes of the sovereign people are right and will prevail. The history of our country cannot be preserved unless the men who made that history preserve it. The REVIEW has mentioned this subject before and hopes that some effort will soon be made to properly organize a Pioneer's Association in Douglas county. There are many other subjects that come into mind as necessities in the social world of our city and county but as space is crowding us this week, we close with the hope that some one will take the initiative in the matter of a re-union of our pioneers. The columns of the REVIEW are open to all on this important subject.

Manufactories.

EDITOR ROSEBURG REVIEW:—We should keep it constantly before the people the importance of home manufactory. Very few are aware how step by step we are being encroached upon by Eastern manufactories and the day will soon come when scarcely anything we use, eat, drink or wear will be made or produced in Oregon. The other day in making an order for groceries I put on the bill, "Hams, Oregon cured." The groceryman said, "We have Oregon cured hams, but you could not use them were we to send you one, they are too salt. We have no packing and curing houses in Oregon and hams put up to keep all summer are so salty they are not fit for use; in the East, where we get our hams we get a fresh supply every month, for there they have packing and curing houses, where the atmosphere is kept cool by artificial means and thus they can cure meats any month in the year."

Why don't some one in Oregon start such a house. C. A. R. Portland, Sept. 21st.

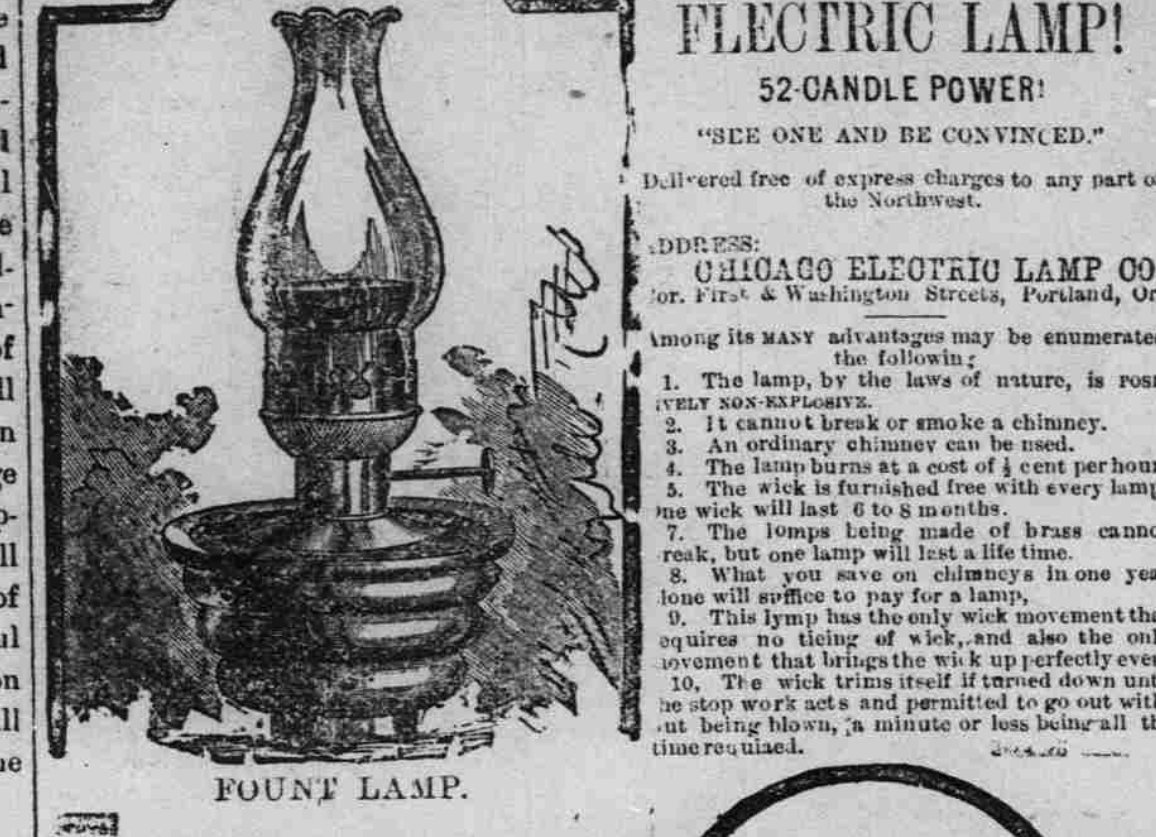

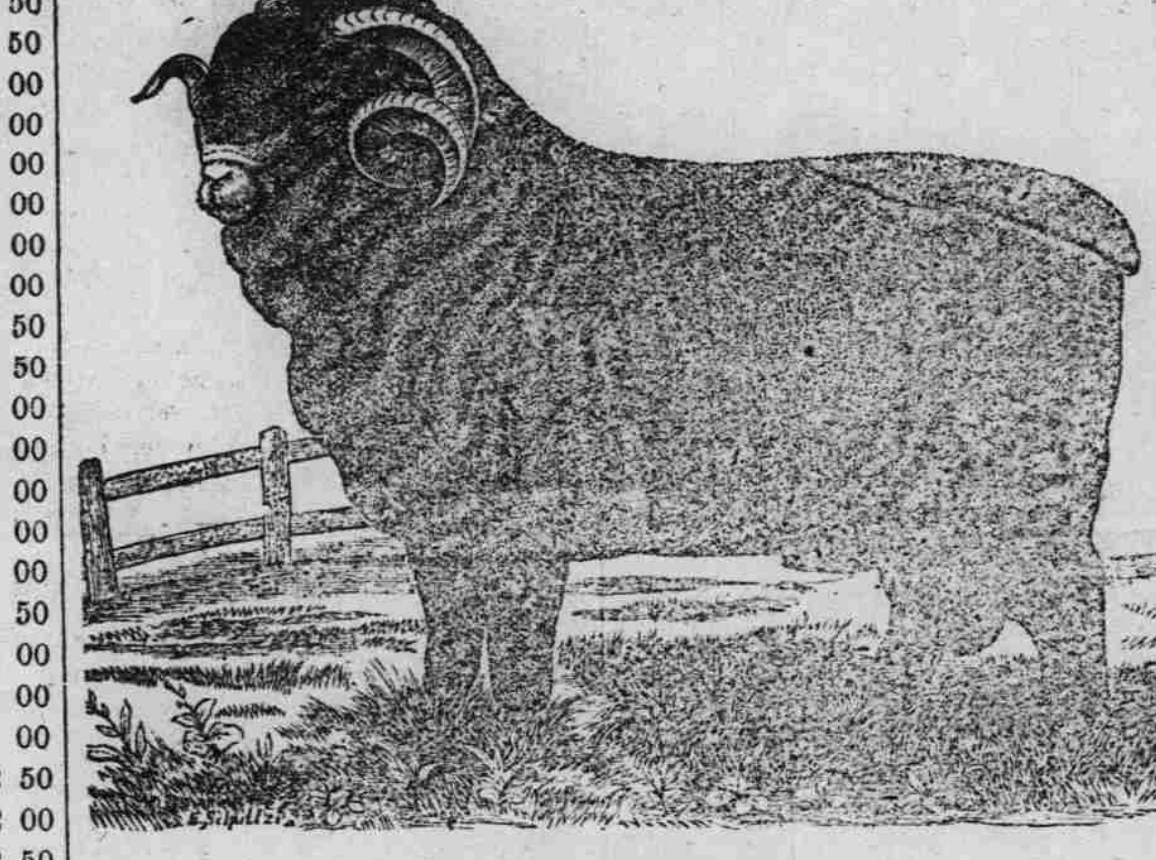
