Soon thereafter the captain's attention was called to an inverted post, to which a small Indian boy was clinging, and the upturned face of an Indian woman floating in the river with a child clasped in her right arm. The boat drifted ashore and the boy was rescued by persons on the bank, and the captain lowered a boat to proceed to take the woman and child out of the water. On taking them out the woman was found to be alive, though nearly completely exhausted by the effort of keeping the child on her arm above the surface of the stream, and, strange to say, she was

grasping the dress of a little girl in the left nand. Every effort was made to resuscitate the children, but to no pur pose, as they were both dead when taken from the river. The kind-hearted captain, assisted by

passengers, were determined that the least \$10,000 invested in the mill prop heart-broken mother should see her chil- erty. dren alive after her heroic effort to preyent them from drowning; but they were dead, and, although only a squaw, she had cluug-to her boy and girl, when, by so doing, she had imperilled her own life." Can a better exemplification of maternal affection be shown among civilized people than this example of a savage Indian in the wilds of Oregon?
