Cereal Production in Oregon. The census office has issued the following statistics of cereal production in Orewig-Holstein, Germany, aged 46 years, 1890, compiled by Mr. C. E Kindt under 224 bushels being at the rate of 16 81 bushels per acre, as against 445,077 acres and 7,480,010 bushels at the census of 1880, the yield per acre in 1879 being exactly the same as in 1889. The in crease in the area in wheat over 1879 was 108,193 acres or 24 31 per cent and in yield 1,818,214 bushels or 24 81 per cent. 1889 was 218,736, which produced 5,948,-594 bushels, being at the rate of 27.20 bushels per acre as against 151,624 acres and 4,385,650 bushels by the census of 1880.
