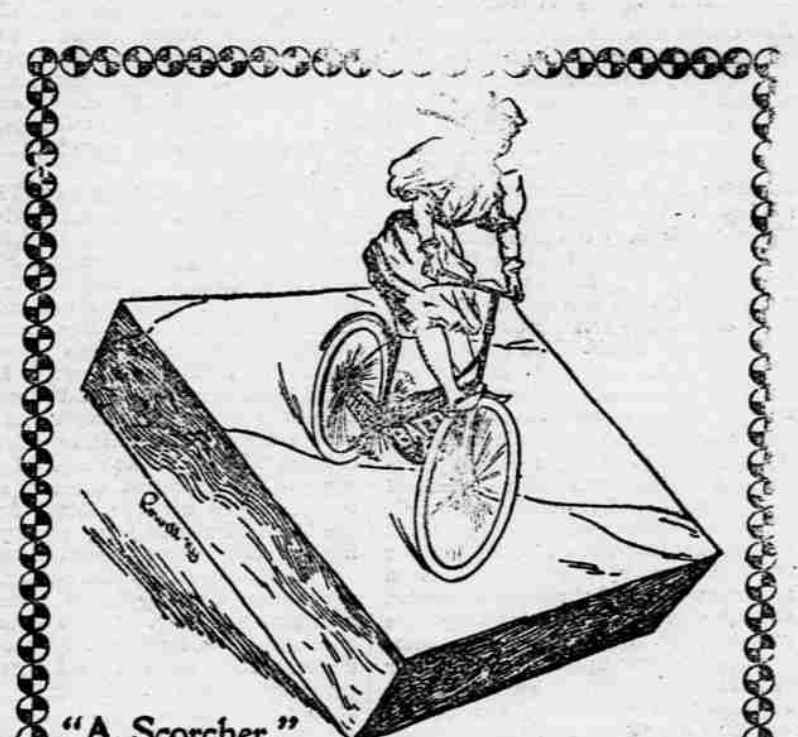

He is Still Remaining Outside the Spanish Trenches.

HAVANA, Nov. 2.—The report that Antonio Maceo crossed the military line after attacking Artimesa and being repulsed with great loss, according to the official account, is again denied. It is stated that the insurgents, upon that occasion, acted without union, disobeyed orders, made no attack upon the forts and were unable to capture the Spanish occupants. Maceo the day after bombarding Artimesa, in conversation with a member of a firm near Manzanillo, Pinar del Rio, deplored the loss his forces sustained and admitted that it was no easy matter to cross the military line. Spanish forces are slowly occupying positions Maceo may have intended to use, and he is said to be resting, in order to be ready for the next day.
