

One country may be more directly interested than the other in the completion and control of the inter-oc anic canal, but both England and America will benefit commercially by the opening of the waterway, and neither can have any adequate motive for hampering or retarding a great work which will contribute to the rogress and civilization of the world. On this high ground the two governments can meet and devise practical measures for facilitating the construc tiou of the canal and providing for its control and maintenance as a neutral waterway open at all times to the shipping and navies of all nations. This is a policy which they are now endeavoring to carry out in an enlightened and progressive spirit worthy of the genius of the Anglo-Saxon race.




