Themselves.

AUKLAND, N. Z., April 27 .- Particulars of the fighting in Samoa, contained in advices received here from Apia under date of April 18, show that a battle between friendly natives and rebels took place at Vailelo, and that the latter lost 100 men in killed and wounded.

Further details of the death of Ensign Monaghan, of the cruiser Philadelphia, and Lieutenant Lansdale, of the same vessel, have been received. They show that Monaghan was beheaded before he was dead. A deserter of the Mataafan force says Monaghan and Lansdale were retreating when they were discovered by the chief and bis wife, who were looking for dead men. They gave the alarm and Monaghan was shot while continuing the retreat. Later it appears the rebels returned and killed Lansdale. Monaghan fought until he was wounded, and he was then beheaded. About 2.000 women and children have sought refuge at Maluit, a station of the London Missionary Society. The rebels are seizing traders' rifles, cartridges and stores and traders are




