Mrs. Ira S. Townsend Dead.

Miss B. F. Smith was born in Missouri in 1831, and in 1853 crossed the plains with her parents, George and Susan Smith, who took a donation land claim near McCoy.

The same year she was married to Ira S. Townsend, who came to this country in 1847 and was living on an adjoining donation land claim.

For many years he was one of the most prominent men in the county and died in 1895.

For almost 50 years she continued to reside there, an honored and useful member of society.

For many months she had been an invalid and last fall came to the house of her son, Hon. J. H. Townsend, in Dallas.

There she lingered until last Sunday, when she passed over the river to be with her loved ones beyond.

She joined the Baptist church in 1852 and for more than a generation had held membership with La Creole church near Crowley.

It was specially fitting that her funeral should be preached by Rev. A. J. Hunsaker, of McMinnville, he being intimate with the family for more than forty years.
