The state convention in Portland last week required a two days' session. Considerable time and great care was devoted to drafting a platform that would meet general approval. Not for years before has there been so much unity of thought and action, and an unusually large vote is sure to be polled. Unless the republicans can hatch out more brotherly love than now abounds, they will have far from a walk over. The democratic nominees are all capable and worthy men. Here they are: Governor, G. E. Chamberlain; supreme judge, H. F. Bonham; secretary of state, D. W. Sears, state treasurer, Henry Blackman; attorney general, J. H. Kaley; state printer, J. E. Godfrey; school superintendent, W. A. Wann; United States senator, C. E. S. Wood; congress, first district, J. K. Weatherford; second district, W. F. Butcher; joint representative for Polk and Lincoln counties, I. M. Simpson.

U. E. OREGON CONFERENCE.

The United Evangelical conference for Oregon convened in the M. E. church south at Dallas at 8:30 April 11th to hold its eighth annual session, Bishop Stanford presiding. After a talk by the bishop, telling of the advancement of the church in the past the members were enrolled. The lay delegates were J. E. Phelps, of Florence, Oliver Beer of Brooks, C. E. McLane of Suver, A. Peterson of Hillboro, C. C. Gardner of Bridgeport, G. C. Countryman of Dallas, Levi Henkle of Corvallis, D. Stoutenberg of Dayton, A. F. Henry of Lafayette, R. W. Orendin of Portland, G. C. Brown of Salem, C. E. Calbreath of Sweet Home, W. H. Hamilton of St. Johns and W. H. Barendrick of Portland. Rev. H. A. Duck was chosen secretary with C. T. Hurd as assistant. The pastors of the Dallas churches were introduced to the conference, which then went into executive session to examine into the characters of the ministers and lay delegates. All of them passed the required examination. With the ministers this means that they have faithfully served their charges, that they have lifted the required collections and that they have not used tobacco during the year. A letter from Bishop Dubs giving advice as to the work in this state was read. J. L. Burns, of Lewisville, was granted license to preach. A resolution regarding the work of the church in this place was presented by Pastor A. A. Winter, and steps will be taken to build a church here as soon as possible. Rev. E. C. Basom was received from the Central Pennsylvania conference. Sunday morning the Bishop preached to a full house, the church being nicely decorated. At the afternoon missionary meeting the bishop preached an excellent sermon on mission and missionary money to the amount of \$600 was subscribed, all to be paid within the coming year. At night Bishop Stanford preached a rousing pentecostal discourse to a housefull of people, while Rev. G. H. Phelps preached at the M. E. church, A. W. Brickley at the Baptist and Rev. J. M. Ballantyne at the Presbyterian church. Presiding Elder Poling and Rev. H. L. Pratt were elected delegates to the general conference which meets at Williamsport, Pennsylvania, next October. Levi Henkle and Oliver Beers were chosen lay delegates to the same meeting. The conference voted to retain the time limit for bishops and presiding elders as at present, that is for a term of four years and to be eligible to reelection but once. After each afternoon session the bishop gave interesting bible readings. A vote of thanks for the free use of the church was given and to the people of Dallas for their generous hospitality. The last order of business Tuesday afternoon was stationing the preachers, which was done as follows: District, C. C. Peeling, presiding elder; Alsea, to be supplied; Florence, T. A. Yost; Mapleton, W. Flowerman; Brooks, G. L. Lovel; Beulah, S. M. Wood; Lewisville, S. J. Lindsay; Corvallis, H. A. Deck; Dallas, A. A. Winter; Dayton, J. Bowersox; Gaston, A. W. Brickley; Hillboro, G. H. Phelps; Independence, B. J. Kelly; Kings Valley, W. L. Arnold; Lafayette, C. T. Hurd; Portland, first church, H. L. Pratt; second, E. C. Basom; Salem, C. A. Riving; Sweet Home, F. E. Fisher; St. Johns, M. J. Ballantyne; Troutdale, J. L. Burns, and D. M. Metzger, professor in Dallas college. The ministers all started to their fields in good cheer. The bishop will remain in the valley for some time to visit the various fields of the conference. He has a church to dedicate at Gaston and another at Sodaville. The conference appointed a committee to raise the endorsement fund of Dallas college \$25,000 above its present amount.
