## TOP NOTCH FOR HAY.

Hay Commands a Higher Price than Ever Before.  
The same as nearly every other commodity, the price of new hay has soared away up into the empyrean. In fact its value now in the field is nearly twice what it generally is at this time of the year. And it is not plentiful even at the advanced price. Mr. George Schmelzer informs me that he and his men were yesterday scouring the county contracting for their year's supply for the livery stable, and that they found hay hard to get and selling at \$8 a ton in the field. This is about the average price asked for good timothy, chest commanding about the same price, also oat hay. This is probably the highest price ever asked for hay in the field in this county, and the cost is laid not so particularly to its scarcity, but to the cost of production. Labor now commands such a price that it would be impracticable for the farmer to sell it at a lower price.

A Very Useful Tree.  
The most marvelous tree in the world is the cranberry palm, which grows in Brazil. Its roots produce the same medicinal effect as sarsaparilla. From parts of the tree wine and vinegar are made. Its fruit is used for feeding cattle. Of the straw, hats, baskets, brooms and mats are made. It is also used for thatching houses. The pulp has an agreeable taste, and the nut is delicious and exclusive. It yields also a saccharine substance as well as a starch resembling sugar. Of the wood of the stem musical instruments, water tubes and pumps are made. From the stem a white liquid similar to the milk of the cocconut and a hour resembling mazaona may be extracted. Moreover, salt is extracted from the tree, and likewise an alkali used in the manufacture of common soap.—An swee.
