During Mr. Grant's term of office the criminal part of his duties has been particularly severe, for jail has been empty most of the time, and it has not fallen to his lot to make many arrests. Whether his occupying the office has been a terror to the law breaker we cannot say, but it might be possible that the many years of service given by him as marshal of Dallas and his well known fearlessness and energy in the apprehension and arrest of those who break our laws might have had no little to do with the almost clean record of the county in this respect. As a local terror to evil doers, J. M. Grant has no equal in this county. But where he has particularly shown in the duties of the office, is in the collection of taxes. There he has a record that skins by a large majority that of any other occupant of the office, and shows how well adapted he was for the duties. Last year there remained uncollectable on the delinquent tax list only \$168.01. Such a small sum out of money left to turn over to the proper officials as delinquent has never yet been approached, in fact by several hundreds. Other sheriffs thought they were doing exceptionally well when they got the amount down into the hundreds. Mr. Grant's record in this particular was a happy surprise to every county official, and one that he will be proud of. It will be pleasing to every taxpayer, and the result will be that Mr. Grant will be returned at the polls by probably the largest majority ever accorded a candidate in this county. He has fairly won by earnest endeavor and constant and painstaking attention to the office a reelection to his second term, and the voters of Polk county will see that he gets his reward for earnest and untiring labor. The result was that said town instead of keeping pace with the growth of the country only continued to hold the same population and business, where if they had been blessed with progressive citizens not content with holding the almighty dollar, their town might just as well have doubled or even tripled their business and population. The last year or so there has been an awakening there, and now they would not go back to the old rut for any amount of money. Their town is sleepy no longer. DR. CLARENCE TRUE WILSON ON WOMAN SUFFRAGE.

The question is not whether the women have a right to vote, but it is whether we have a right to compel them all to vote at the dictation of a very small minority of their own number. It is certain the vast majority of our women do not wish the ballot. The laws for the protection of women are improving steadily with the years and every interest of hers is as well safeguarded as that of any man. If you wish to protect the rights of woman ask yourself today, does my wife want to vote, does my sister, does my mother claim it to be her privilege? If they do not, what right have I to compel them to do it by ballot?

But it is said we need the ballot of woman to aid us in government. But is it expedient? Will society be improved by the granting of the ballot to woman? Will the better element of woman come to the front as political workers and fill our offices, or will the worse? Which is the better element of woman? The quiet and unassuming queens of our homes, our mothers, sisters, wives and sweethearts, or will politics be controlled by the ebullient? This is not an untried experiment. Four states have given the ballot to women unconditionally, and after 20 years of woman's voting, politics has not arrived at the moral standard of our state in Wyoming, Colorado, Utah or Utah. But you say, "There are not as many men as women in Wyoming." Yes, but in Utah women are so plentiful that seven or eight of them club together and one husband between them, and with this numerous company they have not closed the brothels or closed the gambling dens or purified politics. Indeed, there are not four states in the Union where politics is so corrupt as in the four states where woman vote. It is a sad picture where a man, for the sake of office, sells his integrity, but it is a sadder, and a common sight, in the states where woman vote, to see women sell their virtue for offices. I can give specific incidents with names, places and dates, where women, desiring to be assistant county clerks, etc., are sent from the candidate's office to the political boss to there offer her all at the shrine of a man who, but for politics, would not be allowed to enter her home. In every woman's suffrage state, the proverb has had a double emphasis that "politics make strange companions."

If you wish to prevent such conditions in Oregon, vote "no" on the woman suffrage amendment on June 1st.
