Of all the road-projects and built during the last few years in the Willamette valley, this is one that would be the most beneficial to Salem, opening up as it does a slope of country whose trade was needed to make Salem a market center, and which is and will be diverted elsewhere unless such an outcome is obtained in the near future.

The New York World presents the results of an interesting poll. It finds that only one of the eighty-two delegates who attended the meeting of the Central Federated union in the University Settlement recently was in favor of Taft, and he is a life-long republican. Fifty-three said definitely that they would support Bryan, and among the sixteen who were non-committal two thirds showed a strong leaning toward him. A number who previously belonged to the independence league will join either the democratic or the socialist party this year. The result of the poll follows: Taft 1, Bryan 53, Dels 11, independence league 1, non-committal 16, total 82.

Dallas is to have a new brick this year after all. It is something badly needed, but our capitalists seemed a little leary of investing their money in such an improvement. Mr. Williams has no such qualms, being satisfied that Dallas needs more store rooms, and that he will receive value received for the expense there. There is not a store room in town for rent today, and every indication points to more being needed in the near future. New lines of business can in the fall find room here that have not been able to do so before, and it may be that the start thus made will induce other property owners to build up-to-date buildings. There is no danger of such not finding good tenants.

The jetty at Newport is one example of the way in which money is ruthlessly thrown away by Congress. We understand that over \$2,000,000 was expended to attempt to deepen the harbor there. Then the appropriation was cut off and the work stopped, the result now being practically valueless, and what was done going to decay as fast as possible. Either sufficient money should have been appropriated to finish and attain the result contemplated, or it should never have been begun. As it now stands, it is simply a monument of stupidity to all concerned, a detriment to navigation instead of a help, and a not inconsiderable marring of the coast.

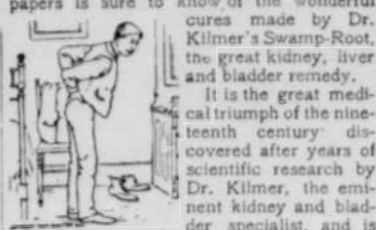
