And it is no wonder that the state's work along these lines has attracted this attention, for no portion of America is circulating the attractive literature that burdens the mails of Oregon every day in the year. Now that the colonists rates are to be into off-cut every citizen of the state should feel it his duty to advertise the fact in his personal correspondence, to send information about his community to eastern acquaintances and to aid in every possible way the com-

mercial organizations which are working to increase the state's population.

Figures of the lumber cut in 1907 compiled by the bureau of the census and the forest service showed the largest total ever reported in the United States, exceeding by over seven per cent the cut reported for 1906, until then the record year. This does not show a larger actual cut than 1906, for the returns obtained last year were more complete than ever before. The figures themselves disclose some interesting facts. The figures of production show that during 1907 Washington fell off very decidedly from its huge cut of 1906, while its sister state, Oregon, is credited with a slight increase in its total. In the early part of the year Washington suffered from a car shortage, and at the end the combined effects of business disturbance and higher freight rates had brought the industry almost to paralysis. Oregon kept up its cut because of its larger proportion of coastwise and foreign trade. These two states together produce more lumber than any other two

## LABOR DAY IS RECOGNIZED.

Governor Chamberlain Makes Next Monday Holiday by Proclamation.

Salem, Ore., Sept. 1. (Special.)—Governor Chamberlain today issued the following Labor Day proclamation: Whereas, The Legislature of this state has set apart and appointed the first Monday in September of each year as Labor day and declared the same to be a public holiday, now, therefore, I, George E. Chamberlain as governor of the state of Oregon, by virtue of the power in me vested, do hereby proclaim Monday, September 7, 1908, as Labor day, and recommend its fitting observance by all citizens everywhere. Let all public offices be closed and all private business wherever possible be suspended, and let the day be observed generally in appreciating labor's worth and the part it has always played in our national life and achievements.

#### Pears by the Carload.

Pear picking at the Wallace farm in Polk county is still in progress. There is a large crop being harvested of a pear that are kinds of their kind. About 300 tons of this fruit will be picked which goes to Portland for cold storage until next winter. A car will hold from 500 to 700 bushels of fruit. About a car load is picked every day, though on the second picking which is now on, it may not quite reach that amount. The pickers were laid off the latter part of last week because the pears were not filling as rapidly as usual. This was on account of dryness of the soil.
