### A FEW TRUTHS.

The federal administration last year spent fifty-four million dollars more than it spent in the 1898 war.

Republican leaders have been thrown into consternation over the "break" which Representative Longworth, the president's son-in-law made in his speech at Rock Island, Illinois, in which he out-lined the Roosevelt dynasty.

Mr. Taft says that the panic is about over and that conditions have about reached normal. That does not correspond with the view of the Chicago Board of Education that 15,000 children go to school hungry partly because their fathers cannot get employment and because of the influenza.

In a speech in the next Mr. Taft told the people that if Mr. Bryan succeeded he would put trust-controlled articles on the free list, but that the republicans would not do anything of the sort, but the "republican plan of regulation" is the proper remedy.

The metropolitan papers have begun to speculate as to the men whom Mr. Bryan will select as members of his official family in the event of his election as president. The Hearst papers predict that Herman Ridder, treasurer of the Democratic National Committee, will be appointed ambassador to Germany. This is the first time Mr. Bryan's election has ever been considered seriously by a hostile press. There is no more sure indication afforded anywhere that the democrats will assume control of the federal government March 4th next.

Mr. Taft says he is in favor of postal savings banks—no does the republican platform. The republican party has been in power 12 years. Why hasn't it established postal savings banks? Mr. Taft opposes guaranteeing bank deposits. The republicans in Kansas, Nebraska, Wisconsin and other states advocate guaranteeing bank deposits, but the big bankers oppose this protection. What the big bankers say goes with the republicans. Why do they wish postal savings banks? Because they know the money deposited in postal savings banks would go into the big banks and strengthen their control of the finances of the country.

The republican national platform which was framed at the dictation of big trust interests has driven thousands and thousands of republicans to the support of the democratic national ticket. In every state in the west there are Bryan clubs composed of republicans who were forced to leave the G. O. P. because of its allegiance to and connection with the trusts. A striking instance of this revolt is afforded by students attending the University of Minnesota who have organized a "Bryan Republican Club." Within a period of three days a membership of 300 republicans who will support Bryan has been enrolled and the list is still growing.

### MORE ROTTENESS.

Assertions of Big Graft in Panama Canal Deal.

Last night's Portland Journal has the following paragraph: The New York World today prints a cable from Paris in connection with its efforts to learn definitely who got the \$40,000,000 paid by the government for Panama canal, in which it is alleged that every source of information has been obliterated. The Paris message asserts that all record of the identity of the persons who received the cash has been hidden and that the records of the details of the agreement between the United States and the Panama Canal company have been either destroyed or lost. The New York World is supporting Bryan in the present presidential campaign and the investigation by the World was based on a rumor that Douglas Robinson, brother-in-law of President Roosevelt, and Charles P. Taft, brother of the republican presidential candidate, made large profits in dealing in Panama securities. The World says the liquidation of the French company's securities, supposed to have been sold to American syndicate, was concluded on June 3, after four years of negotiations. It asserts that all official records of the transactions have been removed. The sale of the canal to the United States was made by William Nelson Cromwell, who is prominent in the republican campaign. Miss Inez V. Gould, daughter of Rev. Hiram Gould, of Forest Grove, was married recently to Dr. Arthur C. Bages, head of the history department at Pacific University—Forest Grove.
