The attempt to follow the scare and coercion business, which worked so well under Hanna in 1896, is being resorted to again in a few places, but the panic of 1897 has made it impossible for the scheme to work again.

You cannot warm over the Hanna scare under different conditions. Maryland has led in passing laws against this method of intimidation. The extent to which the law goes in this respect is indicated by the inhibition placed upon employers of even handing out pay envelopes containing a political motto of any kind. It is unlawful to distribute placards or hand bills stating that men will be thrown out of employment or wages reduced if a certain ticket is elected or not elected.

OUR WASHINGTON LETTER.

Washington, D. C., October 12, 1908. Mr. Roosevelt is so badly scared at the sweeping campaign the democrats are making that it is all the republican leaders can do to keep him off the stump. A majority of the republican leaders hold that if Roosevelt should go on the stump it would indicate the dreadful panic that actually exists among republicans. Their fright and dismay are trying to keep to themselves, but the public understand quite well how badly frightened they are.

In Mr. Taft's recent stamping tour through the middle and central west, he discussed everything from the panic of 1893 down to the present time. Mr. Taft has by his visit made a confession of the weakness of his cause by going back to 1890 to dig up the issues of that campaign. He contended that Mr. Bryan having favored free silver in 1890 is an unsafe man at the present time. But Mr. Taft should remember that in 1890 the democratic party demanded independent bimetalism and the republican party pledged itself to international bimetalism. The only means free silver by this country alone the other means free silver with the consent of Europe. After all, this is only a difference in method and not in principle. The republican party has dropped the silver question just as the democratic party has dropped it. While Mr. Taft delighted to go back in ancient history he did not say one word about the full dinner pail that the republican party made an issue in 1900 and again in 1904. No indeed, the dinner pail of the working man is very empty at the present time. The farmers of this country are prosperous as a whole because they ship about 407,000,000 of their crops every year and they use only maintain their own prosperity but are the foundation of the prosperity of the whole country by reason of the fact that they bring this 407,000,000 from foreign lands to us by selling their wheat, corn, pork and lard. If the republican party were abolished and free trade promoted between us and Europe the farmer would be able to sell more than this vast amount to the foreign world which would greatly promote our prosperity and continue it in a safe state.

Mr. Taft seems to think or tries to think that the proposition of Mr. Bryan to guarantee the money of depositors is but little short of anarchy. Now Mr. Taft's plan is for the government to establish postal savings banks. By this means which he proposes, the depositor will take his money to the post office and have it entered in his book like the bank, and the money that the postoffice receives from the national banks of the country; here is where Mr. Taft's argument is torn to tatters and riddled to shreds. After the postoffice has received this money from the people they do not turn one dollar of that money over to the banks until they have guaranteed that every dollar will be returned to the government. Now if the government demands a guarantee before they will deposit their own money in a national bank, why should not the depositor have a guarantee when he deposits his money in the bank? It is a well known fact that the different banks that the government designated as depositories in which the government funds are deposited for the benefit of circulation guarantee every dollar of it. Now why should not the individual as well as the government be guaranteed? This all goes to show that the republicans have no plea to make to the people and that they have been unable to answer any of the democratic arguments.

While we like to use respectful language towards the president and will be as gentle with him as possible, yet it must be admitted that he has greatly divided in the estimation of the people of this country in the last year.
