COUNCIL MEETING.

Hard Paving Remonstrance Overruled and Resolution Passed.

The council met in regular session last Monday evening, with all the officers and members present except Councilman Coad. Coad recommended that the street committee call for bids for hauling and grading at the west end of Washington street, and on motion the same was ordered.

On motion of Staats the bringing up to grade and continuing the curb of the walk on the south side of Church street, opposite the court house, was left to the marshal.

Campbell reported that the work on the Grand theatre foundation had been completed.

Fenton reported that permission had been granted by the court to place a steel cell in the basement of the county jail, and on motion of Staats the same was placed in the hands of the health and police committee with power to act.

A report was received from City Engineer Flag relative to the dedication of certain streets in what is known as the Howe tract, and referred to the street

committee. A communication was received from Grants Pass requesting the council to visit and view their civic improvement—lights, paving, etc.

The time having arrived for the hearing of remonstrances against the hard surface paving of the nine blocks contemplated for this season, Abel Uglow appeared before the council with a remonstrance signed by a number of property owners. Mr. Uglow discussed the matter from the point of a taxpayer, and Captain Toose from that of those interested in the growth of the city. The hearing was closed on motion of Ayres, and on motion of Fenton the remonstrance was overruled.

Hi Plummer appeared before the council and asked for a grade for the east end of Academy street in order that it could be filled up and graded by the abutting property owners. On motion of Fenton the matter was referred to the street committee.

A bid was received and read from A. W. Dunn for the furnishing of 75 cords of second growth fir wood at the rock crusher for \$2.34 a cord. As this was a fair price Mr. Dunn was awarded the contract.

A resolution was introduced, read and passed providing for the hard surfacing of nine blocks as heretofore given.

An ordinance repealing ordinance 193 placing the auditor and police judge upon a flat salary was read first time.

On motion of Ayres the auditor was instructed to take the necessary steps to provide for the April election.

The council then proceeded to the election of a councilman to fill the vacancy occurring in the third ward by the resignation of A. J. Barham. August Besser was the only nominee and the poll of the vote found him the unanimous choice of the council. Ayres asked for warrants as follows: A warrant for \$1600 on the 1913 street fund to reimburse the 1912 fund, and one for \$5.00 from the general fund to provide for street interest.
