

DELINQUENT TAX LIST, 1912.

This advertised list of delinquent taxes for the year 1912 is in pursuance of an act of the Legislature, which is embodied in Chapter 301 of the General Laws of the 1913 Session.

The taxes on the following advertised real property became delinquent on April 7, 5 o'clock p.m., 1913, and are subject to a penalty of 10 percent and interest at the rate of 12 percent per annum until they shall have been paid.

After day after the expiration of six months after the taxes charged against the following real property are delinquent, the Sheriff is authorized upon demand of any person making application to issue to them, a certificate of ownership upon the payment of the taxes, penalty, interest and cost of advertising.

Certificates of delinquency shall bear interest from the date of issue until redeemed at the rate of 15 percent per annum.
