BY THE SAD SEA.
Postmaster Fiske Writes of His Impressions of Newport.

The first thing that a person wonders in making a trip to Newport this season is what particular brand of dope was handed out by the S. P. to that bunch of newspaper men whom they recently gave a free trip to this place to make them tell of such a wonderful improvement in transportation facilities. While it is true that some car chairs are now in use, and that one is nearly certain to be provided with a seat, yet it still is a nearly all day trip from Dallas—from 10 a. m. to 6 p. m.—and the road despite its recent rebalancing is so rough that it is nearly an impossibility to read on the train, in fact, the roadbed is worse to day in that respect than our old narrow-gauge road to Portland ever was.

The hegira to Newport this season is up to the average, if not more so, and Nye Creek is growing and expanding like a young bay tree. Many new cottages have been erected and all express themselves as perfectly satisfied with conditions as they exist after the tedious time of arrival. The Dallas colony is as populous as ever, entirely too numerous to attempt to mention individually. Among the arrivals today, Tuesday, were Mr. and Mrs. E. C. Kirkpatrick and Maurice Dalton, the latter coming over on his motorcycle, leaving home at 7 in the morning and arriving here at 11, pretty well tired out, but ripe for a good dinner.

Most of the waitresses at the Abby house are Dallas girls. Mr. Stubbfield is the principal transportation man, Billy Rodgers is working on the roads; Price Brothers have a general merchandise store, and many other Dallas people are in business here.

This morning we took an auto trip to Cape Foulweather light house, the second oldest on the coast, having been erected 41 years ago. Although only 41 feet in height, yet it has throwing power from its 20,000 candle power light out to sea nineteen miles, and the view from there is a most entrancing one. Visitors are cheerfully shown over the government premises and light house on all days of the week except Thursdays and Saturdays, and everything about the place is spick and span as it is possible for it to be made.

Three men work the light in eight hour shifts, two of them being on together at night from 6 to 6.

All transportation here now is preferably by auto, although the salt water is extremely harmful to their interior workings, and they frequently get stuck in attempting the very precipitous hills.

There seems to be considerable ocean travel close in this year for some reason, we today noticed passing several lumber schooners and passenger and fishing boats. The deep sea fishing is quite good and the local market is well supplied with nearly everything in that line. This industry is bound to become of considerable prominence on this coast in the years to come, as experience tends to locate proper fishing grounds, and experience is acquired in the new art of which this town is bound to be the center. Eastern oysters are also thriving on the beds in this bay and the popular fallacy that our waters are too cold for their propagation is rapidly being exploded. A popular amusement, ever to be regretted by many who do so, is the taking of a trip out to see the bar. The visitations of mal de mer come back sore on the voyage, but to those who "tumble" can stand the strain it is delightful.

We have no accidents to report among our people, except that at lunch today "Skinny" Williams got a little excited over the chances of electing a Republican president next time and split his soup in his lap, necessitating that a number of us act as his body-guard from the dining room.
