BEFORE THE COURT OF CLAIMS.—Last week Tom Morgan was called to the Dalles as a witness in the case in The Court of Claims, Henry H. Wheeler vs. The U. S. and the Snake Tribe of Indians. Mr. Wheeler was in the sixties owner of a stage line and outfit between The Dalles and Canyon City on which Mr. Morgan handled the reins. According to the complaint, "between May 1, 1864, and December 31, 1866, divers bands of Indians belonging to the Snake

tribe of Indians (the said tribe then being in treaty relations with the United States) wrongfully and unlawfully, and with force and violence, committed depredations upon the property of your petitioner, as hereinafter set forth, and took, stole and drove and carried away 89 head of American horses, the property of your petitioner, and converted the same to their own use, the said horses then being of an average value of \$180.00 each, and of the aggregate value of \$15,800.00; and also took and destroyed one stage coach of the value of \$1,000.00, and one set of double harness of the value of \$30.00, the property of your petitioner; the property aforesaid then being of the value of \$14,800.00; and no part of said property has been recovered, returned or paid for, but the same became a total loss to your petitioner by reason of the depredations aforesaid." In one of the fights Mr. Wheeler was badly wounded in the face.
