BEPPER WINS AGAIN.

The Second So-called Championship Game Won by Lepper—Score 23 to 40.

For the third time the Heppner and Morrow County nines crossed bats at the ball grounds on schoolhouse flat last Saturday afternoon. The game was styled "for the county championship," though this game probably could not, in all events, have settled or finally disposed of the much coveted belt, for according to the percentage system of all leagues it would now be necessary for the Morrow county nine to win three straight games before declaring themselves champions.

The game was called at 2 p. m. with E. L. Freeland and Walt Richardson as umpires, Fred Hart as official scorer, and the Morrow county nine at the bat and before they retired four runs were placed to their credit. To this eight more was added in the second. The Heppner nine scored two runs in the first and three in the second. The Morrow boys were "goose-eyed" in the fourth inning but returned the compliment in the sixth. However, the former retained a safe lead until the last half of the seventh when the Heppner boys scored 13 runs and in the eighth added 16 more, thus giving them the game by a score of 40 to 23. For the Heppner nine L. Matlock pitched the first two innings and Norman Myers the remainder of the game.

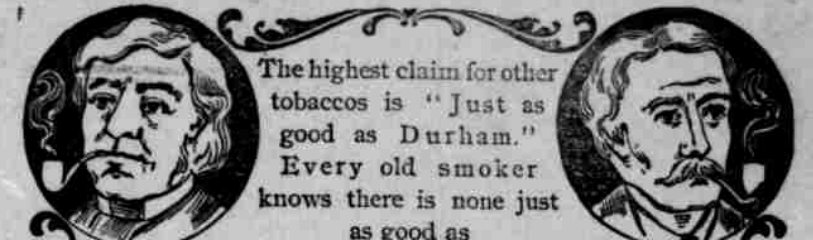
