The New York "Commercial", a financial publication, sustains the assertion made in these columns that the sugar trust gained no permanent advantage through the enactment of the Dingley law, by saying in a recent issue that: "Refiners who knew the profits of the business and who had been long on stock for years, and sold it, do not dream of buying it back." Considering that this statement is made when sugar trust stock has fallen from 160 to 120, it is apparent that those most familiar with the real facts of the case do not consider that the trust occupies an advantageous position under the new law.

THOSE "debt-ridden" and "mortgage-eaten" farmers of Nebraska have found a very rapid improvement in their condition since the rejection of free silver and free trade, and the adoption of a protective tariff with a sound money system. Late reports from that state show that a movement is on foot for the organization of co-operative beet sugar factories in different parts of the state and that the area to be planted to beets this year will be ten thousand acres in excess of that of last, and this, too, in the face of the threat by the factories now existing of a reduction in the price to be paid for beets in case of the annexation of Hawaii.

MR. DUNN TAKES HIS SEAT.

H. Blackman's Successor—Transfer Made on Monday—The Deputies. From Portland Tribune. David M. Dunne was installed into the office of collector of internal revenue Monday morning, Henry Blackman retiring. The change took place at 9 o'clock, the attaches of the office witnessing the ceremonies. Special Internal Revenue Agent L. A. Thresher has been here several days checking up the office, and every thing being to his satisfaction, the transfer was made.

United States Judge Bellinger was present and administered the oath of office to the new collector and his chief deputy, J. Frank Davis.

After these ceremonies were over, Collector Dunne announced his office force. There will be no change excepting the chief clerk. John E. Bellinger, who has been chief deputy under Mr. Blackman, will go to his ranch in Clark county, Wash.

Just before the transfer of the office was made, the office force waited upon Mr. Blackman and presented him with two handsome pieces of furniture. This was followed by a little speechmaking, which indicated the high esteem in which Mr. Blackman was held by those associated with him.

Collector Dunne yesterday made the appointment of all his other deputies under the emergency prerogatives granted the office. All of these appointments with the exception of that of the deputy at Circle City, Alaska, which holds for 60 days, are 30 days' appointments. This is done to enable the collector to familiarize himself with the duties of his office and to determine the fitness of his temporary appointees. If, at the expiration of 30 days the service can be improved by making changes they will be made.

INDIANS TURN CATTLE THIEVES.

Umatilla Bucks Take Fifteen of Gus Ring's Steers From Heppner's Ranch—Fence of Enraged Men in Pursuit of the Thieves. From Pendleton Tribune.

Fifteen head of two-year-old steers are reported stolen from Gus Ring, of Despain gulch, by the Indians. The cattle were missed Sunday, and a posse, consisting of Jonas Watler, of Elmer, and Mike Koskie, started in pursuit. They followed on their trail as far as the Columbia river, and it is thought the thieves swam the river and probably reached the Yakima reservation. Upon the return of the party in pursuit all the Norwegians in that section equipped themselves and started scouring the country for the thieves.

It is supposed it was a party of Umatilla Indians that did the stealing. Every effort is being made to head them off. That section is thoroughly aroused, and if they are caught they will be dealt with in a very unceremonious manner.
