AGUINALDO SHOWS FIGHT

Dewey Declares That it Will Take a Large Army to Subdue the Insurgents

GENERAL MERRITT ARRIVES SAFELY AT MANILA

His Prediction That All the Troops Assigned to Him Will be Needed ---Spanish Anxious to Surrender.

WASHINGTON, July 30.—A dispatch from Admiral Dewey announces that Aguinaldo has assumed a bold attitude of defiance, and that it will take a large force from this country to subdue the insurgents.

WASHINGTON, July 30.—The following has been received at the war department: "CAVITE, July 30.—Arrived today about noon. The health of the command is good. The remainder of the fleet is about four days in the rear. All the troops assigned me will probably be needed."

MANILA, July 25, via Hong Kong, July 30.—The Spaniards are gradually realizing that Spain has not been victorious, that the expected reinforcements are not coming and that the contest is utterly hopeless.

It is asserted here that the Americans may permanently annex the Caroline and Ladrones islands and possibly abandon the Philippines, with the exception of keeping a coaling station here.

Although the insurgents have redoubled their efforts they have been unable to capture the citadel. The Spaniards are not able to re-establish their suzerainty. Under the circumstances it seems evident somebody must interfere in the name of humanity.

SAN FRANCISCO, July 30.—A special from Manila Bay of July 26, via Hong Kong, July 29, says: General Merritt and the transports and troops under his command arrived at Manila on the morning of July 25.

General Merritt's expedition included the transports Ohio, City of Paris, Indiana and Morgan City, which left here June 27, carrying 3,600 officers and men, under Brigadier General McArthur.

NEW YORK, July 30.—A dispatch to the Tribune from Gibraltar says: While in Cadiz on Wednesday the Tribune correspondent noticed that the universal desire of the civilian population remaining there was for peace at any price.

MUTINY AND DESERTION. American Soldiers Refuse to Obey Orders and Desert.

CHICKAMAUGA, July 28.—Tuesday last the Fifth Illinois regiment, which has been in camp here for some time, was ordered to join the troops now at Newport News, preparatory to sailing for Porto Rico.

Preparations were immediately begun and just as the arrangements had been completed for their departure, an order was received revoking the previous one, and commanding them to remain at Chickamauga.

The receipt of this order caused intense excitement and disgust among the members of the regiment. Both officers and men rebelled, threw away their guns and knapsacks, and declared they would not submit to the indignity of being compelled to remain in camp, subjected to all the menial duties that had been thrust upon them, while other regiments not so well drilled or equipped had been ordered to join General Brooks and proceed to Porto Rico.

At the present time over two thirds of the regiment have deserted, and things are in a state of utter demoralization.

Telegrams have been received from Secretary Alger, directed to the commanding officer of the mutinous regiment, ordering a general court-martial. Arrests of deserters are being made every hour by both the military and police. The punishment for mutiny and desertion in time of war is death, but it is not thought such an extreme will be resorted to.

Hegged to Be Killed. SHAWNEE, July 28.—Prospectors arriving here today from Copper River tell a story of the pitiable condition of two men from Los Angeles, California, who got over the glacier almost at the expense of their lives.

Remembers His Friends. Sunday afternoon an observant scout for this paper saw a splendid liverly rig drive up the principal street of the Capital City. Its sole occupant was Hon. Elmore Ford, all dressed in his best and on his head a resplendent silk hat, and thereby making a story.

In 1863 the late Sam Adolph, a Salem capitalist, was on a tour of the East and sent Mr. Ford this "silk" slop-clothe hat. The arrival of that hat was an event in Ford's life. He always wears a slouch hat of some kind or other, but this coming from a warm friend and a man he much admired, he prize it as a treasure, and on the anniversary of his friend's death he puts it on his hat, gets the finest rig in town and goes out to the cemetery and places a bouquet on Sam Adolph's grave. Not the least of Lawrence Ford's eccentricities is to remember his friends.—Salem Journal.
