IMPORTANT TO TEACHERS.

An Opportunity of a Life Time—Oregon Should be Represented.

Hiram Tyree, superintendent of the public schools of La Grande, sends the Gazette the following important communication in the interest of Eastern Oregon education:

LA GRANDE, May 25, 1899. EASTERN OREGON TEACHERS—As corresponding secretary of the eastern division of the State Teachers' Association, I desire to call your attention to the meeting of the National Educational Association at Los Angeles, July 11-14, 1899. This is an occasion that no teacher can afford to miss without making a special effort to attend.

While the matter of expense will necessarily figure in the estimate of what one can afford, yet the importance of this great meeting is so great that every teacher in Eastern Oregon should make a special effort to attend. This will be an opportunity of a lifetime, and will be the last chance some of us will have of attending this, the greatest educational gathering of the world.

The trip from Oregon into California will be like passing into a new world. The instructions and the inspirations received by coming in contact with the greatest educators of the United States, and the acquaintances, associations and friendships formed will mark an epoch in the life of many a teacher.

California will necessarily need the greatest delegation. Washington will send a host, both from the eastern and western divisions, Idaho and Montana promise a full attendance. And now, dear teacher, what about Oregon? What about Eastern Oregon? Shall we show to the world that we have less interest than any state west of the Mississippi? As you are aware, the state of Oregon has been organized into two divisions, the western and eastern divisions of the State Teachers' Association.

The indications are that the western division will send a good representation. It is true that our expenses from Eastern Oregon will be a little more than theirs, but it is not as much as from Eastern Washington, or Idaho, or Montana. The expense can be estimated as follows: The O. R. & N. will sell round trip tickets to Portland for one and one-half fare. From Portland to Los Angeles and return, by ocean steamer in both directions, or to San Francisco and return by steamer and from San Francisco to Los Angeles by S. P. R. R., round trip of \$35 is offered. The Southern Pacific will make a rate of \$35 for round trip from Portland, all overland routes. Tickets on sale July 5th to 9th inclusive.

Good hotel accommodations can be secured in Los Angeles from \$1 to \$4 per day. It will thus be seen that the expenses can be kept very low.

I have been asked to make a report, at the earliest possible date, of those intending to take advantage of these rates. You will therefore confer a favor by informing at your earliest possible convenience, of your intention to attend. Those who desire to establish an Eastern Oregon headquarters at the National Educational Association please state the same in your replies.

GREAT SHEEP COUNTRY.  
Conditions in Oregon are Just Right For the Industry.

"Oregon, like Texas, should become a great breeding-ground for sheep," said C. H. Shurtle, of the Mallory, Son & Zimmerman Packing Company.

While sheep are moving lively from Oregon, Mr. Shurtle says the range has been cleaned of cattle, except a few, which are held at top high prices. During May and June he says he will have shipped from Oregon 100,000 head of sheep. By fall he expects the number to reach 200,000. His company last year handled 150,000 sheep from Oregon.

He places the total number of sheep that will be shipped this year at 400,000. About 100,000 of these will be "trailed"—that is, driven to market instead of shipped on the railroads. Owing to increased settlement along the route, Mr. Shurtle says that "trailing" no longer pays. It is hard to secure enough grass for the sheep, and there is such an intimacy toward sheepmen in new settlements that many sheep are poisoned. In fact, the losses from various causes amount to a great deal more than would pay the freight. Under present conditions he thinks it is positively dangerous to "trail" sheep.

He says Oregon can make a great hit by breeding sheep for the market. There is big money in it, and all conditions, climatic and otherwise, are just right.

## State News.

Total outstanding indebtedness of Grant county, \$185,919.1; by deduction of the total amount due from Wheeler county, \$7,911.76, leaving the total amount of indebtedness of Grant county, \$178,007.35; from which, after deducting the value of public buildings, which is \$12,000, leaves a net indebtedness of \$166,007.35.

Many cattle have died from eating larkspur in the vicinity of Marshfield, Southern Oregon. The case of John D. Spreckels & Bros. Co., vs. R. A. Graham is said to have been compromised for \$500.00, which is within \$20.00 of the amount of the note upon which Graham was sued. Graham is a mine and railroad operator in the Coos Bay country.

H. C. Kooper informs the Antelope Herald that the results of the horse rodeo last week were quite a surprise to every one. The report had gone out that a large number of horses on the range had died during the past winter. Mr. Kooper says there were more horses on the range this year than ever before. In the ride in which he took part, about 250 head were rounded up.

The commissioner of the general land office has held that the failure of A. F. Burns to make final proof and payment for a small tract of land in the Roseburg land district, prior to the day fixed for the sale of the land, served to extinguish all his rights under his filing for the same, and in order to clear the matter up the filing has been canceled. This tract was originally granted to the Oregon & California Railroad Company.

## GRANT COUNTY NEWS.

Blue Mountain Eagle.  
Wm. Sterrett was up from Cottonwood Wednesday. He complains of having his hand and sheep shot into on Camp creek, down near Cottonwood.

J. B. Boyd and wife, who have been faithful employees on the Eagle for over a year, will soon depart on a visit with relatives and friends at Baker City and Spokane.

Road Supervisor Barryman has a force of men at work improving the road to Susanville. Business men of Long Creek contributed \$60 for the road and Grant county appropriated \$40, which will put the thoroughfare in good repair.

Philip Fair, known to the Long Creek people as John Kealey, is enjoying at the Mc Duffie hot springs. As a result of his stay at that famous mineral resort, the wound that has existed on his leg since the days of the late war has healed over, the first time this has occurred in thirty years.

J. M. Boardman passed through Long Creek last Friday enroute to the South Fork country, where he will begin receiving cattle preparatory for another drive to Montana. Mr. Boardman drove 3,000 head of cattle from Grant county last season and will likely drive equally as large a band this season.

Jacob Cannon, who had been an invalid from paralysis of the limbs for near two years, died at the county hospital near Canyon City. He was taken to the hospital early in March, but his mind began failing shortly after his arrival, and all the medical relief at the command of the county failed to relieve him of his distressed condition. He was a man that stood high in the estimation of his neighbors, and was an honorable citizen. He leaves five children to mourn his death.

Wm. Carl and Miss Anna Brazier, both residents of this valley, were united in the holy bonds of matrimony at the home of Mrs. W. M. Kudo, in this city, Sunday evening, in the presence of a number of friends and relatives. Judge Boyd being the nuptial knot to the satisfaction of all present. Mr. and Mrs. Carl were the recipients of a number of useful and valuable presents. They will make their future home at Ukiah, from which point Mr. Carl will direct the management of the Long Creek Ukiah mail route.

The report has reached the Eagle from the Greenhorn country that a deal has been completed whereby a large electric power plant will be built on the North Fork of the John Day river, near the line of Grant and Umatilla counties. This plant will be used for transmitting power to all the mines in the near vicinity. The enterprise is backed by Oregon and Eastern capital. The plant will cost \$100,000 and will have 1,000 horsepower. The power, much of which has been practically ordered in advance by leading Grant and Baker mines, will be transmitted a distance of 30 to 40 miles.

Prospects for Wool.  
Mr. E. H. Clarke, the well known wool buyer, made a trip to Elgin Saturday to look up the local wool situation. The gentleman reports a very favorable outlook for prices this year and the market will now stand a price of 10 to 11 cents per pound. Elgin is the shipping point for Wallawa county and with the local output of the immediate vicinity there will be a total of about 1,000,000 pounds of wool shopped at that point this year.

As a rule sheep in this section have come out of the long cold season in good shape. This is accounted for by reason of the fact that in most instances, especially in Wallawa county, there has been a good supply of feed provided for the winter months. At current prices a great deal of money will be distributed for the wool clip. Mr. Clark expects to make frequent visits to this section during the marketing season.—La Grande Chronicle.
