Dentist Who is up to Date.

Dr. William A. Wise, one of the most prominent of Portland dentists, senior member of the firm of Wise Bros., has withdrawn his membership in the Oregon State Dental Society. Dr. Wise's action was prompted by his desire to be free of the holdbound rules by which, under the name of ethics, the society holds down its younger members of the profession in Oregon.

Dr. Wise has practiced dentistry in Oregon for 15 years, and his rise in the profession recently has been rapid. He is now a member of the State Board of Dental Examiners, having been appointed last March by Governor Geer.

"I have swung clear of the society," said Dr. Wise, "because its rules hampered my progress. The society does not permit its members to advertise. I have determined to advertise. I have been held back long enough by the hypocrisy of ethics, which is purely and simply a scheme to make a close corporation of dentistry, and keep the younger dentists from asserting themselves and becoming known."

"If I can spend \$1000 in advertising, and get \$10,000 worth of business in return I am a fool if I don't advertise. And if I stand to make a profit of only \$1000, I have made a good investment."

Work on the building of a new court house for Morrow county will be commenced as soon as possible.

Judge A. G. Bartholomew and Commissioner Ed. C. Ashbaugh are now away on a trip of inspection and investigation in relation to plans and specifications. They will visit several different court houses in order to be aided in drawing the plans.

For the past week the question has been pretty thoroughly talked over by the taxpayers. The matter of a site was the occasion of some friendly rivalry and several propositions were made to the court.

It has been finally decided to erect the building at the corner of Chase and May streets, and the property belonging to Banker C. A. Rhea and Dr. McSwada has been purchased for this purpose, and the matter will be settled as soon as the deeds can be properly acknowledged.

This beautiful site will cost the county only \$2000, however, it cost more than this, but the difference was made up by business men who wanted the court house placed there.

The new building will be a fine structure and will probably be built of stone. The old court house will be used for a county poor house.

HEPPNER-SUSANVILLE ROAD.

Pendleton Correspondent Gets Matter Somewhat Mixed.

A correspondent writing from Pendleton to the Spokesman-Review says: "Heppner has begun the construction of a wagon road into the Susanville country. This move has been sprung with startling suddenness on Pendleton's business men. It is a coup d'etat. Pendleton has wanted the trade of the interior and the men of the interior wanted to come to Pendleton. Both sides thought there was enough in it for the other to start the road. While they waited Heppner stepped in and a gang is at work now at the Heppner end."

This correspondent is a good news getter. If such a move is on foot it has been sprung with startling suddenness upon Heppner's business men also. There has been considerable talk about a road from Heppner to Ritter, but wind work has been the principal amount of labor performed on the proposition. The East Oregonian, in a long article about the matter, says that it would cost \$75,000 to build this road, but the E. O. is about as far off on this as the Pendleton correspondent. \$3000 would build a fairly good road from Heppner to Ritter, and there is already a very good road from Ritter to Susanville. As it is the Susanville and Ritter trade is divided up between Heppner and Pendleton, however, if this proposed road was completed, the people in these districts would rather come to Heppner on account of being much closer.

An Empire in Itself!

A pamphlet has been issued by Frederick Haynes Newell, of the Interior Department, which shows some facts concerning Eastern Oregon that are worthy of note. It says there are 35,687,680 acres of vacant land in Oregon east of the Cascade mountains. This land, while it is not all susceptible of cultivation, is nevertheless valuable for farming and grazing purposes. Perhaps one-half of it could be reclaimed by irrigation and would furnish homes for 80 acres each to 200,000 families. Continuing the pamphlet says: "The greater part of the vacant public lands are within the great interior basin the streams of which do not have sufficient volume to cut their way to the ocean. The supply of water is very small in comparison to the land to be supplied, and it will be necessary to use storage reservoirs and well water wherever it can be obtained, in order to utilize the land."

COUNTY COURT.

New Court House Ordered—Road Districts Established.

The following proceedings of the county court occurred last week after the GAZETTE had gone to press:

In the matter of dividon and laying out the county into road districts.

In accordance with the law which provides that at the January term, 1902, the courts shall divide the counties into suitable and convenient road districts, the districts were created with numbers and descriptions as follows:

Road district No. 1 shall embrace all that territory lying within the boundaries of Heppner precinct, except that part that lies within the corporate limits of the town of Heppner.

Road district No. 2 shall embrace all the territory lying in Matteson precinct except that portion lying within the corporate limits of the town of Heppner.

Road district No. 3 shall embrace all that portion of Geetry precinct lying outside of the city of Heppner.

Road district No. 4 shall embrace all the territory in Mt. Vernon precinct except which lies within the corporate limits of the town of Heppner.

District No. 5 shall embrace all the territory in Darry precinct.

Road district No. 6 shall embrace all the territory lying in the boundaries of Lena precinct.

District No. 7 shall embrace the territory of Eight Mile precinct.

District No. 8 shall embrace the territory in Dry Fork precinct.

District No. 9 will embrace the territory of North lone precinct except that portion in the town of lone.

District No. 10 will embrace lone precinct except that portion in the town of lone.

District No. 11 will embrace the territory in Cecil precinct.

District No. 12 will embrace the territory of Alpine precinct.

District No. 13 shall embrace the territory of Wells Springs precinct.

District No. 14 will embrace the territory of Lexington precinct.

The resolution passed at a meeting of the citizens last Thursday asking the construction of a court house suitable to meet the requirements of the county was taken under advisement.

It was the unanimous opinion of the court that the vault for the keeping of records is of insufficient capacity to hold the records of the county. That the county jail is not a safe place for the confinement of prisoners. That the present court house is not of sufficient size to accommodate the business of the county. That the present location is not a proper or suitable place to build a new court house.

Therefore, it was ordered and adjudged that a new court house should be and the county court and commissioners of such county are hereby directed to immediately erect and construct a new court house for Morrow county, of sufficient size to meet the requirements of the business of said county.

That the county court and commissioners are hereby directed to procure and purchase sufficient real property within the corporate limits of the city of Heppner upon which to erect and construct a new court house.

That the county court and commissioners are hereby directed to immediately proceed and have drawn plans and specifications for a new court house, and that said court and commissioners are hereby authorized to visit such other court houses within the State of Oregon which they may deem necessary for the purpose of aiding them in having the plans and specifications drawn.
