ARTICLES FOR TWO NEW CORPORATIONS FILED.

A Large Number of Real Estate Transfers--Other Matters of Record.

Frank DuPrat, this week, finished the contract for the stone work on the new court house. Plasterers are now well along with this work. The steam heating apparatus is all in place and can be arranged to heat the building on short notice. The building will be all completed with the exception of the steel furniture in the vault, by the 15th of next January. The contract calls for the completion of the placing of the steel furniture in the vault by the 5th of February, 1903.

The 1000 pound striking bell for the big clock has arrived. The clock has been tested and is now on the way from the manufacturers in Connecticut.

Articles of incorporation of the Saling Abstract and Title Guaranty Company have been filed with the county clerk.
