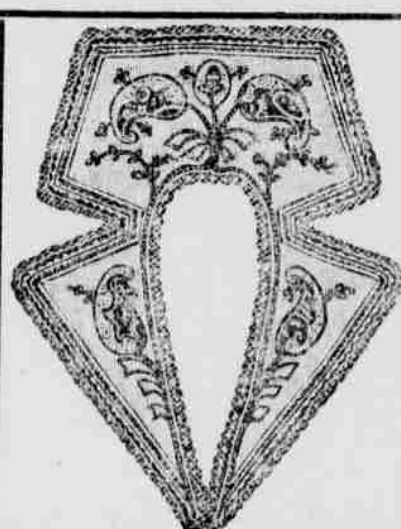

MANGY HORSES KILLED.

Sheriff Shutt Kills Four Head on the Range.

Sheriff Shutt shot four head of horses afflicted with the mange, last Saturday. The diseased horses have been ranging near Heppner for some time and many complaints have been coming in for fear of further spread of this contagious disease among the horses of this section. After serious complaint had been made several times, Sheriff Shutt who did not desire to be hasty in taking action, telephoned to Dr. Wm. McLean, the State Veterinarian for instructions as to the method of procedure. The State Veterinarian immediately deputized Sheriff Shutt with instructions to kill the diseased animals.

Owing to the prevalence of this disease in Morrow county, and the lack of attention of the owners in trying to get rid of the contagion, the State Veterinarian has decided to enforce decisive action in order to stamp out the disease, even if it is necessary to kill all of the animals afflicted, which he has a right to do under the law.

A number of the horse owners who have mangy horses have been dipping and are endeavoring to cure their horses, but the greatest source of trouble comes from the Indians. The Indians who own large numbers of cayuses along the Columbia river, and most of them are afflicted with the mange, have been warned that they must treat their horses or suffer the loss of having them killed, and after several of the Indian horses were killed against earnest protest by the Siwash, it was thought that the Indians would take some action in trying to get rid of the disease.

The Siwash who usually take things pretty easy, have not been doing anything. Another bad feature is that the Indians who make frequent trips from the river to the Blue mountains, are very likely to spread the disease. The State Veterinarian will come to Morrow

county this Fall and all horses badly afflicted will be killed.

Nearly Lost His Life.

Raymond, the 10-year-old son of Thos. Marlatt, narrowly escaped death Sunday by being dragged by a horse, his foot having become caught in the stirrup. He was dragged about 100 yards, a part of the way over rocks. His worst injuries were about the face and head. He was picked up in an unconscious condition and taken to the home of J. T. Kirk. A physician was summoned who dressed the wounds and later in the afternoon he was removed to his home near town. The lad is now on the way to complete recovery, but the shock was so severe he has no recollection of events immediately preceding the accident. He does not remember trying to mount the animal, and does not know how he happened to be thrown. In all cases where a horse is suspected to be the least bit unreliable it is better for the stirrup to be protected with leather taps, to keep the foot from slipping far into it. The lack of such precaution has been responsible for the loss of many young lives.

Another Blooded Dog.

Frank Roberts has received a fine imported English setter which came to him from South Dakota. He has never felt satisfied since losing a valuable dog of the same breed some time ago with an attack of distemper, and was not to be consoled until making his present acquisition. The animal is an unusually fine specimen of a distinguished breed, and Mr. Roberts' canine possession is the envy of his friends. Many fine dogs are to be observed in Heppner and vicinity, among them several pure strains of the Ayrdale, staghound, Collie, St. Charles spaniel, etc.

IN FAVOR OF STANLEY.

Long Controversy Over Property Ownership Decided.

The case of H. E. Warren vs. A. B. Stanley, which has been in the courts for a long time, and which has been the source of much controversy and comment in Heppner, was decided yesterday by Judge Ellis in favor of the defendant, A. B. Stanley.

The case is rather a peculiar one and the questions were closely drawn. The fact that the property was in Heppner has made it prominent here.

Mr. Warren who was formerly a resident of Heppner and who is now a prominent merchant of Morrow county, located at Hardman, owned fine residence property here. He claimed that a short time prior to the Heppner flood of June 14, 1903, he sold this property to A. B. Stanley, who was then a resident of Hardman. While there were no papers to prove the transaction, Mr. Warren held that there was a verbal contract and that Mr. Stanley had taken possession before the flood.

When the flood came the water swept the lot taking the house and everything away.

Mr. Stanley in his defense denied the existence of any contract whatever and resisted the suit for the specific performance of contract, as instituted by Mr. Warren. The amount involved was \$2500. Redfield & Van Vactor were the attorneys for Mr. Stanley, and G. W. Phelps appeared for the plaintiff.

One reason for so much interest being taken in the case just decided was the fact that the Warren house was the city council of Heppner as well as to property owners on Court street. After being washed from the lot on which it stood, the building lodged in the street, and numerous petitions were presented to the council asking for the removal of the building. Neither Mr. Warren nor Mr. Stanley would do anything about moving the house, as neither would

claim ownership, and finally the building was condemned by the city council, and as a public nuisance was removed.

A carload of the "mineral earth," spoken of in last week's Gazette, was shipped to the soap works at Rainier this week. After being refined and pressed into cakes and wrapped up in striped red and white papers Heppner housewives will buy it and think it is the only soap.
