BIDDY'S HALF HOLIDAY.

Most Wonderful Law Fresented Before the New Zealand House.

According to this proposal, every mistress is bound to turn her servants out of her house from three p. m. until ten p. m. one day in every week. If the servant is found employed at her ordinary work during the statutory half holiday, the mistress will be liable to a penalty of \$25. 
