Geo. Conser, of the Lewis and Clark fair state commission, Hon. Henry Blackman, Morrow county's commissioner, and Judge T. W. Ayers were in Portland this week to confer with the fair authorities in relation to the allotment of space to be accorded to Morrow county and also as to the methods of procedure with our exhibit. The matter was placed before the four commissioners, and all of Morrow county's representatives speak very highly of the treatment received. Morrow county's floor space will occupy a room 20 feet square in the state building.

R. F. Hynd this week received a letter from C. J. Millis, live stock agent of the O. R. & N. Co. explaining the federal requirements in relation to dipping. The letter follows: "Sheep passing inspection for immediate slaughter will receive a certificate. Sheep for breeding or feeding or going into other states to be turned upon the range, will have to be dipped once under Federal supervision and twice if they are infected with scabies. There will be no concessions or modifications of this order for the present year, and sheep owners or shippers must put themselves in position to comply with these requirements, as we will absolutely decline to receive for yardage or shipment, sheep except as provided above."

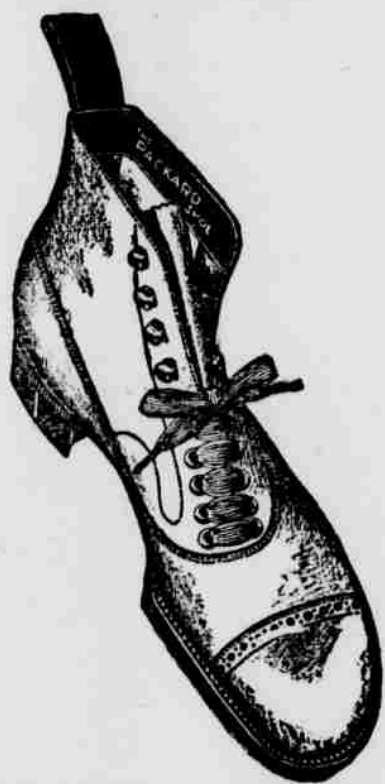

### DIED SUDDENLY.

#### James A. Henderson Falls Dead While at Work.

James A. Henderson, aged 37 years, a native of Barrie Ontario, Canada, dropped dead while attending to his duties in herding sheep for Hynd Bros., of Sand Hollow, Sunday evening. Mr. Henderson was a friend of the Hynd boys, and on account of poor health accepted a job of herding in order to get outdoor exercise.

Acting Coroner Geo. Whiteis went out Monday and held an inquest. The report of the jury was that deceased came to his death by heart failure.

### Dead By Thousands.

Calcutta, April 8.—Telegraphic communication with Dharmasala has been restored. The latest accounts show that the earthquake was even more disastrous than at first believed. Of a total population of nearly 5000 in the town of Kangra, it is believed that only 500 are left alive. Many of these have died.

Of the police only a Deputy Inspector and four Sergeants are alive. Many people are still imprisoned in the ruins. Dharmasala, Kangra, Palanpur, Dhawan and all the neighboring villages were completely wrecked. Scarcely a building remains standing. Not much damage was done at Haripur, Deragopipur, Nadaum or Hamipur. Sujapur, having a population of about 6000 souls, is reported to be in ruins.

The shocks still continue. There is no news from Kulu Valley. According to native rumors, a great amount of damage has been done. An official dispatch from Dharmasala says the place is a scene of desolation. Owing to the scarcity of labor, great difficulty is experienced in excavating the ruins, but the Goorkhas are doing excellent work.

The grading of the portage road is completed, and tracklayers started March 29 laying track in both directions from the center of the line.

### State Sunday School Convention.

The twentieth annual State Sunday School Convention will be held at Portland, Oregon, April 19, 20 and 21. Every Sunday School worker in the state is entitled to a seat in the convention. Marion Lawrence, secretary of the International Convention, and one of the foremost workers of the world, will be present. Let every Sunday School in Morrow county send a delegate or two, even if you have to pay their expenses.

Every superintendent in this county will receive a blank soon upon which to report your school. If you should fail to receive a blank, send a report to S. E. Notson, Heppner, or to Rev. J. L. Jones, president of the County Association, Ione. Give the names of your officers, number of teachers, number of scholars; whether you have a primary department, cradle roll, home department, and the name of the superintendent of the department, if any; amount of money raised for the school during the past year, amount expended, amount contributed to state and county work; also number of months during the year that the school held sessions and the average attendance. Give any other facts you think would be of interest and helpful to other workers.

The last county convention decided to ask each school in the county to contribute three cents per member on roll towards the state work. Will your school do that much? Send the money to Rev. J. L. Jones, Ione, Oregon, or to the person sending you the blank. Let us make a good showing for our county. We receive more help from the state work than we sometimes think. Do not fail to make a report, whatever else you do, and send it in at once.
